#### SUMMARY

  - Contract Amendments for one-time capital funding to support approved SYSCA projects for Northeast Youth Center, Project Joy, Southside Community Center and Hillyard Senior Center. Total funding amount \$10,000 – regular agenda item
- Tony Cane gave a presentation on the Hilliard Senior Center
- Jennifer Papich and Carissa Ware presented a discussion on proposed 2025 Sports Field Impact Fee increases..
- Jennifer Papich presented the Recreation Report.

#### **MINUTES**

The meeting was called to order at 5:17 p.m. by committee chair Sally Lodato.

#### Public Comments: None

#### Action items:

1. Renaming of Downriver Disc Golf Course to Whitewater Disc Golf Course – Ryan Griffith

To recap, the stormwater construction began in 2022 within Downriver Park, TJ Meenach River access and the disc golf course. Everything is now complete and ready to open shortly. To alleviate any confusion with Downriver Golf Course, it was suggested a new name be assigned to much improved disc golf course. The Disc Golf Community Group came up with several names to be included on a survey. Of the 728 responses, Whitewater was by far the favorite.

**Motion #1** – Sally Lodato moved to recommend Renaming of Downriver Disc Golf Course to Whitewater Disc Golf Course.

Greta Gilman seconded. The motion passed unanimously (3-0 vote).

The committee agreed to present this recommendation as a consent agenda item on the May 09 Park Board meeting agenda.

- Contract Amendments for one-time capital funding to support approved SYSCA projects for Northeast Youth Center, Project Joy, Southside Community Center and Hillyard Senior Center. Total funding amount \$10,000 – Jennifer Papich
  - a. Of the ten Spokane Youth and Senior Center Association (SYSCA) centers being supported by Spokane Parks and Recreation Division (SPRD), four centers were awarded the SYSCA Capital Grant. As in 2023, the criteria includes long term capital improvement projects which increase services to underserved areas/populations, promote inclusivity and accessibility, and demonstrate collaboration with other community funding.
  - b. Northeast Youth Center and Project Joy received full funding for their projects, as the Recreation Committee felt they were most closely aligned with the criteria. Hillyard and Southside Community Centers received partial funding. As a reminder, these are one-time funding dollars and are reimbursable once the work has been completed, which must be done by December 31, 2024.

**Motion #1** – Sally Lodato moved to recommend Contract Amendments for one-time capital funding to support approved SYSCA projects for Northeast Youth Center, Project Joy, Southside Community Center and Hillyard Senior Center. Total funding amount \$10,000.

Jennifer Ogden seconded. The motion passed unanimously (3-0 vote).

The committee agreed to present this recommendation as a regular agenda item on the May 09 Park Board meeting agenda.

#### **Discussion Items:**

- 1. Special Guest Report Hillyard Senior Center Tony Cane
  - a. Tony has taken over the lead after the retirement of longtime director Jerry Unruh. Hillyard encompasses 34 zip codes in the low to moderate income level. Of the 14.5% of Citywide individuals over age 65, Hillyard is home to 10.7%. The center's mission is to encourage seniors to keep active in mind, body and spirit. The program offerings are designed to challenge and stimulate good mental and physical health with a sense of well-being and

enthusiasm for life. Most of the recreation activities are either free or very low cost, thanks to the funding from SPRD. One of the new class offering, free tech help, uncovered two individuals who were being scammed online, which triggered the fraud and scam prevention initiative with the Spokane Police Department and a local bank. The tech help class is great for individuals who would like more help with things like social media and simply understanding how to get better use all the innovative features on their phone or tablet. This is not a "tech support", but they could assess the issues and be able to direct them to people who could better assist with those types of questions.

- b. Last year, the impacts from the SPRD funding included the expansion of program offerings, increased accessibility, and long-term sustainability. There were 56,498 participants with 2,271 volunteers logging almost 8,000 hours. The center was also able to raise \$26,630 fundraising dollars in 2023.
- 2. Proposed Sports Field Impact Fee (SFIF) increase for 2025 Jennifer Papich & Carissa Ware

The SFIF was established in 2023 which funded the synthetic turf replacement at Dwight Merkel. The yearly payments are \$180,000 through 2028, with 1/3 of that coming from the SFIF with the remaining 2/3 coming from capital and athletics revenue. The goal is to decrease the burden on capital and athletics revenue and more SFIF. It was projected the SFIF would bring in approximately \$45,000 in 2023, however, the final amount was \$18,000 over projection. The SFIF will remain the same for 2024, however a \$1 increase in 2025 is being proposed, which will result in an estimated \$16,234 extra to put towards the yearly payment of the Merkel Turf replacement. Jennifer thought doing an increase every 2 years. The fees will not go away but will be used towards future field improvements. This fee is in addition to the hourly usage/rental fee.. This item will continue to be a discussion item moving into June, Jennifer with prepare a cost analysis of both a SFIF increase as well as hourly increase.

#### **Standing Reports:**

1. Recreation Report – Jennifer Papich

Corbin Arts hosted 140 youth with a week of spring day camps; Athletics is excited about the new youth skateboard lessons at Dwight Merkel Skate Park, and volleyball has a record number of teams; Outdoor Recreation programs with Evergreen Archery and Wiley E. Waters rafting are fully booked and are pleased about the great partnership with these vendors; Aquatics staffing has 13 of 200 spots remaining, with lifeguard and swim instructor classes beginning May 3; TRS is partnering with Aquatics for a sensory swim program and 95% of the TRS classes are already full; Wellness is collaborating with several departments and outside programs for a new ArtSci camp at Finch Arboretum with all 144 slots filled. EWU students wrote the science curriculum specifically based on the Finch area.

Adjournment: The meeting was adjourned at 6:18 p.m.

#### <u>CITY OF SPOKANE</u> PARK BOARD RESOLUTION

#### A RESOLUTION renaming the public disc golf course located within the Downriver Park Natural Area.

WHEREAS, the City of Spokane owns and operates 3,900+ acres of parks & natural lands within and outside of the City of Spokane; and

WHEREAS, the Park Board is empowered by the City Charter with exclusive jurisdiction and control to lay out, establish, procure, purchase, accept, and have the care, management control and improvement of, all parks and grounds used for park purposes, all boulevards and parkways, and connecting parks and structures thereon located both within and outside of the City of Spokane; and

WHEREAS, there has historically been some community confusion between the downriver disc golf course and the downriver golf course due to nearly identical facility names; and

WHEREAS, the city's disc golf committee recommended changing the name of the downriver disc golf course to reduce future confusion; and

WHEREAS, the disc golf course was recently closed for total reconstruction as a part of a large city stormwater and recreational infrastructure project; and

WHEREAS, the renovated disc golf course is planned to open to the public in Spring of 2024; and

WHEREAS, in December of 2023, Parks conducted an open survey for potential names for the renovated disc golf course, receiving 728 community responses; and

WHEREAS, of the 5 proposed names, Whitewater Disc Golf Course received over 50% of votes and was the clear community favorite; and

WHEREAS, at the January 2024 meeting, the Audubon-Downriver Neighborhood Council voted to support the selection of Whitewater Disc Golf Course as the preferred name for the facility; and

NOW, THEREFORE,

BE IT RESOLVED by the Park Board to officially rename the disc golf course on the Downriver Park natural land to "Whitewater Disc Golf Course".


## **Downriver Disc Golf Course Name Change**

  - Frequently confused with Downriver Golf Course
  - Desire for a fresh new name for the renovated course.
  - Disc Golf Community Group came up with various names and agreed on five to submit for a survey:
    - Ponderosa Pines DGC
    - Whitewater DGC
    - Soaring Eagle DGC
    - o Hawks Ridge DGC
    - o Ponds DGC

The survey received **728 responses,** it was promoted by Spokane Parks and Recreation Communication and Marketing, as well as through the disc golf community.

Capital improvements refer to investments made by an organization in physical assets or infrastructure to enhance their quality and increase overall value. These projects typically involve construction, renovation, technology upgrades, transportation upgrades, essential equipment upgrades/replacement etc.

#### Priority will be given to applications for capital projects that:

- Increase park and recreation services to underserved areas or populations.
- Promote and provide inclusivity and accessibility for all individuals.
- Offer long-term significant benefits to the community and the center.
- Demonstrate collaboration with other community funding.

#### **Non-Qualifying Projects:**

- Routine maintenance painting interior or exterior, carpet cleaning or replacement etc.
- Administration, salaries, and operations
- Debt retirement
- Lobbying activities
- Conferences, workshops, symposia
- Endowments
- Individuals/staff
- Programs with religious content
- Replacement of lost/expired government funding

#### **2024 SYSCA CAPITAL GRANT PROGRAM RECIPIENTS**



The SFIF was established in 2023 to fund sports field improvements, starting with the synthetic turf replacement at Dwight Merkel.

- A flat \$5 fee was added to each Sports Complex booking.
- A \$1 per hour fee was added to each Tier 2 & 3 athletic field reservation.
- A \$10 per team fee was added to each outdoor Adult Athletic Team registration.
- The payment for the Merkel Turf Replacement is \$180,000/yr. through 2028.
  - Debt Service Payment is divided:
    - 1/3 from capital \$60,000
    - 1/3 from Recreation Revenue (Athletics) \$60,000
    - 1/3 from the Sports Field Impact Fee \$60,000
  - The goal is to increase the amount from SFIF and decrease the amounts from Recreation and Capital at a reasonable rate.

Based on past bookings and registration data, we estimated a 2023 contribution of \$45,000 to the SFIF fund.
