### **Public Comment Period:**

There were questions about the use of bicycle sharrows and their appropriate use and locations for placement.. Discussion followed on bicycle signage and temporary and permeant street markings.

### **Board Briefing Session:**

Move to amend changes to the June 20, 2017 meeting minutes with correction to the attendance and wording under the Liaison Report. Move to amend the August 15, 2017 meeting minutes with correction to the spelling of quorum and staff report being about bike share.

Moved to approve the June 20, 2017 and August 15, 2017 meeting minutes as discussed with changes noted. Minutes approved unanimously.

### 1. Liaison Report-Millwood Trail

- The Millwood Trail Meeting focused on technical design issues.
- Discussion around additional river access for non-motorized watercraft and placemaking for a multi-use trail.
- The final meeting will be on November 2<sup>nd</sup> with an open house available to the general public at Spokane Community College.

### 2. Staff Report

 Recruitment- The Mayor's office is acitively recruiting to fill the vacant positions on the Board. Two applications have been submitted and will be brought to the Board for review.

### 3. Future Agenda Items

- Initiated public outreach on the next phase of Sprague Avenue streetscape improvements. The next segment is from Brown Street to Scott Street within the south University District. A presentation is online and can be brought to the Board for discussion.
- Continued work on the TJ Meenach Trail from the bridge to Northwest Blvd. making a solid system for bikers and pedestrians.
- Bike share program

 Cincinnati Greenway will be discussed early spring or winter. The design team will be visiting three neighborhood councils between now and Thanksgiving to gather information and recommendations from the community. Logan, East Central, and Nevada Heights neighborhoods will be visited.

A request was made to share with the Board when neighborhood meetings are held on the Cincinnati Greenway to allow Board Members the opportunity to attend.

A suggestion was made for new Board member information. Having a place for members to locate documents, duties, and information pertaining to the Board all in one place for easy access rather than on separate files not accessible or available to the Board.

A request was made to add a list of ongoing projects that could be added as a standing agenda for the Board to refer back to during meetings.

Discussion was made about a community wish list that could be posted to Facebook or to the website for the Bicycle Advisory Board.

### Workshops:

- 1. North Spokane Corridor Update
  - Students are working with EWU and WSDOT (Washington State Department of Transportation) to determine areas for placemaking along the higher populated areas of The Children of the Sun Trail.
  - WSDOT has hired Eastern Washington Univerty to help facilitate placemaking north of Mission along the freeway corridor and The Children of the Sun Tail.
     WSDOT will start designing bridges and other construction that can take years to design. The first phase of the Placemaking project is to be completed by the end of 2018.
  - More information, timelines, and dates on the Placemaking project will be brought back for further review at the next meeting. 2029 is the set deadline for completion of the North Spokane Corridor project.

Discussion ensued about bike helmets? Seattle uses a disclaimer on the Bike in order to make citizen aware. The helmet rule can vary by City and can be hard to enforce. An invitation will be extended to the Police, and The Health District for further discussion and understanding.

Ryan to provide BABs City Council update.

### 1. Work Plan

- Discussion is summarized here and the draft BAB Work Plan is attached.
- BB Work Plan Finalization (Board Discussion). Last month reviewed previous years' work plan and discussed updates we want to make to it. Will keep the same format. Could not find the draft plan with notes from last meeting, so working from memory on this plan tonight.
- Work Plan Five main categories;
  - a. Increase BAB participation in public outreach.
  - b. Increase partnerships with like-minded organizations
  - c. Vetting infrastructure concepts on the ground, planning + engineering level.
  - d. Make strong connection to Transportation Subcommittee and the City Council.
  - e. Planning Processes.
- Host bicycle open lane recognition events: When a new facility opens have a short ride to bring to public awareness. City staff to provide list of new projects.

- Creating a bicycle web page. Submitted a draft as a recommendation and need to find someone who has time to build it.
- Garry would like to contact businesses to check on bicycle friendly business applications.
- Increasing partnerships SRHD; and participation in local and regional events.
- STA moving forward with placing new bike racks on some buses. Also to coordinate on Central City Line plans.
- Police and the Helmet Law Enforcement.
- Commute Trip Reduction administered by the County provides benefits.
- Street Program Projects (including Impact Fee projects) Bicycle and Pedestrian Coordination.
  - o Fort George Wright choke point at bridge, etc.
  - Developer Impacts.
- Connection to Citizen Transportation Advisory Board, PCTS, and City Council.
- Provide annual update to City Council Chair.
- Reach out to DSP and GSI to install bike racks coordinate. (After bike parking guidelines are adopted).
- Bike Share consultant and coordination.
- Children of the Sun Trail (WSDOT).
- Promoting bicycling as a viable form of transportation and presenting to Council.
- Washington Bike Summit in April. (3-Partnerships). Registration link is posted on their web site. Check to see if we can offer any assistance to them such as presentations or workshops. We are hosting a bike tour.
- Macy's building. Parking structure is underground. Permitting for bicycle parking?
- What is our non-motorized LOS?
- Riverfront Park bike improvements Parks was supposed to check back with us. Checked-in last fall about temporary routing. Post Street and surrounding area planning for flow development and improvements for bicycles.
- NEED A QUORUM TO ADOPT THE REVISED PLAN. (Draft is in January 18<sup>th</sup> Folder).
- 2. Year End Council Report -
- 3. Bike Share Program Update (Brandon)
  - Updates on processed RFQs; received six submissions. We have made a selection; they are not a bike share provider; we chose a traditional planning firm, and will be contracting with them next month.
  - Several submittals were bike share providers.
  - Funding will be local.
  - Dock or dock-less will be considered.
  - Helmet law will be small part of the scope.
  - Focus will be on pilot installation then will phase-up.

• The City would manage the program through permitting, vendor management and staff.

### 4. Cincinnati Greenway Update (Brandon)

Brandon, Rhonda Young and the Gonzaga Senior Project Team attended the Logan and East Central Neighborhood meetings last year to present the Greenway concept. Attendees voiced concern about parking and landscaping. Students are back tomorrow and will work on feature options; will reach out to more neighborhood councils and the Board with these features at the end of February.

Lars (U-District) is coming next week to discuss the Cincinnati project. Will discuss the U-District's transportation innovation, which includes bicycles, and better connectivity in the future; a completed MLK will help with this. Temporary road alignment to Trent Avenue is going in this year - re-built later when ROW determined. Will install some bicycle signs -( bike lane to sharrow to bike lane).

### 5. Sprague at Sherman Plaza (Brandon)

South end of pedestrian bridge. Concepts and opportunities presented. Goal is to get shuttle to pick-up at the pedestrian bridge landing.




