Briefing Session:

Minutes from the March 16, 2021 meeting approved unanimously.

1. Liaison Report -

- Jessica Engelman reported the PeTT did not meet last month.
- Grant Shipley reported that Citizen Transportation Advisory Board (CTAB) is updating the 6
 Year Street Plan, and the City is implementing a new streets dashboard.

2. Chair Report -

• Grant Shipley urged everyone to get outside and bicycle. He also added that the Fish Lake Trail to Centennial Trail connection is of interest to the public and progress is being made.

3. Staff Report -

• Colin Quinn-Hurst reported an opportunity for federal funding for the Ben Burr Trail, Garland Shared-Use Path, and Riverfront Park East and West Wooden Bridges.

Pablo Monsivais motioned to approve a letter to Rep. Cathy McMorris-Rogers stating support of the federal funding of bicycle projects. Seconded by Rhonda Young. Motion Passed.

- Mr. Quinn-Hurst also reported that Harrison Husting is resigning as a member of the BAB as he
 is moving out of state. There is now a vacancy in the Bicycle Advisory Board (BAB) membership
 that will need to be filled.
- He reported that the BAB subcommittee met and worked on the Bike Priority Network and the next step is to create a bike network map with ranked projects for the BAB to review.
- He reported that Shauna Harshman, City Council Manager of Neighborhood Connectivity Initiatives, is working on right of way mural program and would like volunteers to join a working group.

Public Comment

- Jeff Sevela asked about the Fish Lake Trail route alternatives to know if the 'blue route' is selected will Government Way be reduced three lanes and will it be reduced all the way down to Greenwood Road.
 - o Colin Quinn-Hurst said that it's likely that Government Way would go down to 2 lanes all the way to Greenway Road.


- Mr. Sevela also wanted to know if the RRFV signal on Cincinnati Greenway is going to get an activation button.










Illinois Avenue Bikeway Project: Initial Concepts














