<u>Minutes:</u> Minutes from 7/16/2024 were approved unanimously. The minutes from the 8/21/2024 meeting were approved unanimously with one correction on the roll call. Change was that BAB Board Member Brian Falteisek was present.

#### **Briefing Session:**

#### • Liaison Reports

Discussion was had that the Plan Commission Transportation Subcommittee (PCTS) has now
disbanded in lieu of the upcoming Transportation Commission and therefore there will be no
liaisons report at this time. In future meetings there will be a liaison report by the BAB
representative to the Transportation Commission.

#### • Chair Report - Grant Shipley

- Grant reported that while riding around town he has been asked by the public about the bike lockers outside of City Hall (which will be discussed later in the staff report).
- He also stated that he has been actively seeking comment on the separated bike lane on Riverside.

#### • Staff Liaison Update - Ryan Shea/Colin Quinn-Hurst

- Ryan shared in follow-up to last month's mobile meeting, he has been meaning to get a pdf of the map of the route. He is looking for input from the BAB board to fill in any of the gaps as well as any sidebar conversations that were had about the route that they rode. One of the board members mentioned that he had tracking turned on that may be helpful as well.
- Colin shared that they have received a lot of requests from the public as well as city staff about secured bike parking. At this time there is a trial with bike lockers outside of City Hall as one possible solution. For the first 3-6 months of the trial, they will be renting them out to city employees on a first-come first-served basis. Tyler has also been researching an app-based system, but it is very rudimentary at this time.
- Update on Transportation Commission: It appears as though there is a full roster of candidates that will go to the Mayor's office next for approval. The goal is to begin meeting in October for the first time. Lauren Pangborn would be the BAB liaison to the TC.

Current Agenda: The current agenda was approved unanimously.
