#### Proposed New Agenda Items:

- Wilma Flanagan's term expiring
  - Wilma will inform Bicycle Advisory Board of the need for a new representative for CTAB.
- Brandon Blankenagel pitched the ability to use the Cincinnati Greenway 500K to do a grind and overlay project on both sides of the street on Manito Blvd., 21<sup>st</sup> Ave.-33<sup>rd</sup> Ave., he explained this was an idea from staff, not the Council.
  - Staff Scenario 1:"We (Integrated) ends up needing the Cincinnati money to help fulfill STA's vision near the college where we line up with similar goals".
  - Staff Scenario 2:"We shake loose that 500K by finding a way to accomplish the Cincinnati Greenway without it which we essentially had to begin with".
  - TBD Board would have to approve the ability for CTAB to move the 500K around as they approved and dedicated the 500k specifically for the Cincinnati Greenway project.
  - o Is it better to shift dollars in order to do integrated work making complete streets?

## Discussion and Approval of the 2016 Annual Report to be presented to the TBD Board:

- The Board reviewed each page of the draft version of the annual report for any errors or edits.
- There was a discussion regarding how the dollar balances change as the different projects are finished and billing finalized.
- Per Brandon Blankenagel, Arthur Street grind and overlay project may be delayed in the project program if a grant comes through.
