Alice Report:

Andrey from the United Way was kind enough to join us at our meeting and provide the board with the following information. A power point was shared with the members via the WebEx platform.

- The Alice report was first published in 2016, and their publication came out in 2020 which used the data from 2018.
- The People of Alice Who is Alice Alice stands for Asset Limited (has no safety net in times of crisis), Income Constrained (Not enough to afford basic household necessities) Employed (working, yet financially at risk).
- ALICE individuals often work as cashiers, nursing assistants, office clerks, servers, laborers and childcare providers. Essential workers are often Alice's individuals.
- History of Official Poverty measure was created in 1963 and used the cheapest food plan x 3 to determine the poverty threshold. 50 year later this is still how the federal government determines who is in poverty, this figure does not include the basic household necessitates.
- 2018 for a household of 4, if they were under \$25,100 then they were considered at 100% poverty.
- ALICE household survival budget includes housing costs, food, Health Care, Child Care, Transportation, Tech and Misc. taxes. This survival budget for a household of 4 to \$54,168. 35% of those in Spokane are in the ALIVE threshold.

Here is the background on what has been done so far. Board member Whigham sent out versions of the new bylaws a few days ago for everyone's reference. There were several areas that the members and city staff had questions on and were going to do some research and bring back information at a future meeting.

Rental Assistance NOFA:

The RFP committee give a brief rundown on the committee is bringing forward.

- Copy of the NOFA project been working on the past couple of months. Providing
 ways to provide funding to those who do not just need rental assistance buy
 mortgage assistance.
- NOFA and application have been through the RFP committee, pending the approval of the CHHS board, we will make this available to the community. The NOFA will run 4.8.21 4.22.21. After the RFP was closed it will be going to committee for a few days from review and will meeting on 4.26.21 and to recommend that will be brought to the board at the May meeting. After this recommendation has been made it will go be before council and then for final approval on 5.17.21.
- June 1st will be the start of the contract for Rental, Mortgage and Utility

assistance.

Motion to approve the allocation of \$2 million for rental, mortgage and utility assistance and for the RFP to be released on 4.8.21 moved by board member Barfield and seconded Council Member Betsy Wilkerson.

COVID-19 Emergency Housing & Utility Assistance RFP - Action Required

Subject:

COVID-19 Emergency Housing & Utility Assistance RFP summary of applications and funding recommendation.

Background:

Members of the Evaluation and Review Committee met on Monday, April 26, 2021 to discuss applications received in response to the COVID-19 Emergency Housing & Utility Assistance RFP. The Committee discussed each proposal (see table below) and came to a recommendation that CHHS fund the Better Health Together proposal based on their response to the priorities outlined in the RFP. Staff was asked to follow-up on a few outstanding questions to the Better Health Together application. Better Health Together provided their response to staff on Friday, April 30th. The response addressed each question, but left the split between direct client services and operations/administration unanswered, due to the nature of their proposal. Anne will provide additional information during the CHHS Board meeting regarding her conversation with Better Health Together.
