## CDBG-CV Rental Assistance:

- Board Member Anne Whigham who also sits on the Evaluation and Review committee informed the board that for this RFP five (5) applications were received for this and the committee has decided to recommend the applicant Better Health Together.
- Better Health Together within their application they are not taking any administrative costs and going straight to the program. Better Health together would bring in other programs that will bring in communities for the underserved. Group will be doing trainings on how to do a budget and how to best use the funds. This group will be using their own direct admin support for this program.
- CDBG money coming in from the Feds, needs to be used for COVID relief and will be used for rental, mortgage, and utility assistance.
- When the RFP was released there were very clear parameters on what was being looked for when one applied for funding. Smaller Organization just do not have the experience to put out the funds or the capacity to work on a refund basis. Better Health and put in their application that they would help smaller organization with training and help with

getting the funds out the door to those in need.

- Is there going to be an incentive for the smaller communities to want to reach out to Better Health to see if they can get some of the funds?
- Better Health will be working with the different programs and coming up with a budget and then presenting it to City Staff. City Staff will be in the know and should see a budget back within 4-5 weeks. It is known that some organizations will require more admin than others.

#### **Treasury Emergency Rent Assistance RFP – Action Required**

June 7, 2021

#### Subject:

Department of Treasury Emergency Rent Assistance RFP summary of applications and funding recommendation.

#### Background:

Members of the Evaluation and Review Committee met on Monday, June 7, 2021 to discuss applications received in response to the Treasury Emergency Rent Assistance RFP. The Committee discussed each proposal (see table below) and came to a recommendation that CHHS fund both the Family Promise and LiveStories' proposals based on their ability to deliver funds expeditiously and in compliance with the Department of Treasury's guidelines. Committee members did express concerns that the urgency to release these funds perpetuates disparities in which agencies apply and are awarded. Committee members requested staff include conditions within each contract that ensure:

- Comprehensive translation services
- Engagement with broad network of BIPOC and 'By and For' partners
- Meaningful compensation for community partners engaged in program
- Equitable program access for those uncomfortable with online applications

The table below provides a summary of each application received:

#### Impact:

Funding both Family Promise and LiveStories will allow for efficient delivery of rental relief to City of Spokane renters. Both organizations are currently administering and distributing Treasury rent assistance and have program infrastructure in place. LiveStories' program will be open to all households, while Family Promise will specialize in households with minors. These funds will prevent evictions and support housing stability for individuals and households directly impacted by the COVID-19 pandemic. Direct client services include rental and utility assistance.

#### Action:

Vote to approve RFP Committee recommendation that CHHS enter into contract with Family Promise and LiveStories.



## **Emergency Rental & Utility Assistance**

**Description:** The city of Spokane has been awarded emergency rental assistance program dollars (\$9.26 mm) to disperse to qualifying and eligible families. No less than \$7.64 MM of the funds must be used for direct expenses related to: rent, rental arrears, utility and home energy cost arrears, and other expenses related to housing. Grantees must additionally work with "By and For" organizations in the Spokane community that assist and serve marginalized populations. Specifically \$441k has been identified to support organizations that work with ethnic and racial minorities, immigrant and refugee community, individuals who identify as LGBTQ+, individuals with disabilities and the Native American community.

<u>*Time frame:*</u> 65% of funds must be encumbered no later than 9/30/21. Failure to do so will result in financial resources being recaptured and distributed to other regional entities.

## Eligibility:

## CARES Act and State Rent Assistance - Washington State Department of Commerce

Renter households (no ownership language), where the household meets all three of the initial screening criteria:

- 1. Income at or below 80% of the <u>Area Median Income</u>
- 2. Experiencing a financial hardship directly or indirectly due to the COVID-19 outbreak that threatens the household's ability to pay the costs of the rental property when due.
- 3. At risk of experiencing homelessness or currently experiencing housing instability.

Prioritization for households who have individuals who have been unemployed the previous <u>90 days</u> prior to application, or have a household member who is at or below <u>50% of AMI</u>.

#### US Citizenship is NOT an eligibility requirement of this program.
