BRIEFING PAPER Community, Housing & Human Services Board 2023 HOME-ARP Supportive Services Only Funding Allocation December 6, 2023

<u>Subject</u>

This briefing paper discusses the Affordable Housing Committee's recommendations to:

- Allocate a total of \$888,224 in HOME-ARP supportive services only funds for the 2023 program year to Spokane Neighborhood Action Partners (\$462,861), Community Frameworks – Sinto Commons (\$225,000), and Community Frameworks – Multi-Sites (\$200,363).
- 2. Require CHHS staff to submit a substantial amendment request to HUD to fund the total amount of supportive services only requests received through the HOME-ARP request for proposals.

Background

In 2021, HUD allocated \$4,628,671.00 in American Rescue Plan funds to be administered through the City of Spokane's HOME Investment Partnerships program for the provision of housing and services to households meeting one or more of the following qualifications:

- 1. homeless, as defined in section 103(a) of the McKinney-Vento Homeless Assistance Act, as amended (42 U.S.C. 11302(a)) ("McKinney-Vento");
- 2. at risk of homelessness, as defined in section 401 of McKinney-Vento;
- 3. fleeing, or attempting to flee domestic violence, dating violence, sexual assault, stalking, or human trafficking;
- 4. part of other populations where providing supportive services or assistance would prevent a family's homelessness or would serve those with the greatest risk of housing instability; or
- 5. veterans and families that include a veteran family member that meet the criteria in one of (1)-(4) above.

HUD required each participating jurisdiction to submit an allocation plan for HUD's approval before the participating jurisdiction could allocate HOME-ARP funds. The City of Spokane collaborated with Spokane County in providing a total of eight (8) presentations to member organizations or individuals representing the Continuum of Care, Spokane Housing Authority, homeless service and shelter providers (including the Spokane Homeless Coalition), regional government, affordable housing developers, veterans' affairs, and consultations with domestic violence service providers, fair housing, and human rights agencies, beginning in December 2021 and continuing through June 2022.

Member organizations provided a broader reach and included more interested parties, contributing to good feedback through the HOME ARP survey. An informational web page was developed where interested parties could review every PowerPoint presentation, the CPD notice and guidance, as well as factsheets on HOME ARP. A link to the regional survey, for

feedback on development of the HOME ARP Plan, was also located on the informational web page. The survey had good responses from stakeholders and provided insight on the perceptions of the community regarding the best use of funds.

The City of Spokane publicly announced the HOME-ARP allocation plan on November 23, 2022. On December 07, 2022, the City of Spokane held a public hearing regarding the HOME-ARP allocation plan and opened a 30-day public comment period. Public feedback throughout the lengthy public participation process overwhelmingly favored increasing affordable housing options for the qualifying populations. In alignment with the community's needs, the City of Spokane drafted the following allocation plan for HUD's approval:

HUD approved the City of Spokane's HOME-ARP allocation plan on March 31, 2023. The Community, Housing, and Human Services Department released the HOME-ARP Request for Proposals (RFP) on August 21, 2023. Affordable housing providers had until September 21, 2023, to submit applications for funding that met the following priorities:

- New Construction of Affordable Multi-family Housing.
- Acquisition of multi-family projects with or without rehabilitation.
- Supportive services in a multi-family housing project. (\$462,867 is the total amount of HOME-ARP funding available for supportive services.)

Staff provided an applicant workshop on August 28, 2023. Individual technical assistance was provided to 13 organizations interested in HOME-ARP funding. CHHS received six HOME-ARP applications. One of the supportive-services-only applications, and one of the development-of-affordable-housing applications did not meet minimum thresholds as established by HUD and could not be considered for funding. Of the remaining applications, three supportive-services-only projects, totaling \$888,224 in requested funding, were staff reviewed and forwarded to the Affordable Housing Committee for consideration. One development-of-affordable-housing application was received, passed the initial threshold review, and was submitted to the Affordable Housing Committee for consideration.

On October 19, 2023, the AHC met to discuss their independent reviews of the HOME-ARP applications. The Affordable Housing Committee voted to recommend the Spokane Housing Authority's Hifumi En expansion for HOME-ARP funding. However, subsequent conversations with the applicant determined that the HOME-ARP qualifying population restrictions are incompatible with the requirements of the project's other funding sources. The applicant cannot accept the HOME-ARP allocation.

After a thoughtful and thorough discussion of the supportive-services-only projects on October 19, 2023, the Affordable Housing Committee requested additional information from the applicants and additional time to review the applicant materials before making a funding recommendation. The Affordable Housing Committee met on November 14, 2023, to discuss their second independent reviews of the supportive-services-only applications and supplemental application materials, and the HOME-ARP funding challenges and restrictions.

Projects discussed:

- 1. Spokane Neighborhood Action Partners' (SNAP) request for \$462,861.00 to establish a *Road to Resilience Tenant Support* pilot program. This project will provide outreach services, life skills, employment assistance, meals and groceries, mental and outpatient health services, transportation, case management, landlord/tenant liaison services, and housing related financial support to qualifying tenants in approximately 108 households throughout five SNAP-owned affordable housing properties, over a three-year contract term. The three-year contract term would permit SNAP time to set-aside a per door percentage of reserves to fund a case manager at the end of the contract term. The detailed description of the supportive services to be offered, the program objectives, and proposed program outcomes are attached.
- 2. Community Frameworks request for \$225,000 to expand supportive services in Sinto Commons. Sinto Commons currently offers supportive services to 23 households and those services are built into the overall budget for the property. With the three-year HOME-ARP grant, Community Frameworks will expand the supportive services to as many as 47 qualifying households, and will assist tenants with meals and groceries, life-skills training, transportation, case management, and mediation for the three-year term of the contract. During the three-year contract term, Community Frameworks will work with other funders to identify longer term funding for expanded supportive services at Sinto Commons. The detailed description of the supportive services to be offered, the program objectives, and proposed program outcomes are attached.
- 3. Community Frameworks requested \$200,363 to establish a Multi-Site Supportive Services Only project. The project would serve 144 qualifying households at four different Community Frameworks owned properties. Currently, Community Frameworks can pay for 0.25 FTE to provide supportive services at these locations. The HOME-ARP funds would be used to fund 0.75 FTE of a resident coordinator position to assist tenants with meals and groceries, life-skills training, transportation, case management, and mediation for the three-year term of the contract. Community Frameworks intends to use rent revenue at the properties, and additional external funding to sustain services following the end of the contract term. The detailed description of the supportive services to be offered, the program objectives, and proposed program outcomes are attached.

Additional Discussion:

 Regulatory challenges of the HOME-ARP funding source limit other public and private funders in an affordable housing development project, making the funding source difficult to award to affordable housing development projects that use typical affordable housing funding sources. Flexibility within the HOME-ARP funding source allows for increasing the amount of money for supportive services, and set-aside funding for other eligible activities through a HUD-approved request for a substantial amendment to the 2021 Annual Action Plan.

<u>Timeline</u>

- If the CHHS Board votes to approve the Affordable Housing Committee's recommendation to amend the 2021 Annual Action Plan, HOME-ARP allocations, then CHHS will develop the substantial amendment for submission to HUD in January. The public comment period will be opened as an action taken by the CHHS Board at its next meeting.
- If the CHHS Board votes to accept the Affordable Housing Committee's recommendations to fund the three supportive services only projects, and HUD approves the substantial amendment request, then CHHS will submit the supportive services only project recommendations to Council for review and approval.

Impact

The HOME-ARP funds allocated to SNAP's Road to Resilience Tenant Support project will provide supportive services to 108 qualifying households, in 5 SNAP-owned properties for a three-year contract term. Impacts of this program are detailed in the attachment.

The HOME-ARP funds allocated to Community Frameworks Sinto Commons Supportive Services Expansion project will increase the supportive services offered at Sinto Commons from serving 23 households to serving 47 qualifying households for the three-year contract term. Impacts of this program are detailed in the attachment.

The HOME-ARP funds allocated to Community Frameworks Multi-Sites Supportive Services project will provide the supportive services offered to 144 qualifying households at four Community Frameworks owned properties for the three-year contract term. Impacts of this program are detailed in the attachment.

Actions

The Affordable Housing Committee met on October 19, 2023, and November 14, 2023, to review applications and voted to take the following actions:

The Affordable Housing Committee recommends that CHHS submit a substantial amendment request to HUD for approval to amend the 2021 Annual Action Plan HOME-ARP allocations.

If HUD approves the substantial amendment request, then the Affordable Housing Committee recommends that City Council commit \$462,861 to Spokane Neighborhood Action Partners,

\$225,000 to Community Frameworks – Sinto Commons, and \$200,363 to Community Frameworks – Multi-Sites in HOME-ARP funds.

The total amount of HOME-ARP funds recommended for allocation to supportive services only projects by the Affordable Housing Committee is \$888,224.

Dear Jennifer,

I am writing to appeal the provider selection for the recent RFP for the Trent Resource and Assistance Center. The Salvation Army stepped into the role of shelter provider at TRAC when an emergency need arose for a new provider to run the TRAC shelter. We came in with expertise and began implementing changes within the way the shelter ran to help bring operations up to best practice standards, to ensure the safety and success of guests and employees. As soon as we hit the ground running, we knew that we needed to utilize services already being provided within our community and sought out non-profits and other organizations already doing the work who could come alongside us and help bridge gaps within our services. Our success in running the TRAC shelter is hugely due to the relationships and partnerships that we have with those within our community that provide needed services to the individuals who stay within the walls of TRAC. Please see attachment.

I am asking that you reconsider the decision made by the CHHS committee. The Salvation Army has decades of experience running shelters. There are many success stories that can be shared to reflect the good work that is happening at TRAC. We felt the struggle with changing providers in November 2022, when we began operations of the shelter, and we feel that it would be a disservice to our guests to interrupt shelter operations with another provider change, less than a year after starting as the second provider. We have gained the trust of not only the guests we serve within our facility, but also the businesses surrounding the facility. We have been audited by the City of Spokane for this shelter and have had no findings. We have a proven track record for running shelters and helping those who are in desperate need of services, fair and honest.

We believe, given the opportunity to provide the services of shelter and case management at TRAC, would allow us to provide wrap around services from the streets to being housed. We have proven success with our Bridge Housing model, The Way Out Center. We ask that you allow our track record to speak for itself and continue to allow us to run the TRAC shelter.

Summary (Background) *use the Fiscal Impact box below for relevant financial information	Extension amendment for TRAC and Salvation Army for four months (January – April 2024) and inclusion of 2023 safe air and warming center costs and budget not on the original February 2023 contract. The purpose is to ensure uninterrupted emergency shelter services through winter and allow for a new transition plan to be created in 1Q 2024 that includes wind-down and transition scope and costs. Scaled to start transition mid-month April. New effort and administration priorities are required to transition to closure and movement of people and services from May through summer.
	This amendment includes warming center costs, summer and winter surge, and higher number at TRAC consistently (low/mid 300's to high 300s daily) which results in higher variable costs (meals, laundry, portable facilities, consumables) during the winter months. The 2023 dollars are already planned/available (not a new dollar request) and just need to be added to the existing contract. Breakdown of the funding is described below:
