





## **Navigation Center**

Service enriched entry point shelter for high needs adults experiencing homelessness. From the navigation center individuals are referred to appropriate longer stay placement options.

- On site coordination and operations staff 24/7.
- Visiting Providers to address health needs.
- Housing focused individualized and holistic supportive services.
- Limited stay overnight shelter capacity for approx. 30 people
- Smaller scattered shelters can address populations specific needs and strengths.



## **Implementation Timeline**



### **RFP Highlights**

- •Anticipate \$8 Million to address decommissioning of TRAC and launch of new model
- •\$4 Million from State Legislature
- •\$4 Million in Emergency Housing Fund Grant from WA Department of Commerce
- •Includes an operator for the Navigation Center to coordination and facilitate partnerships and outcomes
- •Working to identify opportunities for capacity building to ensure opportunities for new organizations
- •Planning to include surge capacity to address heating/cooling/air quality

Updates from SRHD

- Vax Expo is this Wednesday
- Board of Health has approved a feasibility study for the separation of SRHD's Opioid Treatment Division from the health district
  - This is NOT a reduction in services, and Treatment Services will remain under SRHD until further notice

Updates from Sarah (Providence Community Clinic)

- Still going to shelters to provide care
- Partnering with Molina's mobile RV unit to provide care

Updates from Anne (Fire Department)

- Expanding CARES department—more social workers will be available
  - Social Work hours are M-F 8 am to 5 pm (hope to expand to weekends at some point)
- Medication assisted treatment—still providing Suboxone on the street
  - Struggling to find right clients for suboxone program
  - Ideal client is someone who got a lot of Narcan and is conscious and able to consent; people may be more likely to consent if the Narcan has started withdrawal symptoms
  - Many potential clients are taken straight away in ambulances and there is no way to intervene with Suboxone at that moment
  - Suboxone hours are M-Th 10 am to 8 pm
- Patients initiated on Suboxone will have a warm handoff to a treatment facility
  - Provider-to-provider handoff
  - Social worker team will follow patient to make sure they have transportation, are keeping up with treatment, etc.

Updates from Luis (CHAS Street Med)

- People do not need to be in full withdrawal to get Suboxone
- Many people who are resuscitated from overdose are not willing to go to the hospital
- Wait 3 minutes between Narcan doses (start a timer because 3 minutes feels like a long time when a person isn't breathing)
- Provide rescue breaths every 6 seconds if the person is not breathing (pale/purple lips are a symptom of not breathing)

- CPR (chest compressions) are rarely needed in overdoses (compressions are only necessary if a person hasn't been breathing for long enough that their heart has stopped)
  - If you see someone go down, they likely do not need chest compressions (they haven't been overdosing long enough for breathing and then heart to stop)
  - Check pulse—providing chest compressions while a person has a pulse is harmful

Updates from Gidget (Revive)

- Wellpoint's (previously Amerigroup) housing system is frozen for now
- People can still do housing assessments during the freeze

• HH will be trying out the new SHA online application.
