VOA Youth Shelter Affordable Housing: Adriane and George gave an overview of the funding and goals and decisions around the project so far. Some of the challenges that required it to be re-bid was the delay between the bid and now as well as a lack of prevailing wages included in the first bid. George followed up with confirming that CHHS staff want to get the RFP out and get the money out.

<u>City Council Updates:</u> Johnathan gave an update on the proposed flex-capacity shelter and Johnathan and Betsy updated on the next round of rental assistance funding.

<u>Applicants and Committees:</u> Barry encouraged board members to join committees. Barry then asked about if it would be possible to expand the board to more than 12 members. Some brief discussion followed.

<u>Director's Report:</u> Jenn gave a brief overview on the staffing of CHHS. Jenn then spoke about the ERA grant and when the rental assistance portal can be re-opened. She also spoke about the new RFP for the Flex-Capacity Shelter and the changes made to try to encourage more applicants. Then she gave a brief update on the PIT Count numbers and when they will be submitted to HUD. Jenn spoke on the workload regarding the many RFPs going out right now and the CoC contracts being renewed and asked for some patience while staff work on those heavy lifts.
