<u>HHOS Funding Overview and Upcoming NOFA:</u> Jenn Cerecedes provided an overview of the next HHOS funding cycle and next steps. Discussion followed.

<u>Director's Report:</u> Jenn Cerecedes gave an update on what the CHHS Department is currently working on, staffing, the department remodel, funding, and future plans. Some discussion followed.

<u>City Council Updates:</u> Karen Stratton shared that the Study Session will include an update on the PDA with Gavin Cooley.

Committee Updates:

Affordable Housing: Adriane provided an update for Affordable Housing – they had a presentation on the Low-Income Housing Consortium which included a request to set a schedule for funding, which was agreed there should be more of a schedule to it. That had to do with staffing mostly so there will be more support moving forward now that CHHS is fully staffed. AF will also be meeting in June.
