- Affordable Housing Committee recommendations:
 - Affordable Housing RFP

David shares the AHC recommendations for the PY2025 Affordable Housing RFP. CHHS received eleven (11) applications, and all applicants received technical assistance. In funding recommendations of the committee, we recommended to fund projects in

summary that would create 95 new construction units, preserve 50 units through rehabilitation, would create 49 units through conversion of larger units into studios, and 12 new townhomes. Also, tenet based rental assistance would support for 86 households. A total of nine (9) of the eleven (11) applications received full or partial funding.

David Edwards motion to accept recommendations, Hollis seconds, passed unanimously

- HUD Certified Counselor Services

David shares that funding at the federal level had caused HUD counselors to be not properly funded. These counselors work with people in foreclosure situations. A rush RFP that came out Monday, June 23rd. ACH committee was bumped up to Tuesday, July 1st to vote on RFP. Only had one applicant. Applicants had to provide HUD certifications that they were certified. 1590 funds will be utilized to fund these services.

David motion to fully fund SNAP application for HUD Counseling, Leslie second, passes unanimously

- NECC request for additional funds

Northeast Community Center is requesting an additional \$30,979 for their "Covered Walkway" project. Other providers had de-obligated funds due to unspent funds. Funding based on circumstances on timing and explanation of the need of additional funds. Wes shares it was a cost overrun.

David motion to approve request for additional funds, Wes Anderson seconds, passed unanimously

Department updates

Areille shares we are currently working on contracts, just received grant agreement from commerce. Routing agreement internally and will go to the Urban Experience Committee on July 14th to accept funding. Then contracts will be routed out for signatures. Statement of work provided to agencies for them to fill out and provide total numbers of beds or thing that we are supporting.

Also, working closely with local universities to create a story book/map and presentation should be ready in September.

- City Council Nicolette, Council passed two of the four homeless ordinances. Council Members and key staff attended AWC, Association of Washington Cities, will provide a full update to the Urban Experience Committee. CM Navarette no longer with Council, will be

working in CHHS department moving forward. A new council member will be taking her place, on July 10th interview for the final candidates. July 28th the vote will be held to replace CM Navarette. No Homeless Coalition meeting tomorrow, nor in August. Any changes to the human rights section of the Spokane municipal code will need to go in front of Human Rights commission for review. Council voted on Monday ensuring that the multi-family tax exempted are not being used for Air BnB's but for home ownership opportunities.
