### **New Business: CHAS/COC Collaboration Request**

Lance Laurier, Grants Director at CHAS Health, discussed the application CHAS is submitting to SAMHSA in response to the FY 2023 Grants for the Benefit of Homeless Individuals NOFO. Katie (LM?) commented that CHAS will utilize the grant to fund Street Medicine Team ie Narcan, connections to MAT, SUD professional with SMT (up to \$500,000/year for 5 years); focused on unsheltered and reoccurring; application due date March 21st

On March 3, Co-Chair Arielle Anderson called for an email vote to approve the CHAS letter of commitment presented at the February 22 meeting.
