Joe Ader; Questions re: Universal ROI and Executive Order (EO) section 5i related to collecting health related information and sharing with law enforcement being a HIPAA concern.

Arielle; Universal ROI sent for comment to committees, or will route soon for feedback. Planning for October rollout of new ROI.

Blake requests copy of ROI for possible use with their system, Arielle will send.

Arielle; Proposed changes in EO tied up in litigation, recent decision that contracts can't be held up, hoping to see grant agreements soon. Citizenship piece being litigated, can't see if it's included in the agreements until they're received.

RFP Committee Meeting

RFP evaluation committee intended to be ongoing regarding allocations of funding. Mandate of UFA within CoC to maintain group.

Next meeting will be September 23rd to review Fourth quarter QPR reports, renewal of and potential competition for 2026 funds, and whether or not we have funds to de-obligate.

RFP may be issued for funding of next year's projects. Current application was intended for two years but it appears that we'll need to apply again. May need special board meeting depending on timeline.

Meeting attendees should be mindful of potential conflict with projects being discussed for funding.
