Meeting Process - Spokane Design Review Board

Call to Order

- Chair calls the meeting to order, noting the date and time of the meeting.
- Chair asks for roll call for attendance.
- Chair asks if there any changes to the agenda.
- Chair asks for motion to temporarily suspend the rules (see Agenda packet)

Board Workshop

- Chair announces the first project to be reviewed and notes the following: a) the Board will consider the design of the proposal as viewed from the surrounding public realm; b) the Board does not consider traffic impacts in the surrounding area or make recommendations on the appropriateness of a proposed land use; c) the Board will not consider un-permitted, possible surrounding development(s) except those which are contemplated under the Comprehensive Plan and Development Code; c) it is the applicant's responsibility to meet all applicable Code requirements regardless of what might be presented or discussed during workshops.
- Chair asks for a staff report.

Staff Report

- Staff report on the item, giving findings of fact. Presentation will be kept to 5-10 minutes.

Applicant Presentation

- Chair invites the applicant(s) to introduce the project team and make a 10–15-minute presentation.

Public Comment *

* During the Stay Home, Stay Safe order, public comments are being accepted in writing.

DRB Clarification

- Chair may request clarification on comments.

Design Review Board Discussion

- Chair will ask the applicants whether they wish to respond to any written public comments, after their response (if any) they are to return to their seats in the audience.
- The Chair will formally close public comments (unless motioned otherwise).
- Chair leads discussion amongst the DRB members regarding the staff topics for discussion, applicable design criteria, identification of key issues, and any proposed design departures.

Design Review Board Motions

- Chair asks whether the DRB is ready to make a motion.
- Upon hearing a motion, Chair asks for a second. Staff will record the motion in writing.
- Chair asks for discussion on the motion.
- Chair asks the applicant if they would like to respond to the motion.
- After discussion, Chair asks for a vote.

Design Review Board Follow-up

- Applicant is advised that they may stay or leave the meeting, and that the annotated & signed motion will be made available within five working days.
- Next agenda item announced.

Board Business

Minutes: Minutes from 9/24/2025 approved unanimously.

Briefing Session:

Chair Report - Mark Brower

- Mark discussed the status of the board. With multiple members terming out at the end of the year, he wanted to check in regarding their roles.

Secretary Report - Spencer Gardner

- Spencer mentioned that there may be an uptick of new projects in the new year with the approval of the school bond.

Motion passes unanimously, 5-0-0.

Based on review of the materials submitted by the applicant and discussion during the November 19, 2025 Collaborative Workshop the Design Review Board recommends the following advisory actions:

- The Applicant is encouraged to develop the material and color palette of the building to compliment and integrate the concrete wall into the entire composition of the Boone facade.
- The Applicant is strongly encouraged to maintain and prioritize landscaping as a means of softening the north property edge and existing concrete wall.
- The Board appreciates the transparency of the proposed rail at the existing concrete wall.
- The Board is supportive of the design of the entrance courtyard and the positioning of trees to avoid infrastructure.
- The Applicant is strongly encouraged to consider the final rail placement with regards to its proximity to the concrete wall to maintain the layering between the public sidewalk and building as presented.
- The Board is supportive of the proposed material palette of the new building and its relation to the existing building.
