- President Chris Venne opened the meeting at 12:01p.
- November 15, 2023 Minutes (Dana/Darryl) were approved as written.
- Reviewed the 2024 Management Report
 - We discussed the ongoing fixed assets maintenance issues concerning:
 - Lights and Lighting
 - Getting onto the City's six-year planning project
 - Cost of lighting three blocks worth of existing light poles
 - Estimated cost of streetscape per block
 - Extending the Sprague Streetscape east and west to encompass the whole District
 - Having the City look for Grants (Streets Department) to pay for the additional construction to complete the District
 - Holiday lighting was paid for and installed by Visit Spokane (Merry and Magical)
 - There were several businesses that expressed interest in extending the program beyond the electrical constraints with the City light poles
 - Include lights for the buildings where electrical is not available along Sprague for 2024
 - Rezoning parts of Sprague Avenue where goods and services cannot match the rest of the District from Zone 1 to Zone 2. We acknowledged that this is a goal to complete prior to the 2025 assessment.
 - It was noted that snow and sidewalk trash removal has not been happening east of Altamont
 - Concerns were raised about using one vendor to complete various activities (snow removal, garbage pickup, etc.)
 - Events need to be more comprehensive across the District to include the businesses east of Altamont
 - Amanda was going to check on what the ARPA money could be used for. There
 does not seem to be a clear path on how to capture the money, or how or where it
 could be used.
- Ratepayer BID Board Election: Nominations were approved as slated (Dana/Chris)
 - Chris Venne President
 - Amy Vega Vice President
 - Tresa Schmautz Treasure
 - Dana Reinke Secretary
 - Sam Mace Zone 3 representative

- Financial Reports Tresa Schmautz
 - Financial income and expenses are operating as expected.
 - 93% of the invoice money has been collected for 2023. Additional money could be received in December.
 - An invoice for \$19,652.05 was sent to the City for 2023 payment.
- Neighborhood Beautification Amy Vega
 - Bob Mauk reported that the flower baskets and 10 additional hangers have been ordered.
- District Branding and Marketing Dana Reinke
 - Holiday on the Ave was a success. (December 2nd)
 - Street Lighting Program December 1st at 4:30p
 - Street Lighting, Santa, Wakeup Call Hot Chocolate, 25' foot tree on the corner at the Tin Roof – was well attended. However, the City Staff's failure to turn on the lights as requested resulting in many disappointed people.
 - 2024 install lights on buildings
 - Flag discussion Dana was going to send LaVerne the vertical flag design. All the US flags and flag holders have been purchased.
 - We will add a metal chain gromet to the flag holders.
 - Feather Event Flags for participating businesses
 - CSO Event Center We are working with Visit Spokane to make this happen in 2024.
 - To Do: Event Committee will draft a policy and budget. (Dana, Sam, Heather, & LaVerne.)
- Clean and Green LaVerne Biel
 - Contact Sumac about litter pick up and snow removal not occurring on the east end of Sprague Ave.
- Safety and Security Darryl Reber/Chris Venne
 - Darryl observed that the viaducts remained clear (except a blue tarp camp near ESD101).
