- President Chris Venne opened the meeting at 12:01p.
- December 2023 Minutes (Jim/Chris) were approved as written.
- City Report
 - Amanda will check with Council Member Zappone. Some money has been allocated for a consultant with capacity building. No additional information is available.
 - o The deadline for ARPA money is December 2024.
 - We discussed the financial impact of changing a portion (east end) of Zone 1 to Zone
 - How can we do things differently?
 - What goods and services can we provide with the restrictions currently in place?
 - Lower service would also lower some of our expenses
 - Calculate 2025 projected revenue for these changes
 - What method can we use to push out notifications to ratepayers to send Minutes and Events out?
- Financial Reports Tresa Schmautz
 - Financial income and expenses are operating as expected.
 - 93% of the invoice money has been collected for 2023. Additional money could be received in December.
 - The City invoice for 2023 was paid on 1.4.24 for \$19,652.05.
 - We received additional funds for 2020 and 2022. That money was sent via check and deposited.
 - Reviewing the 2023 financial statements expense \$4,800 was for depreciation.
 - We broke even
 - George reviews the accounting procedures and approves the checks written.

 - Spring on the Ave is scheduled for April 20, 2024
 - The Committee will be holding a meeting at the end of January.
