- President Chris Venne opened the meeting at 12:03p
- August 20, 2025, minutes (Jim/Darryl) were approved as written.
- Financial Reports Tresa Schmautz
 - 2025 Normal financial position for August
 - 93% of Ratepayer invoices were paid through August.
 - September invoice was submitted and paid for the third quarter.
 - Bookkeeping: Transition from QuickBooks to Zoho Books approved. (Amy /Jim) for 2026. George and LaVerne will work on the conversion process at the first of the year.
- Police Report Officer Prim
 - Officer Prim reported on a new program and introduced a new specialist.
 - o RV issue: An RV was towed due to being inoperable; housing resources were located for the family. However, the RV remains problematic. Social workers have improved coordination with police in addressing these challenges.
 - o Viaducts: Semi-cleared but continued to require monitoring.
 - o Bikes/Suburban area: Containers at Tormino's are being moved.
- Administrative LaVerne Biel
 - Economic Development Programs:
 - 2026 Avista grant for Branding and Marketing our holiday lights
 - Tresa and Amy will work on an Avista grant to use Dignified Workday.

BID Programs:

- Clean and Green Jim Hanley
- **Sprinkler issues:** Community sprinkler line broke off; Tom (B&C) and Carl (City of Spokane) have been doing an excellent job maintaining sprinklers and grassy swales along Riverside.
- District Beautification LaVerne Biel
 - The Board recommended that we order 105 16" plants for the hanging baskets, and 9 12" plants for the planters east of Altamont.
 - We are looking for watering bids east of Altamont to maintain the plants. Dignified Workday will provide a quote.
 - Trees: It was reported that several trees have not been replaced. (1919 E Sprague & in front of the Key Shop)

- <u>District Branding & Marketing</u> Jim Hanley, Chris Venne, & Shayla Scott
 - Paul Dillon suggested that we look at the **Taci grant** application for neighborhood tourism promotion.
 - o Lighting: Across-the-Street lights were briefly discussed.
 - Proposal to wrap trees and poles with lights, like Perry Districts last year's project.
 - o Donations committed: \$3,000 + donated lights from last year.
 - o Possible: Edge Construction to assist with lift and tree installation.
 - Holiday lighting program includes exploring solar-powered flag lights (Amazon) and additional tree lighting and flags.
