#### Member Election

Dan Brown was the only member nominated for election, so he was elected to the Board and will serve until 2017.

# **Special Meeting**

The Board decided to hold a special meeting on February 24, 2016 in place of the regularly scheduled meeting on March 3, 2016. The Hyas Group will present the quarterly investment performance report at the meeting.

# **Board Rules**

Several changes to the Board Rules were presented.

1) In Section 3, Increase the time limit for submitting invoices to 24 months for both vendors and participants.

- Dan Brown moved and Clive Jones seconded the motion to change the Board Rules. The motion passed unanimously.
- 2) In Section 5, Necessary cleanings and repair of hearing aids will be paid in full. Clive Jones moved and Terri Pfister seconded the motion to change the Board Rules. The motion passed unanimously.
- 3) In Section 5, Hospice care at a Hospice Facility shall be handled in the same manner as Assit Living or Nursing Home care. All other hospice care sahll be handled by the current third party administrator as outlined in the Summary Plan Description. Clive Jones moved and Dan Brown seconded the motion to change the Board Rules. The motion passed unanimously.
- 4) In Section 8, Any request for travel reimbursement shall be reimbursed at the City's rate at the time of travel and pre-approval is required. Clive Jones moved and Dan Brown seconded the motion to change the Board Rules. The motion passed 4-1, with Terri Pfister voting against.

All of the approved changes will be drafted into the Board Rules, with ratification of the amended Board Rules to take place at the next meeting.

There being no other business, the meeting adjourned at 9:32 a.m.
