OPEN SESSION

The regular meeting of the Spokane Firefighters' Pension Board was called to order at 9:01 a.m.

Investment Performance Report 2016

The Board reviewed the Investment Performance Report for the year ending December 31, 2016 and discussed broad economic trends as well as the relative performance for the Reams managed portfolio. The portfolio has maintained a slightly lower duration than the benchmark, which helped boost relative performance in the fourth quarter; but caused it to lag over the course of the year, as interest rates remained at low and declining levels. The intermediate-term fixed income market remains a challenging place to invest, with low yields and interest rates expected to rise. The return expectations should be lower in the short- to intermediate-term.

Mr. Davidson briefly discussed a recent downgrade for one of the securities in the portfolio, Nobel Holding International. The manager has been liquidating the position and only a small residual amount remained at year-end. No additional action was necessary at this time.

Investment Policy Statement

The Board engaged in the annual review of the Investment Policy Statement.

Dan Brown moved and Clive Jones seconded the motion to replace the reference to "primarily investment grade" with "only in investment grade" language in the Obligation of Financial Institutions section. The motion passed unanimously.

Clive Jones moved and Dan Brown seconded the motion to add the proposed "electronic notification" language to the Quality section of the document. The motion passed unanimously.

EXECUTIVE SESSION

The Spokane Firefighters' Pension Board went into Executive Session at 9:45 a.m., with appropriate representatives and staff present, to discuss disability reports and submitted medical claims.

The Executive Session adjourned at 9:49 a.m. and the Board immediately reconvened into Open Session.
