Disability Report

Board Rule Revisions

Several changes to the Board Rules were presented.

- 1) Rule 2.3—Increase the time limit for submitting invoices to 24 months for both vendors and participants.
- 2) Rule 2.5—Necessary cleanings and repair of hearing aids will be paid in full.
- 3) Rule 2.7—Hospice care at a Hospice Facility shall be handled in the same manner as Assisted Living or Nursing Home care. All other hospice care shall be handled by the current third party administrator as outlined in the Summary Plan Description.

Dave Anderson moved and Mark Grumbly seconded the motion to change Rule 2.3, Rule 2,5 and Rule 2.7 of the Police Pension Board Rules as stated. The motion passed unanimously.

4) Rule 2.8—Any request for travel reimbursement shall be reimbursed at the City's rate at the time of travel and pre-approval is required.

Dave Anderson moved and Mark Grumbly seconded the motion to change to Rule 2.8 of the Police Pension Board Rules. The motion passed 4-1, with Terri Pfister voting no.
