MINUTES

The meeting was called to order at 3:05 p.m. by committee chair Kris Neely who opened the meeting with introductions.

Approval of Minutes: The minutes from **December 2024** were approved. Motion by Tim Kohlhauff, seconded by Justyce Brant, approved unanimously.

Discussion Items:

- 1. Ceremonies, Appointments, Announcements -
 - Reappointment Guy Gifford. Justyce Brant motioned to reappoint Guy Gifford for another term on the UFCAC. Joe Zubaly seconded the motion. A vote was taken to reappoint Guy Gifford for another term and passed unanimously.

Standing Report Items:

Community Assembly – No report.

2. Staff Report - Katie Kosanke

Katie provided a staff report presentation update advising many projects and planning for spring are underway.

- Planning is in process for the Arbor Day Celebration, which is a free fun community event held each spring at Finch Arboretum.
- On -Track Academy (OTA) is holding their 5th Annual Tree Hero Community Event in April. They have been helping educate the public about the benefits of trees, getting teachers and students involved, and assisting with volunteer plantings in areas UF is focusing on increasing the number of trees being planted. OTA received a grant through Vita Coco to build a school yard forest classroom and Urban Forestry staff will be collaborating with students and staff at the school on designing, creating and building it. UF will mostly provide guidance with tree expertise. The model for this school yard forest could then be replicated at other schools.
- Restoration Planting continues at Down River Golf Course with the third round of planting taking place Spring 2025.
- Miscellaneous plantings will take place this spring.
- The partnership between UF and the library continues and will include seedling distributions and providing trees for the Shadle plant swap.
- Parks Planning is creating a concept design for the Nature Based Playground in the area
 of the historic willow at Finch Arboretum. Community Engagement will continue so there
 are opportunities for feedback on what the community would like the concept design for
 the Nature Based Playground area to include. Photos of people with the Willow Tree
 (since it was a popular location for such) are still being collected for a picture mosaic that
 will likely hang in the lobby of the Woodland Center. Recently, a painting of the Willow
 was donated by artist Melissa McConnell. The painting may be displayed and/or used for
 fundraising. Fundraising opportunities are being considered such as a Willow walk or fun
 run to contribute to playground project as funding has yet to be identified.
- Urban Forestry had a consult with a Washington Department of Natural Resources Entomologist at the end of January. UF and other parks staff toured Audubon Park, Manito Park, and Downriver Golf Course to confirm findings of bark beetles and learn more about opportunities to assist in preventing tree loss from beetles. Once signs and symptoms of beetles show up, typically the beetles have already emerged, and it is too late to reduce the insect population by destroying infested wood. Additional tools to assist with preventing pine beetle infestations are being worked on, such as pheromones that would repel Western Pine beetles. The Western Pine beetle pheromones are under USDA review and not on the market yet or labelled for use at this time. Neighborhood Councils will be notified of trees being removed in parks in their neighborhoods. Creating a brochure for citizens regarding how to care for their trees, general care of trees, etc. was briefly discussed and a subcommittee will be formed to work on that item.

- The tree crew is busy with day-to-day tasks and dead tree removals. UF is working on a training program for seasonal workers and operations staff so they can assist with minor pruning tasks. A yearly chainsaw training was held for Park Operation and Public Works employees who often assist with storm clean up.
- A pest readiness workshop will take place on March 6th in the Woodland Center at the Finch Arboretum. There is no cost to attend the workshop and registration is open now.
- UF staff will attend the Climate Resilience & Sustainability Board on February 13th to provide an update on the UF IRA/USDA/USFS grant project.
- Katie advised UF will be transferring some responsibility of plan review tasks back to Development Services/Planning Department in the near future. UF will continue to be involved with some tasks and will be available for consults, reports, typical tree permits and inspections at CO.

Old Business:

- 1. IRA USDA USFS Grant Update The IRA USDA USFS Grant is currently on hold and UF is seeking clarity from the grant administrator. The contractors were advised to stop work until clarity is received and they are instructed to resume work. Removals are being prioritized within the federal boundary with approximately four hundred dead trees street side. Three tree services are under contract to perform removals and over 120 trees have already been removed through the project. Prior to the grant work being paused, education and outreach continued which included tree signups, receiving commitment to care for trees from property owners, attending neighborhood council meetings to advise the work proposed foreach neighborhood, and sending notifications to abutting property owners to inform them about proposed removals. Three contractors are under contract for tree planting services, and 178 trees were planted this past fall. Pruning contracts have not been finalized, however, the bid process is complete. The pruning contracts will be presented at one of the upcoming committee meetings for review and then will be forwarded for Park Board approval. The Tree Equity website is up and running and UF has a brochure that provides additional information on the grant project.
- 2. Downtown Specific Tree Program A subcommittee will be formed to discuss ideas, challenges and priorities regarding trees in the downtown core. Ideas previously discussed include an educational program, providing tree care information to abutting property owners, partnering with the Downtown Spokane Partnership for possible watering assistance, a tree monitoring program to identify trees that need water (before they decline) and educating property owners about tree watering. Signs and symptoms as well as color and characteristics of a tree are used to read trees and soil moisture meters can be used to determine moisture level. Lidar Technology, which is a tool currently being used by utility companies, was briefly discussed. Performing an inventory and condition rating to establish a baseline rating for downtown trees before any projects are started was discussed. UF has an (outdated) inventory of public trees which collects extensive data on the trees such as species, condition ratings, etc.






