SUMMARY

- The committee approved to recommend the Park Board accept the following consent agenda item:
 - Fisher Construction Group, Inc. contract Downriver roof renovation project in the amount of \$403,424.59, tax inclusive consent agenda
- Mark Poirier presented the golf financial reports.
- Mark Poirier provided an overview of What's Happening at the Courses.

MINUTES

The meeting was called to order at 8:03 a.m. by committee chair Gerry Sperling.

Public comment - None

Action items

- Fisher Construction Group Inc., Construction contract / Downriver Golf Course Roof Renovation (\$403,424.59, tax inclusive) – Nick Hamad
 - a. The clubhouse roof repair is one of the highest priorities for the Proposed 2022 Golf Couse Capital Projects list. The current 30-year flat roof was installed in 1985 and received a Failing report from a January inspection. In June, it was sent out for bid. The lowest bidder was Fisher Construction group with a bid price of \$403,424.59 for a new 20-year membrane roof & soffit replacement. The repair will be guite extensive, including total removal of the existing roof, rebuilding the framing for the new membrane, new insulation package (which is currently nonexistent), and adding a new roof slope and scuppers for drainage. The new roof will come with a 20-year materials guarantee, 2-year labor guarantee, and the manufacture would supply cleaning, caulking, and inspection every 5 years for the 20-year warranty of the roof. This price is higher than first anticipated but is in line with the rising cost of materials. Rather than reopening the bidding process or waiting until a later time to re-bid the project, which may result in 10-15% higher costs, it is recommended to proceed with this bid. A completion date of November 1 is required, and the contractor's price is a hard bid, with no clause for increasing material prices. However, if it is determined during construction that additional building materials are needed due to unforeseen damage, a change order may be required. Separate from this contract, Parks has engaged McKinstry to assist in the removal and replacement of the HVAC units on the roof during roof construction, which would cost less than \$10,000.
 - b. Per Bob Anderson's inquiry, a cost analysis for installation of a solar array as a part of the Downriver Clubhouse roof project has not been completed, though the new roof maybe suitable for adding the array. Nick will approach City Facilities to explore a cost-benefit analysis for future addition of solar arrays. Bob asked about the boiler/HVAC at Esmeralda. Mark indicated he has been in contact with an HVAC company who believes with the proper maintenance, this equipment could last another season, whereas it is crucial to replace the roof this season.

Motion #1 – Gerry Sperling moved to approve the Fisher Construction Group, Inc. contract Downriver roof renovation project in the amount of \$403,424.59, tax inclusive. Nick Sumner seconded, and the motion passed unanimously. The committee agreed to present the recommendation to the park Board as a consent agenda item.

Discussion item - None

Standing reports

- 1. Golf financial report Mark Poirier
 - a. There was an approximate 10% drop overall in rounds compared to this time last year, keeping in mind, 2021 was a record year with stellar weather through the season. Passes are up 345 overall, with \$88,447 in revenue. Junior numbers are very strong.
 - b. There was a \$49,525 drop in revenue last month compared to June 2021. Golf is down roughly 11,000 rounds and \$117,000, which is about \$10.63 per round. This indicates that the increase in greens fees is doing its job, and the no-show feature is also working as more people are on the greens.

- c. Salaries and expenditures will continue to rise. Services and charges have decreased from last year. This is due in part to cooler temperatures and rainfall this year compared to the high temperatures and draught last year as well as more efficient irrigation.
- d. Overall, revenue less expenditures is down \$160,874 from 2021. The year-to-date cash balance is \$852,140. In 2021, there was \$610,000 available cash and \$184,000 in 2020.
- e. Facility Improvement Fee revenue is down \$21,496 for June and \$64,644 year-to-date compared to 2021. Now that all the improvements have been made, the Debt Service Payments are going to increase. The first payment was made in June bringing a monthly and year-to-date difference of \$-226,941. The final installment should be in 2037.
- 2. Superintendents' reports What's Happening at the Courses Mark Poirier
 - a. Mike Vandervert with Esmeralda states the heat is coming on. Steve Nittolo has been pruning the course. Steve is receiving 20% of his Urban Forestry salary from Golf and he has been doing a great job. Lot of limb chipping going on. Urban Forestry will be bringing in a bucket truck to prune back trees. They are top dressing and getting prepared for August Pro Am and City Championship tournaments. It's been difficult to find and keep temp-seasonals but they are finally fully staffed.
 - b. Steve Conner reports 320, 321, 307, 353, the numbers from Wednesday Sunday at Downriver. Golf course is in fantastic shape. They had a busy June and promising July.
 - c. Rob Decker states Qualchan just hosted the Drive, Chip & Putt contest with 124 kids participating. This is a regional event which would eventually go to the Augusta National Championship. Junior rounds are down 120 from last year, which is good considering the wet spring. He states the course is in great shape and is diligently putting in repurposed irrigation heads from Downriver.
 - d. Doug Phares has been preparing for the Rosauers Open, which kicks off Wednesday at Indian Canyon with 72 teams of 5 in the Pro Am, and 140 teams in the proper, one of the largest PGA sectional events in the country.

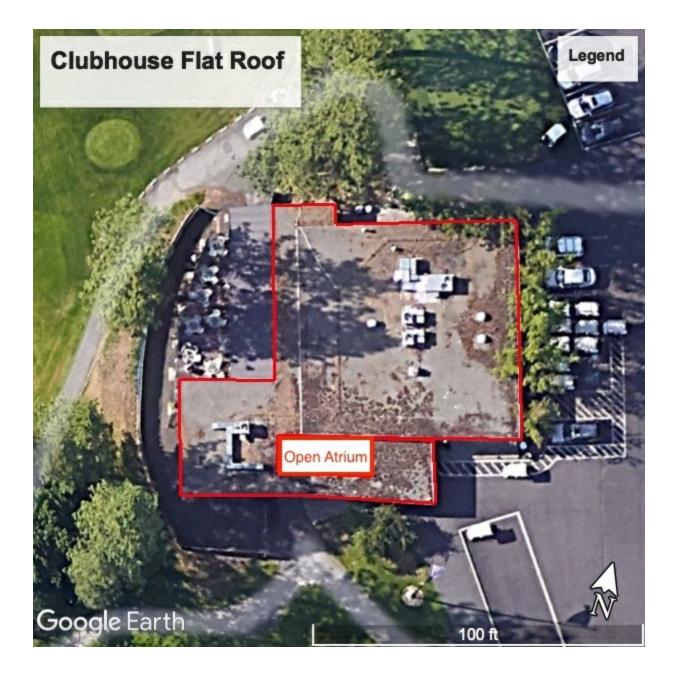

- Removal and disposal of the existing roof system, replacement of dry rot wood materials, raising of all curbing, installation of a tapered insulation package, installation of new clad medal edge, installation of 60 mil KEE membrane, proper flashing of all penetrations, pipes curbs, etc., manufacturer's rep job site inspections, permits, and work coordination with City.
- Include replacement of 15% of sheeting in base bid pricing.
- Include hazardous materials survey (asbestos survey) prior to commencement of work.
