SUMMARY

- The committee passed the following action items which will be presented to the Park Board for consideration and approval:
 - Approval of the Green Area Maintenance Pilot Project Agreement with the City of Spokane Public Works subject to modifications discussed in the meeting be incorporated into the final agreement – consent agenda item
 - Corbin Park Sport Court Renovation/Ditches Unlimited Change Order 1 (\$22,004.38 plus tax) – consent agenda item
 - Washington State Grant Applications/several projects (no cost) – consent agenda item
- Bob Scarfo provided an update of the progress on the proposed Memory Garden.

The next regularly scheduled Land Committee meeting is set for 3:30 p.m. Wed. May 01, 2024.

MINUTES

The meeting was called to order at 3:31 p.m. by committee chair Greta Gilman.

Public Comments:

1. Jeff Lambert, Friends of the Bluff, spoke in favor of the [Thorpe Rd. trust land transfer](#). He stated there are 35 applications from various agencies for the Dept. of Natural Resources (DNR). The properties would have to be bought out by the State of WA and transferred to the various agencies. The Thorpe Rd. property has been public since the Washington Territory became a state. The DNR has considered selling this parcel to a private developer to build 800 homes. There are 4 selection criteria: ecological factor (which Jeff said needed to be polished up before the July advisory committee presentation), community support (which Jeff is working on), community benefit (which is the letter Parks is preparing), and economic benefits to the community (which is more difficult and needs to be polished). In addition, [Karen Mobley](#), community volunteer for Spokane Urban Nature, emailed her support, citing the high priority in the master plan for the preservation of natural habitats for many unique wildlife and vegetation. [Carol Landa-McVicker](#) also emailed her support and would like to keep the open spaces as the area grows in population.
2. Cynthia Parker commented on the purpose and necessity of a [memory garden](#) in Spokane. It should offer peace, beauty and quiet where they are safe, is easy walkable, fenced and gated. She spoke of how her loved ones with dementia enjoyed the ability to work in garden and it was the highlight of their day. Jean Kinden works with aging and long-term care individuals who have needs which have not been addressed. She feels it should be in a neighborhood where both north and south area residents can easily access. Bill Heaton is chairman of the Land Use committee. He emphasized the people benefitting from a memory garden are people (taxpayers) who have spent their lives contributing to the neighborhood and because of declining mental health are now begin shut out or walled off from the community for no fault of their own. Mr. Scarfo's memory garden tears down those walls, allowing the aging population to again enjoy the outdoors without fear. Rhonda Spangler, a geriatric care provider, sees loved ones struggle to find activities in the area for people who have difficulty understanding the environment, irritability, and anxiety. A memory garden is also a unique environment for caregivers to connect. The garden also elicits responses from non-verbal individuals, sparking long-term, joyful memories. The memory garden is also an ideal haven for individuals with autism and traumatic brain injury.

Action items:

1. [Approval of the Green Area Maintenance Pilot Project Agreement with the City of Spokane Public Works](#) – Al Vorderbrueggen/Carl Strong

Greta expressed concern that the agreement is too broad. Al reminded the committee that as a pilot program, this will most likely be changed again in 18 months. He stated that Parks can only provide the level of service and maintenance to which they receive funds. This project cannot and will not affect the Park fund. After speaking with several department heads, the Park Operations is best suited to handle this project. Carl pointed out that Operations would manage the Green Area Maintenance no differently than they handle the parks when it comes to illegal dumping and encampments, where the Homeless Outreach Team/Code Enforcement are brought in. Greta indicated she would like to have more clarification in the fourth paragraph as to which properties are included. Carl Strong stated the "green spaces" are listed in Exhibit A. Greta suggested changing "green spaces" to "green areas pursuant to Exhibit A". Kevin suggested further simplifying to read "WHEREAS, Public Works has traditionally maintained the properties in Exhibit A". The committee agreed to rewrite section 2.2. The agreement will be passed around this week for revision and the motion will be changed to accommodate these revisions.

Motion #1 – Greta Gilman moved to recommend the Green Area Maintenance Pilot Project Agreement with the City of Spokane Public Works subject to modifications discussed in the meeting be incorporated into the final agreement (modifications have to do with the wording of the agreement, not with the intent of the agreement).

Sally Lodato seconded. The motion passed unanimously (4-0 vote – Doug Kelley was unavailable for the vote).

The committee agreed to present this recommendation as a consent agenda item on the April 11 Park Board meeting agenda.

2. [Corbin Park Sport Court Renovation/Ditches Unlimited Change Order 1 \(\\$22,004.38 plus tax\)](#) – Berry Ellison

Berry showed the progress so far, which included a short reinforced concrete wall along the south and north side perimeter wall to hold up the fence. After inspection he realized the sidewalls are deteriorating. Although the scope of work does not include the side walls, he worked with the contractor on a plan to build up the curbs along the south side, which was within the 10% cost adjustment already agreed upon. During the negotiation, they agreed upon site protection since work was interrupted over winter. They agreed to pay for one of the three months of site protection mats (50 mats @ \$3,750/mo). Also due to the additional work, Berry would like to request a no-cost extension through June 31, although they are hoping to have a July 4th opening.

Motion #2 – Greta Gilman moved to recommend Corbin Park Sport Court Renovation/Ditches Unlimited Change Order 1 (\$22,004.38 plus tax)

Kevin Brownlee seconded. The motion passed unanimously (5-0 vote).

The committee agreed to present this recommendation as a consent agenda item on the April 11 Park Board meeting agenda.

3. [Washington State Grant Applications/several projects \(no cost\)](#) – Nick Hamad

- a. There are three projects: Meadowglen Park development (acquired in 1985), Coeur d'Alene (CdA) Park playground, and the trust land transfer for the Thorpe Rd. property.
- b. Meadowglen, 14 acres of undeveloped property at the north end of the City limits near Indian Trail identified as a first-tier project in the master plan. Provided the levy passes, the \$7-8M development funding has been allocated. There is a desire to augment \$1-1.5M through a WA State Recreation and Conservation Office (RCO) grant. This development would benefit the 650 +/- residences without easy access to a park.
- c. CdA Park in Brown's Addition was recently denied a request for state funding. The playground has been identified as the third adverse in the park system. Parks would like to propose an RCO grant for renovations for this facility as well, which would include the playground, restrooms, and handicap accessibility. The funding for this project has also been allocated provided the levy passes.
- d. The 192-acre DNR owned Thorpe Rd. property is located near the southwest corner of the City limits. Although this has been defined as a third-tier project, however the state legislature would fund this transfer at no cost to Parks. There is heavy residential building in this area and Parks would prefer to secure this land now. The application was submitted in the fall however, Parks would like to follow up with a Letter of Resolution from the Director of Spokane Parks and Recreation indicating the need for natural land and recreation in that location, rather than being absorbed with residential properties.

- e. Greta clarified that by approving this action item, the committee is approving staff putting in efforts to write the grant applications on the first two items and providing a Letter of Resolution from the Director in for the trust land transfer. Nick reminded the committee that if these applications are approved, Park Board would then need to take more action to then develop and/or renovate these properties. He also stated that if the levy does not pass, the two existing park projects could be done in phases, which is how the grant applications will be written.

Motion #3 – Greta Gilman moved to recommend Washington State Grant Applications/several projects (no cost)

Kevin Brownlee seconded. The motion passed unanimously (5-0 vote).

The committee agreed to present this recommendation as a consent agenda item on the April 11 Park Board meeting agenda.

Discussion Items:

1. **Memory Garden Pilot Project Progress Update / Manito Park (no cost)** – Nick Hamad
 - a. Many people came to the meeting in support of the memory garden. Kevin Brownlee emphasized this was only a discussion item and no action would be taken at this meeting. To recap, Bob Scarfo last visited the Land Committee in October of 2023 with a recommendation to place a memory garden in Manito Park. The committee is in support of a memory garden in Spokane, however, he was given a number of things to retool and revisit. Today he is bringing an update.
 - b. Bob reintroduced himself, a registered landscape architect, Debby Dodds, a dementia focused gerontologist, and Adriano Eva, Wellness & Life Enrichment Program Supervisor with Spokane Park as the team steering this project. The first of only eight public memory gardens in the country is in Portland, OR. He would like to see this as a pilot project, with the anticipation of more in the future. An estimation based on State and national statistics, the potential target population is 37,150, which includes caregivers. There is value in a memory garden for the caregivers as a respite from the 25-hour day. It reduces a person's isolation, providing opportunities for socialization, as well as numerous physical and mental health benefits. Bob provided examples of ornamental fencing which would provide a safe enclosure, blending into nature, which could reduce the patient's fear. He emphasized the wide range of design possibilities, both natural and architectural. He mentioned that although water features may provide stunning winter memories, they may prove to be troublesome.
 - c. There were eight possible prime locations based on several favors which were further assessed and ranked with Manito and Comstock being number 1 & 2. After walking the site at Manito, four sites were assessed: west of the Helen Keller Memorial, which had parking limitations; 17th, which would require too much grading and tree removal; Tekoa near the playground, which would be too noisy; and the old zoo site on Loop Dr., potentially the best location. Nick pointed out that the upper Loop Dr. was an area used as a dumping ground for pond muck and would be a good opportunity to restore this site. There would be a good location just east of the proposed garden site for parking with enough room for 5-6 cars and a large van.
 - d. The next phases are to continue meeting with area senior centers, involving them in the process. He will be looking back at funding sources and identifying deadlines. He indicated he and Debbie would fund the design process then hand the project off to the City. Something that would be very beneficial is focus groups with both caregivers and those with dementia. Nick stated that the Friends of Manito are aware and are supportive of the project, however, have not written an official letter of support. However, they were concerned with too much

competition with their fundraising project for the pollinator garden so timing would need to be considered. Kevin reminded the group rather than focusing on the unknown, to focus on what was solved, which was the issue of access and parking.

The Spokane Sustainability Action Plan places emphasis on the access to natural lands. Our community is excited about protecting open space. We have strong volunteer support for this kind of place.

I know that there are many community organizations weighing in on the support of this transfer and I add my voice to this effort.

INTERDEPARTMENTAL AGREEMENT BETWEEN PUBLIC WORKS AND
PARKS & RECREATION DEPARTMENT REGARDING GREEN AREA
MAINTENANCE PILOT PROGRAM

THIS AGREEMENT is between the City of Spokane, Public Works Division, on behalf of the Water, Wastewater Management and Streets departments, located at Second Floor City Hall, 808 W. Spokane Falls Blvd, Spokane, Washington 99201, hereafter referred to as "Public Works" and the City of Spokane, Parks and Recreation Department, whose address is Fifth Floor City Hall, 808 W. Spokane Falls Boulevard, Spokane, Washington 99201, herein after referred to as "Parks".

WHEREAS, the City of Spokane ("City") owns and operates a Water-Wastewater Utility pursuant to chapter 35.67 RCW and other applicable laws. Public Works operates the Water-Wastewater Utility as a separate system and enterprise; and

WHEREAS, Public Works also manages the Street Department, which generally is responsible for managing the City's street system, which encompasses much of the public right of way; and

WHEREAS, Public Works has traditionally maintained open, non-developed, green areas located within the public right of way, including traffic medians, stormwater management facilities, and related facilities ("Green Areas"); and

WHEREAS, the City, through its Park Board, operates a Park and Recreation Department ("Parks") pursuant to the Spokane City Charter and manages thousands of acres of open/green space; and

WHEREAS, the Parks Department has expertise in managing and maintaining Green Areas and is well-suited to take on responsibilities for maintenance of Green Areas located within the right of way, gaining efficiencies of scale by consolidating this work with its regular park operations and maintenance activities; and

WHEREAS, currently there are hundreds of locations city wide that are designated Green Areas and are being maintained by various Public Works departments; and

WHEREAS, the City is committed to maintaining these spaces for the benefit of the citizens in the most cost-effective and efficient manner possible; and

WHEREAS, Public Works spends an inordinate amount of time to manage and maintain these Green Areas and its resources are better spent elsewhere; and

WHEREAS, coordination and consolidation of the individual Green Areas provides for efficiencies of scale and greatly benefits all Public Works Departments, to include Water, Wastewater, Streets and Parks Departments, along with the citizens of the City of Spokane; and

WHEREAS, the Parties have negotiated terms and conditions to transfer the responsibility for caring for these facilities to Parks, outlined herein:

NOW THEREFORE, the Parties mutually agree as follows:

1. PARTIES: The Parties understand they are all part of the same municipal corporation, and, though they operate as independent departments and divisions of the City and are subject to separate budgetary and legal requirements and procedures, they desire to reflect their relationship most efficiently through this Interdepartmental Agreement. The Public Works on behalf of Water, Wastewater and Streets is represented by the Director of Public Works. Parks is represented by the Park Board acting through the Parks Director.
2. PURPOSE: The purpose of this MOU is to establish the terms and conditions for:
 - 2.1 Establishing a maintenance program to maintain the Green Areas which are generally located within the public right of way to include without limitation program plan development, project management, mowing, clean up, weed control, tree care, edging maintenance, irrigation, etc.
 - 2.2 Green Areas are defined to include without limitation those areas which are generally open, non-developed, and green areas located within the public right of way, or contemporaneous to public right of way, including traffic medians, stormwater management facilities, and other such related facilities.
3. DURATION: This Interdepartmental Agreement shall be effective upon final signature and shall remain in effect through December 31, 2025. This period is considered a pilot period. Within six (6) months prior to expiration of the pilot period, the Parties agree to review the effectiveness of this Agreement and determine if a permanent agreement should be developed.
4. TERMS:

- 4.1 Parks will be responsible for maintenance of Green Areas pursuant to Attachment “A”, to the extent the payment and resources provided by Public Works allows for the duration of this Agreement. In the event there are insufficient resources to cover the maintenance of the items in Attachment “A”, the Parties will mutually agree in writing to the maintenance prioritization of the identified spaces.
- 4.2 Maintenance of Green Areas pursuant to Attachment “A” shall include without limitation the following: program plan development; project management, mowing, clean up, weed control, tree care, edging maintenance, fertilizing, landscaping, irrigation system maintenance, etc.
- 4.3 Public Works also agrees to pay for water used at Green Areas pursuant to Attachment “A”.
- 4.4 New Green Areas which are constructed and intended to be maintained pursuant to this Agreement will be agreed to by both Parties, at which time, the Parties will determine whether there are any additional costs for maintenance. The list of locations contained in Attachment “A” shall be updated on at least an annual basis. Public Works will identify those locations at the project conception and upon completion provide Parks with written information.
- 4.5 Parks with the park planning department, will establish uniform standards for landscape commensurate with the area’s intended use. Parks will work with Public Works to ensure that ongoing maintenance and operations are considered prior to project start of any new Green Areas that are intended to be added to Parks responsibility under this Agreement.
5. PAYMENT: As consideration for the terms outlined herein, the Parties agree that Public Works shall fund annually the sum not to exceed ONE MILLION ONE HUNDRED THOUSAND Dollars (\$1,100,000) for Parks to maintain the Green Areas listed in Exhibit “A”. Any modification of this amount shall be in writing, signed by both Parties.
- Parks will provide invoices to Public Works on a monthly basis to support this payment. On an annual basis, the Parties shall review, evaluate and adjust as necessary.
6. INDEMNIFICATION:
- 6.1 Public Works shall indemnify and hold harmless Parks, its employees and agents for any loss, claim or action to which they may be put by reason of this Agreement, except to the extent Parks, its employees and agents are determined to have acted negligently.

6.2 Parks shall indemnify and hold harmless Public Works, its employees and agents for any loss, claim or action to which they may be put by reason of this Agreement except to the extent Public Works, its employees and agents are determined to have acted negligently.

7. ENTIRE MOU: This MOU contains the entire understanding of the Parties, and there are no other promises or conditions in any other Agreement whether oral or written concerning the subject matter of this MOU. This MOU supersedes any prior written or oral MOU or arrangement between the Parties.
8. AMENDMENT: This MOU may only be modified or amended in writing, if the writing is signed by all Parties.
9. SEVERABILITY: If any portions of this MOU will be held to be invalid or unenforceable for any reason, the remaining provisions will continue to be valid and enforceable. If a court finds that any provision of this MOU is invalid or unenforceable but that by limiting such provision it would become valid and enforceable, then such provision will be deemed to be written, construed, and enforced as so limited.

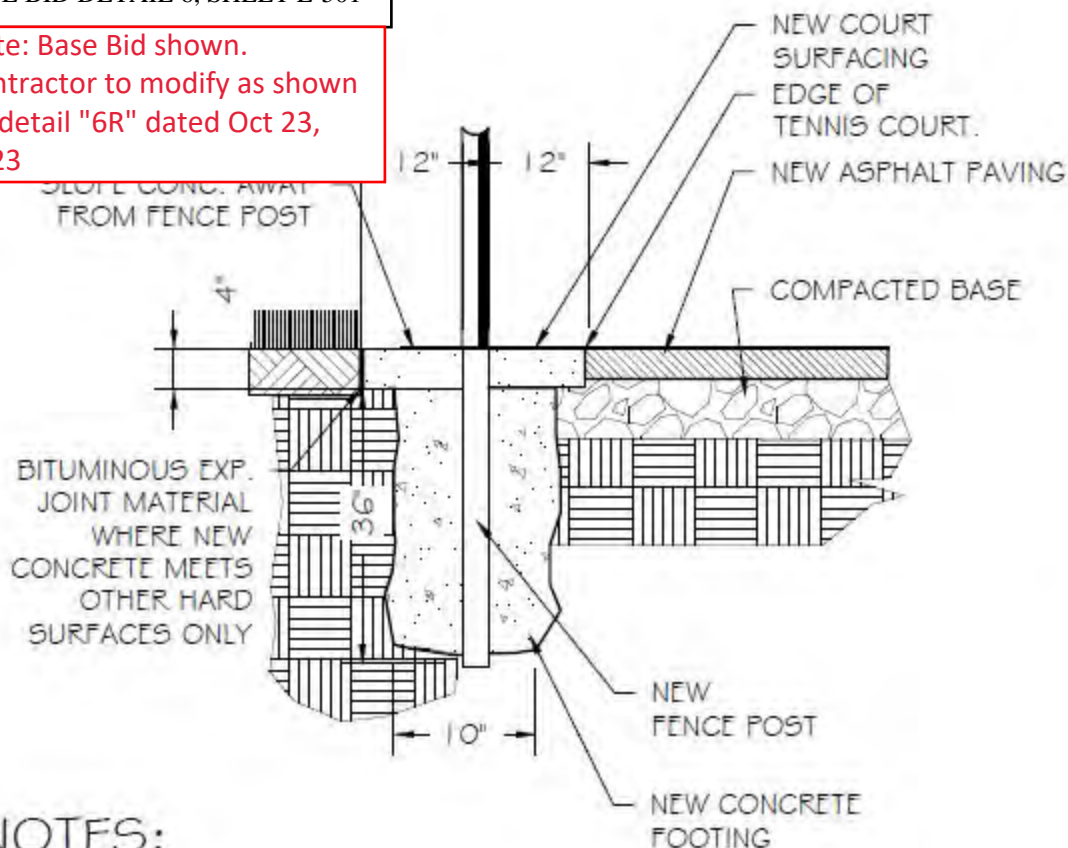

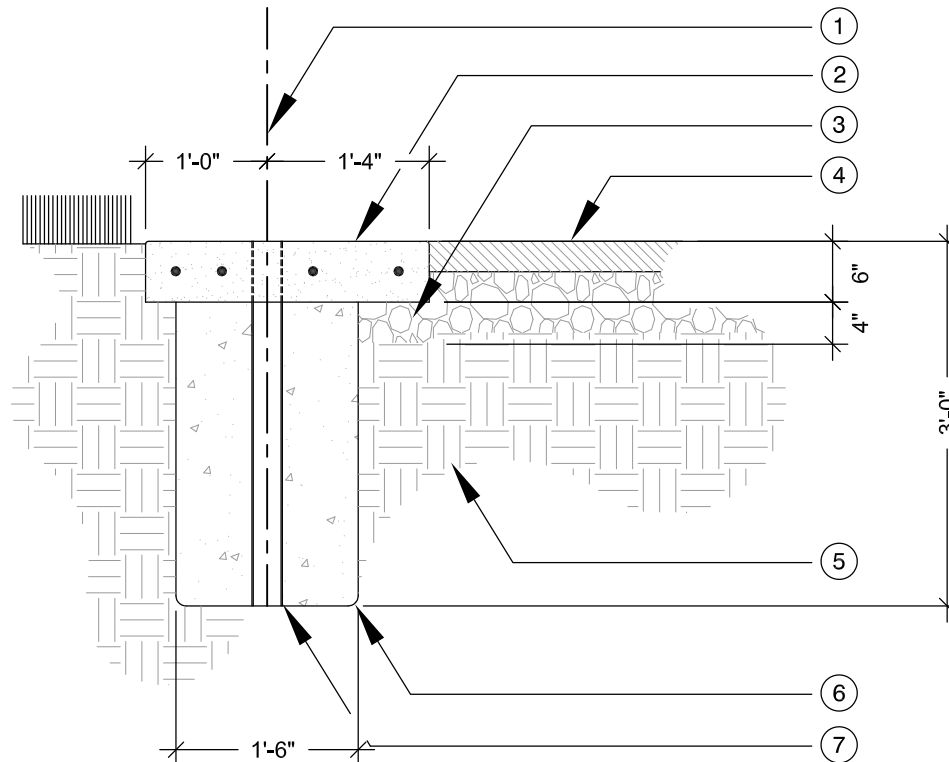

WHEREAS, the Washington State Department of Natural Resources (DNR) owns approximately 192 acres of natural land (Thorpe Property) within the Grandview/Thorpe neighborhood which it intends to surplus; and

WHEREAS, the Thorpe Property is identified as 'potential open space' in the City of Spokane Land Use Plan; and

WHEREAS, DNR manages a special program, titled the Trust Land Transfer (TLT) program, intended to 'keep special places in public ownership' using funding appropriated by the Washington State Legislature, which may enable the DNR property to be maintained as public open space at no up-front cost to Parks; and

WHEREAS, Parks received support letters from several non-profit and neighborhood groups interested in Parks acquiring the Thorpe Property through the TLT program; and

Greetings,

We are writing in support of the memory garden pilot project in Manito Park championed by Bob Scarfo, Debby Dodds, and Adriano Eva. This kind of space is needed in Spokane because it will give care partners space to relax while ensuring their loved ones' safety, provide a safe space for people living with dementia to interact with nature in public, and contribute to Spokane as a dementia-friendly community.

Spokane has an urgent, growing need for respite for care partners. In our daily support work and as members of the Spokane Regional Dementia Friendly Community, we regularly interact with people who are living with dementia, caring for someone living with dementia, or working with people living with dementia. One of the running themes that we hear over and over again is that there is not enough respite care in Spokane. Caring for someone living with dementia is more than a full-time job, especially in the later stages when people living with dementia often need continuous care to ensure their safety. With the current workforce shortage, especially in the healthcare sector, many care partners find it difficult to fulfill even basic needs like grocery shopping, getting a haircut or going to their own healthcare appointments.

A public memory garden would give care partners space to both enjoy nature and relax with the peace of mind that their loved one is safe. They could meet with friends or other care partners in this garden, allowing the person with dementia to wander without worrying that they might get lost. It's hard to overstate how comforting such a space could be for an exhausted care partner.

When someone starts to experience dementia symptoms like memory loss, personality changes or difficulty with problem-solving, one common reaction is to isolate so that no one sees these symptoms. People living with dementia frequently stay away from social gatherings, church, work, and other social interactions so that they can keep their diagnosis or symptoms hidden. Likewise, care partners often encourage their loved ones to stay home so that they won't "cause a scene" or be hurt by others' reactions.

With the rising number of people living with dementia in Spokane, creating and maintaining inclusive, safe spaces for people living with dementia and their care partners is critical to reduce

isolation and support care partners. Many factors go into making a space safe for people living with dementia. While criteria for a safe space can vary from person to person and even moment to moment, there are a few common trends. For example, people living with dementia often feel more comfortable with fewer distractions like loud noises, crowds of people and intersecting sounds.

Establishing a Memory Garden that anyone can use would be a significant step toward making Spokane feel safe and welcoming for people living with dementia in Spokane. We would eventually love to see memory gardens in many public parks across Spokane, especially in underserved communities. However, we think that Manito Park is the best place to start this pilot project because it has spacious areas that are away from distractions like playgrounds and traffic, public restrooms that could be close to the memory garden, and several parking areas.

We hope that you consider this as the beginning, not the end, of a much-needed shift to make Spokane a more inclusive and inviting place for people living with dementia and their care partners.

I am writing in support of a publicly accessible Memory Garden in Spokane for those living with a host of different memory loss issues, as well as their caregivers. During my work with the library's Memory Café (a weekly meeting for those with dementia and their caregivers to socialize) we frequently hear from participants that they would like to spend more time outside and surrounded by nature.


When a friend or partner with dementia begins their decline, it can be overwhelming for a caregiver to commit to a simple hiking trail or picnic in the woods. Sometimes this is due to the misconception that the disease means you can no longer enjoy the activities you used to in a public space, or the fear that your partner may become moody or uncooperative in an isolated area, or the time it takes to reach a natural area that is likely on the outskirts of town or overly crowded. During one Memory Café, couples even requested a virtual tour through state parks on our TV screens because they could pretend to be surrounded by nature as we did a gardening related indoor activity, but it's not the same. Memory Café's first group field trip was to a tour of a fish hatchery, and they were thrilled to be out in the sunshine together enjoying a walkable area where they could interact with streams and fish and enjoy a light breeze. The Spokane community desperately needs publicly accessible, peaceful outdoor community spaces, and does not yet have one that welcomes those with dementia directly. A garden would be easily accessible and recognizable as a gathering space for those who have not yet found a dementia community.

There were 300,000 unpaid dementia caregivers in Washington state last year (2022), and the number of people developing dementia continues to increase as a large generation ages and the diseases' cure remains unknown. The waiting list to be officially diagnosed with dementia in Spokane is typically over six months long because specialists cannot keep pace with demand. The number of people over 65 with Alzheimer's alone, not counting the other 70+ forms of dementia, is projected to be 140,000 in Washington state by 2025. 75% of people with dementia live at home, and their caregivers desperately need a break. I believe an opportunity to be outdoors in a dedicated quiet space would help the wellbeing of both caregivers and those with dementia immensely. A Memory Garden would send a clear message that those with dementia belong out in our community appreciating flowers, seeing friends, and enjoying the last years of their lives, not locked away to decline. Best of all, it could be utilized by other members of the public, such as veterans or those struggling with depression, who might benefit from a place of solitude and beauty.

I believe you're uniquely suited to make this happen as a licensed landscape architect who has connections in the dementia community. The Friends of Manito are well known for their ability to keep gardens beautiful, and with their support, I'm confident a garden in the Manito area would be a success as well as a resource for dementia groups located on the South Hill. I would like to see additional Memory Gardens implemented across the area, notably in Spokane Valley and the West Plains. Please let me know if there is anything the library can do to support your endeavors.

I wholeheartedly support your efforts to introduce a Memory Garden to the City of Spokane. I think it's important to communicate with the Park Board about the opportunity to get aboard a growing movement that the WA State legislature embraces.

I coordinate and manage activities set in Seattle's Memory Garden, known as Maude's Garden at the Memory Hub, led by the University of Washington's Memory and Brain Wellness Center. Instead of speaking to the need for more memory gardens across the state, I thought I would share testimonials from people who have experienced our memory garden and let them speak to the value of what you are striving to accomplish in Spokane.

Below are insights and quotes from people and my own observations. As a caveat, I'll say that the value of Maude's Garden is very attached to the Memory Hub, a dementia-friendly community center, as people who participate in Memory Hub programs and events held in the garden are the ones who give quotes that I record. These thoughts bring up a big point. While a Memory Garden can bring the benefits of socialization, sensory/emotional stimulation, and physical activity; or a place to cope and manage one’s grief—I understand that is likely not enough to uniquely justify a memory garden for a city. Because what makes

a garden therapeutic specifically for dementia, rather than some other population? The answer is that a memory provides opportunities and activities that suit the needs of people living with memory loss and help them to interact and be involved with the garden. If at all possible, when your memory garden becomes a reality, do consider including Spokane's horticultural therapist in the development of **activities and therapeutic opportunities.**

I would also recommend supervising a volunteer living with early memory loss in the maintenance of the garden. Side note, I have more people (not patients, but people with love of gardening) than I can handle contacting me and asking if they can volunteer in Maude's Garden, so you could frame it as a community engagement project.

For us at the Memory Hub, we have always known that the most important part of a memory garden is how it provides **activities and therapeutic opportunities** for our population (that's in the formal definition of a therapeutic memory garden from AHA), so it is ideal if your garden leadership team can ensure that there is a mechanism to hire or offer volunteer opportunities for interested people to run art programs, support groups, horticultural therapy programs, or maybe nature/herb classes(?) specifically tailored for people living with dementia/and/or care partners.
 - I would also recommend supervising a volunteer living with early memory loss in the maintenance of the garden. The site is located away from traffic which will make it appropriate for this endeavor. Persons with dementia or cognitive impairments need a quiet environment in order to maintain their function.

Furthermore, we as a community will benefit by having a place where we can take our loved ones. I speak from experience; my mother had dementia. One of my last memories of time spent with her was when I wheeled her into our garden, and I picked a flower for her. She smelled it and for a moment her smile returned. Then she leaned over and pulled a flower, smelled it and gave it to me, a daughter whose name she could no longer recall. At that point I knew that a mother's love was still there.

From a professional standpoint, I have been involved with the environmental and care planning for persons with memory loss. The organizations I worked with when planning a housing environment for Alzheimer's patients always included a garden with colorful plants, trees, benches, and a walking path. Both our residents and families enjoyed time together there.

We are fortunate to have the expertise of Bob Scarfo, PhD, to plan and execute this garden. He has been a professor of landscape architecture at Washington State University. He has studied how persons with Alzheimer's disease and other cognitive impairment respond in a memory garden.


Finally, a memory garden will provide a public relations opportunity for Manito Park, the Parks and Recs. Department, and Spokane.

Hello,

I am writing to put my unreserved support behind the memory garden pilot project in Manito Park championed by Bob Scarfo, Debby Dodds and Adriano Eva. This is desperately needed in Spokane because it will give care partners space to relax while ensuring their loved one's safety, provide a safe space for people living with dementia to interact with nature in public, and contribute to Spokane as a dementia-friendly community.

Spokane has a growing, urgent need for respite for care partners. As the Dementia Resource Catalyst at Aging & Long Term Care of Eastern Washington (ALTCEW) and a member of the Spokane Regional Dementia Friendly Community, I regularly interact with people who are living with dementia, caring for someone living with dementia, or working with people living with dementia (PLWD). One of the running themes that I hear over and over again is that there is not enough respite care in Spokane. Caring for someone living with dementia is more than a full-time job, especially in the later stages when PLWD often need 24-hour care to ensure their safety. With the current workforce shortage, especially in the healthcare sector, many care partners find it difficult to fulfill even basic needs like grocery shopping, getting a haircut or going to their own healthcare appointments.

A public memory garden would give care partners space to both enjoy nature and relax with the peace of mind that their loved one is safe. They could meet with friends or other care partners in this garden, allowing the person with dementia to wander without worrying that they might get lost. It's hard to overstate how comforting such a space could be for an exhausted care partner.

When someone starts to experience dementia symptoms like memory loss, personality changes or difficulty with problem-solving, one common reaction is to isolate so that no one sees these symptoms. People living with dementia frequently stay away from social gatherings, church, work, etc. so that they can keep their diagnosis or symptoms hidden. Likewise, care partners often encourage their loved ones to stay home so that they won't "cause a scene" or be hurt by others' reactions.

It's our responsibility to create and maintain inclusive, safe spaces for PLWD and their care partners throughout Spokane to encourage people living with dementia to remain in our community. Many factors go into making a space safe for people living with dementia. While criteria for a safe space can vary from person to person and even moment to moment, there are a few common trends. For example, people living with dementia often feel more comfortable with fewer distractions like loud noises, crowds of people and intersecting sounds.

Establishing a Memory Garden that anyone can use would be a significant step to making Spokane feel safe and welcoming for people living with dementia in Spokane. I would eventually love to see memory

gardens in many public parks across Spokane, especially in underserved communities. However, I think that Manito Park is the best place to start this pilot project because it has significant space, more large areas that are away from distractions like playgrounds and traffic, public restrooms that could be close to the memory garden, and several parking areas.

I hope that you consider this as the beginning, not the end, of a much-needed shift to make Spokane a more inclusive and inviting place for people living with dementia and their care partners.
