MINUTES

- 2. **Motion No. 1:** Ken Van Voohris motioned to approve the October 8, 2015, Regular Park Board Meeting Minutes and Study Session Notes.

Preston Potratz seconded Motion carried unanimously

5. Special Guests:

A. SYSCA Update - *Jerry Unruh*, Hillyard Senior Center executive director, provided a presentation on the 2015 fall quarter noting there were more than 128,000 recreation participant hours in senior and youth programing for the last quarter. Another portion of the operations involved a variety of successful fundraisers.

B. Friends of Manito Park presentation – *Eberhard Schmidt*, Friends of Manito Park president, provided a presentation on The Friends of Manito activities, products, project, membership and communications during 2015. This year marks the 25th anniversary of the organization. Mr. Schmidt reported on a variety of projects, including Mirror Pond, Rose Hill

Gazebo, Iris Garden and Shade Garden. Mr. Schmidt also reported the group enjoyed a substantial increase in membership this year.

C. Friends of Indian Canyon – *Steve Prugh*, Friends of Indian Canyon board member, and *Eric Sawyer*, Spokane Sports Commission president/CEO, made a request of the Park Board on behalf of the FOIC. Mr. Prugh requested the Board commit to renovate Indian Canyon and establish a goal of attracting a national event, such as the Champion's Tour, LPGA Tour and Web.com Golf Tour, to the renovated venue. Mr. Prugh proposed the Park Board provide \$4 million targeted to infrastructure improvements at Indian Canyon. In turn, the FOIC would commit to raise \$2 million for the renovation project. He added this renovation should generate more than \$1.3 million in annual revenue at Indian Canyon alone. Mr. Sawyer elaborated explaining these improvements not only mean the potential of hosting national and international golf events, it brings the golf course back to the way it was, as a destination for tourists. Mr. Prugh explained the request is a barebones proposal. FOIC is looking for feedback from the City and FOIC determined the first step is to ask the Park Board for their support. Ken Van Voorhis and Preston Potratz commended FOIC for their vision and look forward to future discussions regarding the project.

6. **Motion No. 2:** Susan Traver motioned to approve claims for the month of October 2015 in the amount of \$1,898,750.24.

7. Financial Report & Budget Update: - Sari Luciano provided the October Financial Report & Budget Update. Parks and Recreation Fund revenue is tracking at 94% of the projected budget. Parks and Recreation expenditures are tracking at 94% of the projected budget. The Golf Fund revenue is tracking at 101% of the projected budget. The Golf Fund expenditures are tracking at 104% of the projected budget.

9. <u>Committee Reports – Action Items</u>:

Golf Committee: November 10, 2015, Preston Potratz

A. No action items

B. Mr. Potratz reported the Downriver #10 Tee project is well ahead of restoration expectations. He anticipates it will be ready for spring play. He also noted the Indian Canyon Golf Pro RFP is on the streets and candidates are currently touring the course. The RFP deadline is November 23.

Land Committee: November 4, 2015, Ken Van Voorhis

B. Mr. Van Voorhis reported the committee deferred action to the December meeting on the Heath Park Agreement with St. Aloysius. Mr. Van Voorhis also announced Manito Park and Manito Boulevard have been placed on the State Historic Register, and both will be nominated for placement on the National Register. The decision is expected soon.

Recreation Committee: Sam Selinger

Riverfront Park Committee: November 9, 2015, Susan Traver in Andy Dunau's absence

A. No action items

- B. Ms. Traver reported the committee approved the Stantec Contract which has been scaled down from the initial comprehensive scope. The approved contract is more of an initial consultant agreement. The contract involves design services for the Recreation Rink and SkyRide facility project.
- C. Ms. Traver announced the committee approved the Collins Group Contract be presented to the Finance Committee.
- D. An update was provided on the MOU with the Spokane Parks Foundation. The committee had a few questions and determined some minor changes were needed. The agreement has been pushed back to the Foundation who will have their legal review the MOU.
- E. A brief update was provided on the Park Redevelopment Project.
- F. Ms. Traver reported on Jeff Bailey and Sam Song's recent fact-finding trip to Canal Park ice rink in Washington, D.C. This ice ribbon design is similar to the one proposed at Riverfront Park.
- G. Chris Wright reported on a recent meeting with the Joint Arts Committee to discuss opportunities to incorporate art into the Riverfront Park Redevelopment Project.
- H. The next schedule meeting is December 7, 2015, at 8:05 a.m. in the City Council Briefing Center, Lower Level.

Finance Committee: November 10, 2015, Susan Traver

Action item: Collins Group Contract – Financing from the Parks Fund Balance not to exceed the amount of \$63,138

Ms. Traver introduced the Collins Group contract which was presented to the committee by Monique Cotton. The scope of work involves the Collins Group assisting Parks in managing and conducting a Capital Fund Drive Feasibility Study for the Riverfront Park Redevelopment Project. Key elements involve in-person meetings, a full written report and a debrief for the Park Board. The feasibility study is designed to understand timelines, develop budget goals and provide insight to creating a successful fund drive. She added the financing must come from the Parks Fund Balance as the Park Board is not allowed to take these funds out of the Park Bond. Leroy Eadie explained the funds would be coming from an excess fund balance which means Parks is in a good financial position to purchase this feasibility study. Ross Kelley explained the study results could be used in other areas by the Parks Department, such as other sponsorships, donations and fundraising activities.

Motion No. 3: Ms. Traver motioned to pass the Collins Group Contract financing from the Park Fund Balance not to exceed the amount of \$63,138.

Action item: EBO – 4640 Golf Debt Service Fund consolidation to 4600 (Golf Fund) as part of the 2005A LTGO Refinancing and Debt Restructure

Ms. Traver introduced the EBO to consolidate the Golf Debt Service Fund to the Golf Fund. Sari Luciano expounded on the EBO and explained with 2005A LTGO refinancing, the Debt Service Fund is no longer necessary. For this reason, the fund is being moved to the Golf Fund and the Debt Service Fund will be closed.

Motion No. 4: Ms. Traver motioned to approve the EBO 4640 Golf Debt Service Fund consolidation to 4600 (Golf Fund) as part of the 2005A LTGO Refinancing and Debt Restructure

Ken Van Voorhis seconded Motion passed unanimously

A. The October Financials were reviewed. Ms. Traver noted, while there are certain anomalies primarily due to utilities costs, there are good cost controls in place to level the financials.

B. A review of Jason Conley's report on information technology project plans was provided. Plans include new golf software, Capital Program Software and a replacement system for Class Software.

One item has to do with language in the Charter which restricts long-term leases in the park and the second involves a paragraph addressing alcohol in the park. Mr. Eadie also provided an overview of the American Society of Landscape Architects Conference which he attended last week in Chicago. In addition to the conference, Mr. Eadie had the opportunity to tour and meet with staff at Millennium, Grant and Maggie Daley parks. Mr. Eadie cited some examples of how Chicago utilizes their parks to revitalize neighborhoods.

COMMITMENT. The FOIC asks the Park Board to commit to renovating Indian Canyon with a goal to bring a professional golf tournament to the course by 2020. We ask that it provide \$4 million for infrastructure improvements at the course including a modern irrigation system. The FOIC commits to raise \$2 million targeted to improving Indian Canyon golf course to return it to its status as one of the premier golf experiences in the United States.





VISION: CHAMBERS BAY. "Several years back, Pierce County Executive John Ladenburg looked at an abandoned sand and gravel pit, and instead of a hole in the ground, he saw economic development via golf. He dreamed of the United States Open. Ladenburg managed to talk his dubious county commissioners into buying this hole in the ground, then approached the USGA, promising to do everything they wanted for a venue worthy of a U.S. Open. " - courtesy Bob Herold, The Inlander

The economic impact of this tournament on the Seattle/Tacoma was staggering. Estimated in excess of \$140 million with a \$1.1 million net profit to Pierce County, the tournament established Chambers Bay as an international destination resort. A LPGA, Champions, or web.com event would bring significant economic impact to the greater Spokane area, and provide week long national television/media exposure.

VISION AND COMMITMENT: EXPO '74/ARENA. In the midst of the Great Depression in 1930, the City of Spokane Park Board committed to building what 85 years later is the nationally recognized treasure that is Indian Canyon G.C. "The Canyon" has hosted P.G.A. tour events that drew golf icons like Ben Hogan, Sam Snead, and Byron Nelson to its grounds and Spokane. Three times the U.S.G.A. selected it to hold its national championships. Today, the course must be significantly renovated to bring it back to its original prestige. We ask the Park Board to recall the vision of its 1930 counterpart, the determination of this City 41 years ago in holding Expo '74, and the citizen efforts in 1995 to replace the "Boone Street Barn" with our nationally renown Veterans Memorial Arena. Each project created millions of dollars of positive economic impact to this area, and demonstrated the vision and commitment of this city to invest in its future by recalling in its past.
