Motion No. 1: Jennifer Ogden moved to approve consent agenda items #1 - #3, as presented.

Bob Anderson seconded.

Motion passed with unanimous consent (6-0 vote).

5. **Special Guests:**

6. **Financial report and budget update:** – *Mark Buening* provided the [June financial report and budget update](#). Mr. Buening pointed out revenues and expenditures are consistently below historic averages. The June operating expenditures for the Park Fund are about \$2.47 million less than the two-year historic budget average. Year-to-date revenues are exceeding the budget average about \$1.33 million. Revenues are exceeding expenditures approximately

\$1.86 million. The June operating expenditures for the Golf Fund is about \$245,000 less than the budget average. Year-to-date revenues are about \$86,000 less than the budget average. Revenues are exceeding expenditures almost \$698,000 year-to-date. A recap of the redevelopment bond fund reflected of the \$68.4 million total budget, there is about \$900,000 which has not been spent or encumbered.

7. **Special discussion/action items:**

A. [Garco Construction sponsorship and gift agreement/Pavilion Elevated Experience](#) – *Berry Ellison* presented an overview of a proposed sponsorship and gift agreement with Garco Construction for the Pavilion Elevated Experience. Staff has been strategizing methods to increase the Pavilion capacity from 3,900 to 5,100 people. This added capacity will allow for several operational and programming opportunities that will make the Pavilion more attractive to big name performers and sponsors. Mr. Ellison explained the return on investment is considered significant with long-term benefits. Garco has offered to complete the necessary improvements required to increase the capacity, at no cost, in return for recognition within the Pavilion Amphitheater, specifically the Elevated Experience. The work has an estimated value of \$130,000, which includes design, permitting, construction, contingency and tax. The change order would expand pedestrian egress at the Pavilion's amphitheater space resulting in increased capacity to 5,100 persons. The scope of in-kind work includes widening and adding egress paths, as well as adding a fire hose standpipe that will eliminate the need for a fire lane through the amphitheater. The proposed recognition scope, including signage and branding, will be negotiated and offered to the Park Board at a later date. *Garrett Jones* explained staff is requesting the board to authorize proceeding with the site improvements at the Pavilion with the condition that the sponsorship agreement recognition scope be approved by Park Board prior to installation. *Jennifer Ogden* stressed the importance that Garco absorb any unforeseen conditions and Parks will not receive any bills of any kind for this change order. Ms. Ogden added this will ensure Garco will receive their full in-kind value. *Nick Sumner* asked if the current restrooms could accommodate an increased capacity. Mr. Ellison explained staff is working with Planning and Development, and building officials on a strategy to potentially phase in restrooms for a certain amount of time, possibly a couple of years. This time will allow staff to see how the Pavilion performs and be able to better assess those needs. He said planning and building officials would like Parks to build additional restrooms rather soon, but budget constraints and operations point to a portable restroom solution for now. This would be the most feasible and cost effective way to handle the increased capacity short term.

Motion No. 2: Jennifer Ogden moved to authorize the Parks director to proceed with the site improvements at the Pavilion with Garco Construction's in-kind offering with the condition that the sponsorship agreement recognition scope with Garco be approved by Park Board prior to installation with in-kind value of \$130,000.

B. [Redevelopment update](#) – *Garrett Jones* presented the Riverfront Park redevelopment update. Highlights included: 1) North bank project – the M&O concrete slab is in place and the skate park base and walls are being formed; 2) Ice Age Floods playground on the north bank – the addition of the Roskelley Performance Climbing Boulder has been made possible courtesy of the Jess Roskelley Foundation; 3) West Havermale Island project – equipment is being installed at the playground and the shade structure is being installed; 4) Stepwell art piece – completion is scheduled for late fall or early spring; 5) second art piece – the Joint Arts Committee selected four final art designs and chose one piece to recommend to the Park Board, “Beaver” and staff is currently gathering additional public feedback on all four finalists’ designs.

Finance Committee: July 7, 2020, *Bob Anderson*

A. [Swire Coca-Cola beverage contract/Division-wide](#) – *Jason Conley, Jonathan Moog and Mark Poirier* presented an overview of the pouring rights and beverage contract selection process and recommendation. The current beverage contract with Pepsi expired in January. The master contract designates the selected vendor the exclusive beverage pouring rights at Riverfront Park, all city aquatic centers and golf courses, Dwight Merkel, Manito Park, and other mutually agreed upon Park properties. In exchange, Parks receives the following from the beverage provider: fixed-unit pricing, marketing and promotions funding, event support, beverage equipment, a fixed commission on vending machines sales, annual support product, and an estimated \$60,735 annually, based on historical average. Mr. Conley reviewed the process which lead to a staff recommendation to award Swire Coca-Cola, USA, the five-year agreement with an optional two-year renewal to begin July 10, 2020. This beverage agreement requires a competitive request for proposal (RFP) process administered by Purchasing Department. There were three vendors who responded to the RFP, including RC Cola, Swire Coca-Cola and PepsiCo. The evaluation committee, comprised of staff from Parks administration, Riverfront Park, Recreation, Golf and City Purchasing, determined Swire would be the best fit as a beverage partner. Some of the key elements Swire is agreeing to offer, as part of the proposed contract, includes: 1) 55% commission on vending machines; 2) \$20,000/year in annual support and sponsorship funds; 3) \$20,535+ annual rebate accrual; 4) \$7,500/year in major event sponsorship fees; 5) 400 cases of annual support product; 6) \$15,000 in ice-making equipment; 7) \$7,500 annual credit for Menu/Look of Success funds; 8) minimum of one Riverfront Park promotion per year; 9) special event staffing/equipment support for major events; and 10) marketing and promotional assistance. Mr. Moog explained he looks forward to this partnership with Swire.

Barb Richey arrived at the meeting at 4:15 p.m.

Mr. Poirier said this proposed agreement could be a great partnership which can help drive

rounds of golf at the city courses. If this agreement is approved by the Park Board, Swire could begin installation immediately with Golf being the first area converted to Coca-Cola. Riverfront Park Numerica SkyRide/Ribbon would be next followed by vending machine installations in other operational areas this summer.

Motion No. 3: Bob Anderson moved to approve a five-year contract with an optional two-year renewal with Swire Coca-Cola, as presented, for exclusive pouring rights for Spokane Parks and Recreation Division beverages sales.

Motion passed with unanimous consent (7-0 vote).

B. [LaRiviere change order #3/Riverfront Park north bank playground \(\\$134,200.47, tax inclusive\)](#) – *Berry Ellison* presented an overview of change order #3 with LaRiviere for work on the Riverfront Park north bank playground in the amount of \$134,200.47, tax inclusive. This change order includes value-added improvements and credits, including upgrades to the large shade structure roof, reduction in drainage materials and concrete curb, modifications to faux rock and railings, structural upgrades to the M&O facility, addition of a performance climbing boulder as part of a philanthropic gift to Parks, increase height of parking lot screen walls, and added fixtures for public restrooms. The climbing feature would be funded by \$48,000 donation from the Jess Roskelley Foundation in memory of Jess Roskelley, a world-renowned outdoorsman who grew up in Spokane. Roskelley passed away last year while on a climbing trip. Mr. Ellison explained the additional 50 days being requested is needed due to delays caused by Covid-19 and the added scope of work in this change order. If approved by the Park Board, substantial completion is scheduled for Jan. 5, 2021.

Motion No. 4: Bob Anderson moved to approve change order #3 with LaRiviere for work on the Riverfront Park north bank playground in the amount of \$134,200.47, tax inclusive, from Administrative Reserve, Roskelley Foundation and FFE budget, and to add 50 calendar days to the contract.

Sally Lodato seconded.

Motion passed with unanimous consent (7-0 vote).

A. **Park Board President:** *Jennifer Ogden* thanked the Roskelley Foundation for their vision and generosity for their donation of the climbing boulder at the north bank playground. She reminded the board to review all the public comments relating to the new artwork at Riverfront Park. The Park Board is expected to make a final decision on the art selection in the near future.

C. **Director:** *Garrett Jones* reported, in spite of the pandemic, Parks has been able to reach or surpass its projections for the past six months. This has been made possible through invaluable partnerships and support from the Park Board, City Council, Mayor's office, Parks Foundation, and all the other sponsors and partners from around the region. Mr. Jones commended staff for their tremendous dedication. He also thanked Spokane Indians Baseball Club, City of Spokane Parks & Recreation, Spokane County Parks, Recreation & Golf, and Spokane Public Schools for their partnership in organizing a truly successfully 4th of July firework show.

MINUTES

1. **Call to order:** *Jennifer Ogden* called the meeting to order at 3:30 p.m.

Motion No. 1: Jennifer Ogden moved to approve consent agenda items #1 - #5, as presented.

Rick Chase seconded.

Motion passed with unanimous consent (7-0 vote).

5. **Financial report and budget update:** – *Mark Buening* provided the May financial report and budget update. Mr. Buening explained the pandemic, shutdown of almost all revenue-generating activities and the hiring freeze have resulted in dramatic reductions in both revenues and expenditures. The May actual expenditures for the Park Fund are about \$1.5

million less than the two-year, historic budget average. Year-to-date revenues are about \$728,000 less than the budget average. Revenues are exceeding expenditures approximately \$1.8 million. May operating expenditures for the Golf Fund is about \$227,000 less than the historic budget average. Year-to-date revenues are less than the budget average by almost \$175,000. Revenues are exceeding expenditures almost \$387,000 year-to-date.

6. **Special discussion/action items:**

A. Clarification of Park Board Authority per the Spokane Municipal Code – *Councilmember Lori Kinnear* proposed a draft paper be crafted which clarifies the authority of the Park Board, Park's director and city administration per the Spokane Municipal Code (SMC). She pointed out there appears to be some ambiguity regarding certain responsibilities. One example included requests for Park facilities which currently goes through a process that ultimately is determined by the Mayor. She explained, according to the SMC, it should be the Park director's responsibility. She suggested there be clarification to avoid some of these "fuzzy" or gray areas. When referencing Article V of the City Charter and the SMC, *Jennifer Ogden* noted that the Park Board has the authority to care for, manage and control all grounds and facilities for park purposes, and to make rules and regulations covering the use of those facilities. Ms. Ogden welcomed this opportunity to have clarification and articulation.

B. Parks and Open Space Master Plan update – *Nick Hamad* presented an update on the Parks and Open Space Master Plan. This planning document is developed by Parks every six to 10 years, and serves as the division's strategic investment plan for its parks and open spaces. Public engagement is a key component in developing the plan. Due to the Covid-19 pandemic, there has been a delay in kicking off the public engagement step. Mr. Hamad outlined the input process which includes: 1) creation of a citizen advisory committee consisting of partner agencies and citizen organizations; 2) input from neighborhood councils, park users and the general public; 3) input from staff and the consultant; and 4) creation of a project advisory committee consisting of representatives from the Park Board, City Council and mayoral city staff. Mr. Hamad reviewed some of the timeframe adjustments which have been made due to the pandemic. He also shared some of the project branding, and the progress made on the project inventory and mapping.

C. Centennial Trail Summit Boulevard Gap project/Kyle Twohig – Director of Engineering Services *Kyle Twohig* presented an overview of a project to complete a missing section of the Centennial Trail, connecting the trail at Boone Avenue and Summit Boulevard to the trail at Pettet Drive and West Point Road. The project also involves replacing deteriorating sidewalks in the West Central Neighborhood. Mr. Twohig explained the project was delayed to allow for additional engagement and to incorporate feedback. A recent public survey received more than 2,300 responses and more than 550 responses from the West Central Neighborhood residents. Survey results included: 1) more than 20% of the respondents use this section of the trail for commuting; 2) 72.8% indicated they would use this section of the trail more as a shared use path; and 3) 83% of users of this segment do not feel the current section adequately meets users' needs for safety and accommodation. The Design Review Board (DRB) provided suggestions for better design elements to improve the project and address public concerns. Mr. Twohig shared the DRB recommendations with the Park Board. *Garrett Jones* thanked Mr. Twohig and his team for the collaboration and communication throughout this project.

Motion No. 2 – *Jennifer Ogden* moved to have staff draft a letter of support from the Park Board for this project.

7. **Committee reports:**

Finance Committee: June 9, 2020, *Bob Anderson*

A. Community basketball court murals donation – *Melissa Huggins*, Spokane Arts executive director, presented the background, selection process and proposed recommendation to accept a donation from Hooptown USA, made possible by a grant from MultiCare, of three basketball court murals at three Spokane neighborhood parks.

- a) Background – Hooptown USA received a grant from MultiCare to revitalize community basketball courts, and approached Spokane Arts with the idea of installing murals in Spokane. Prior to the art selection process, proposed sites were identified at three city park basketball courts located in neighborhoods designed to benefit as many citizens as possible. These selected neighborhoods include Peaceful Valley, Chief Garry and Lincoln Heights.
- b) Selection process – Spokane Arts hosted an open call for artists to submit qualifications and concept designs. A total of 38 artists submitted applications for the mural projects. A panel of representatives from Hooptown USA, Spokane Parks, MultiCare and Spokane Arts selected eight finalists. Those eight designs were shared in a community survey of the three neighborhoods' residents, as well as from people who use those parks but aren't residents of the neighborhoods. Representatives from each neighborhood were also invited to participate and vote in the jury selection process.
- c) Artists/location – Mural designs by artists Tiffany Patterson, Joshua Martel and Nick Goettling were selected from a field of 38 artists who responded to the call for artists administered by Spokane Arts. These murals will be installed at basketball courts in Peaceful Valley, Chief Garry Park and Thornton Murphy Park. The Chief Garry mural installation, designed by Mr. Martel, will include neighborhood participation.
- d) Installation/timing – The first installation at Peaceful Valley is scheduled to begin the end of June and expected to be completed in August. The second installation, at Chief Garry Park, is scheduled to begin mid-July. The mural at Thornton Murphy is set to be installed in 2021. The donation to Parks includes court resurfacing, line painting, artist selection, mural design and installation, project administration, and all costs reasonably associated with the installation of the murals.

Motion No. 3 – Bob Anderson moved to approve the community basketball court murals donation from Hooptown USA made possible by a grant from MultiCare, for mural designs by artists Tiffany Patterson, Joshua Martel and Nick Goettling at the three designated sites, including Peaceful Valley, Chief Garry Park and Thornton Murphy Park.

Barb Richey seconded.

Motion passed with unanimous consent (8-0 vote).

B. Selkirk Development reciprocal easement/Riverfront Park north bank – *Berry Ellison* presented an overview of the proposed reciprocal easement agreement with Selkirk Development. Mr. Ellison presented a site plan of the Riverfront Park north bank and adjacent

properties which include the SportsPlex site, Veterans Memorial Arena and Selkirk Development Papillion property. The park's north bank redevelopment project is currently under construction and includes a playground, skate park, maintenance building and signature basketball court. The Papillion project, located in the former Ram Brewery & Restaurant building, is a multi-use development which includes a tower for office, residential, hotel use and/or restaurant use, and a parking structure. The 15-foot, no-build easement is required for permits, planning and development coordination, and access. In exchange for allowing Selkirk the easement on Park property, the City will gain a public walkway and use of the restrooms in the Papillion tower during regular park hours. Mr. Ellison explained this development would anchor the north end of the park's promenade. As stated in the agreement, the developer will cover the cost of constructing and maintaining the walkway and landscaping. No money would be exchanged as part of this agreement. The agreement allows Selkirk five years to complete the project.

Riverfront Park Committee: June 8, 2020, *Nick Sumner*

A. Utilities/Parks interdepartmental agreement amendment/Riverfront Park parking lots (Revenue: \$96,865, no tax) – *Jonathan Moog* presented an overview of the amended interdepartmental agreement with city Utilities Division for use of the Riverfront Park parking lots, Bosch Lot (Lot #7) and parking lot #6. The original agreement, executed in 2016, provided Utilities access to construct the Combined Sewer Overflow (CSO) tank on the Bosch Lot site. Later the same site was used as a lay-down for construction supporting the construction of the CSO tank/plaza adjacent to the downtown library. The proposed amendment would allow Utilities continued use of Riverfront Park parking lots during construction of the Post Street Bridge replacement project. In return, Utilities will pay to Parks for the number of parking stalls used during the duration of each project. The expected number of stalls for the Bosch Lot is 42 charged at a rate of \$924 per stall annually and upper portion of Parking Lot #6 is 29 charged at a rate of \$2003 per stall annually. Total annual compensation is \$96,865. *Jennifer Ogden* explained it is important that some parking, at least six spots, available when the new all-

inclusive playground on West Havermale Island is completed. Parks plans to work with the contactor regarding parking options. All of Post Street will be closed, so Parks may need to look elsewhere for playground accessible parking.

Motion No. 5 – Nick Sumner moved to approve the interdepartmental agreement amendment, as presented, allowing Utilities use of Riverfront Park parking lots, Bosch Lot and lot #6. In exchange, Utilities will compensate Parks \$96,865 annually.

Bob Anderson seconded.

Motion passed with unanimous consent (8-0 vote).

B. The next scheduled meeting is 3 p.m. July 6, 2020.

8. **Reports:**

A. **Park Board President:** *Jennifer Ogden* deferred her report in the essence time allowing more time for public comment.

B. **Liaisons:**

1. **Conservation Futures** – *Greta Gilman* reported the county commissioners recently approved the purchase, through Conservation Futures, of two properties in the Beacon Hill area. The land acquisitions included the Collin and Paras properties. These property acquisitions allow the connection needed for non-motorized, public recreation in the Beacon Hill area. The area would continue to be maintained through the agreement with Evergreen East Mountain Bike Alliance.
2. **Parks Foundation** – *Gerry Sperling* reported highlights of the April 22 Parks Foundation meeting. The foundation has experienced a reduction in donation dollars due to Covid-19. The Kalispell Tribe has announced it will not be awarding any grants this year. The Parks Foundation is focusing on open spaces since these are the areas which are accessible to the public, at this time, due to the pandemic. The foundation was recently awarded a \$10,000 grant from Principal Financial. Foundation staff is looking into funding opportunities for a dog park within Riverfront Park.
3. **City Council** – *Lori Kinnear* reported a request for proposal went out a few days ago for the fuel mediation project which involves using goats on city property to reduce wildfire fuel. Council member Kinnear said once the state enters Phase 3, pools will be allowed to open with restrictions. She said council is working with Park staff in finding funding opportunities needed to open the city's aquatic centers.

C. **Director:** *Garrett Jones* reported Parks recently opened following to the public: playground structures, dog parks, Numerica SkyRide and field rentals for outdoor sports practices. Golf can now have non-household members ride a cart together. Temp/seasonal support is a primary focus area. Currently, Parks has about one-third of its normal work force for this time of year. Staff is monitoring revenue and looking at slowly ramping up temp/seasonal staff as Phase 3 unfolds. Staff has developed an operations plan, aligning with Phase 3 modifications required by the state Department of Health. The plan includes staffing, training, a reduced-capacity analysis, budget and timelines. He thanked staff, the Park Board and city administration for their hard work and support while working through the pandemic.

Thank you for your phone call this week and for your concern regarding the status of our consulting fees. BWA wants to ensure we can maintain quality service to the city throughout the construction administration phase of the project. As we discussed, we have experienced several out of scope changes during the design phase, as well as, during the construction administration phase of the project. Both of which have affected our consultant budget.

This amendment consideration is for the consultant agreement between the City of Spokane Parks and Recreation Department and Bernardo Wills Architects, P.C. Dated August 27, 2018. It is intended to provide reimbursement for out of scope services moving forward through the construction administration phase, to substantial completion.

The largest portion of out of scope work was incurred through the extension of the construction period and inclusion of additional construction coordination meetings. Multiple delays have postponed construction completion, originally planned for the fall of 2020, to the spring of 2021. The original construction administration scope included 12 bi-weekly construction coordination meetings. These meetings have become weekly due to the complexity of the site work. We have exceeded our 12 meeting allotment, with several months remaining until the completion of construction.

Additionally, during the construction administration phase, we have greatly exceeded the amount of time estimated to secure Building Department Permits and Health Department Permits for the splash pad that has been out of our control. The budget has absorbed additional coordination time for owner directed changes occurring after approvals. To provide the city with the best value moving forward we would like to transition to bi-weekly meetings as originally agreed to. Because most of the RFI's and Submittals are complete, we feel that doing so would not impact the level of responsiveness.

This amendment consideration is intended to be concise, but we can provide additional detailed information, with dates, hours and detailed description of changes as requested.

We respectfully request your consideration of additional services in the amount of \$20,000 for these out of scope items.

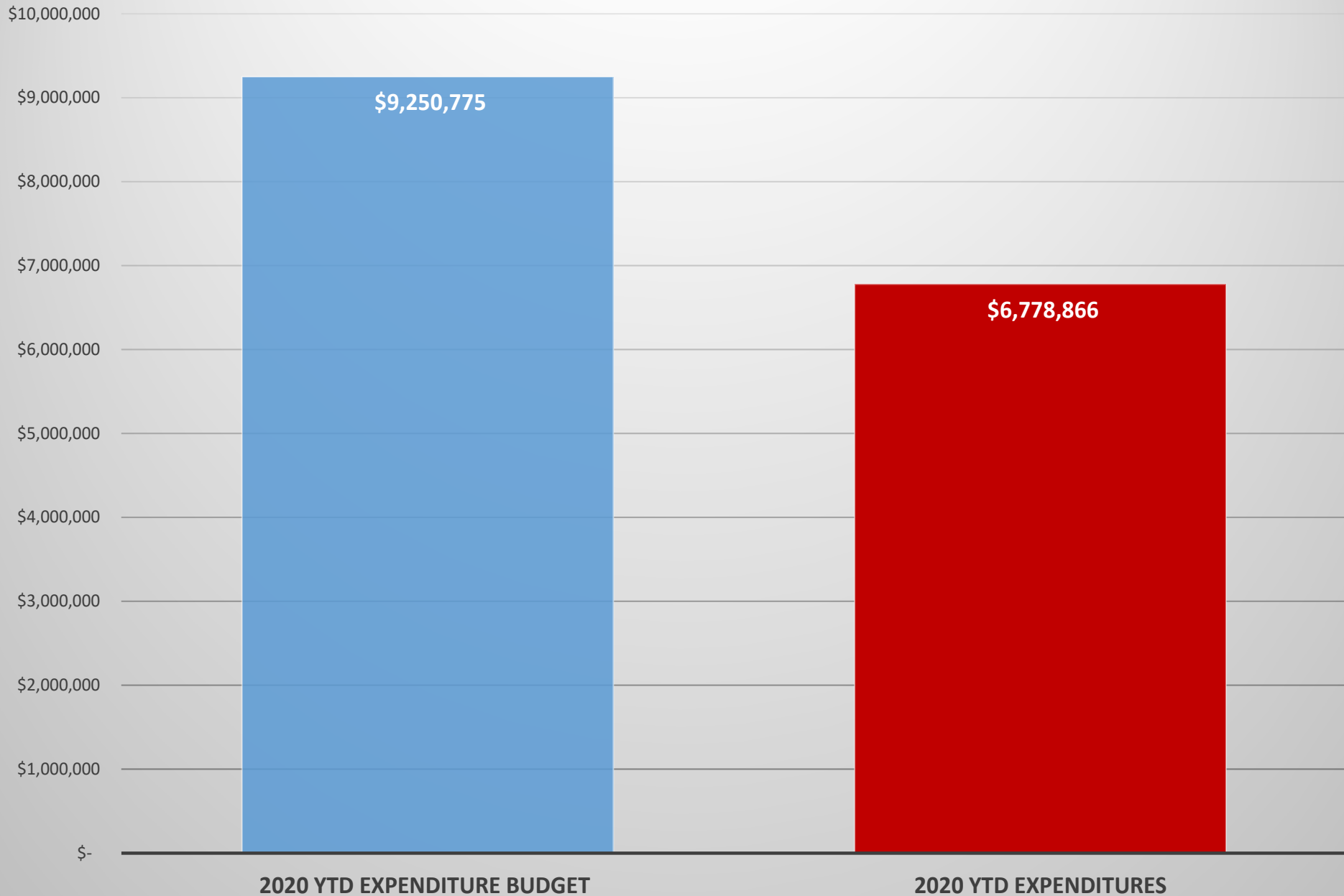

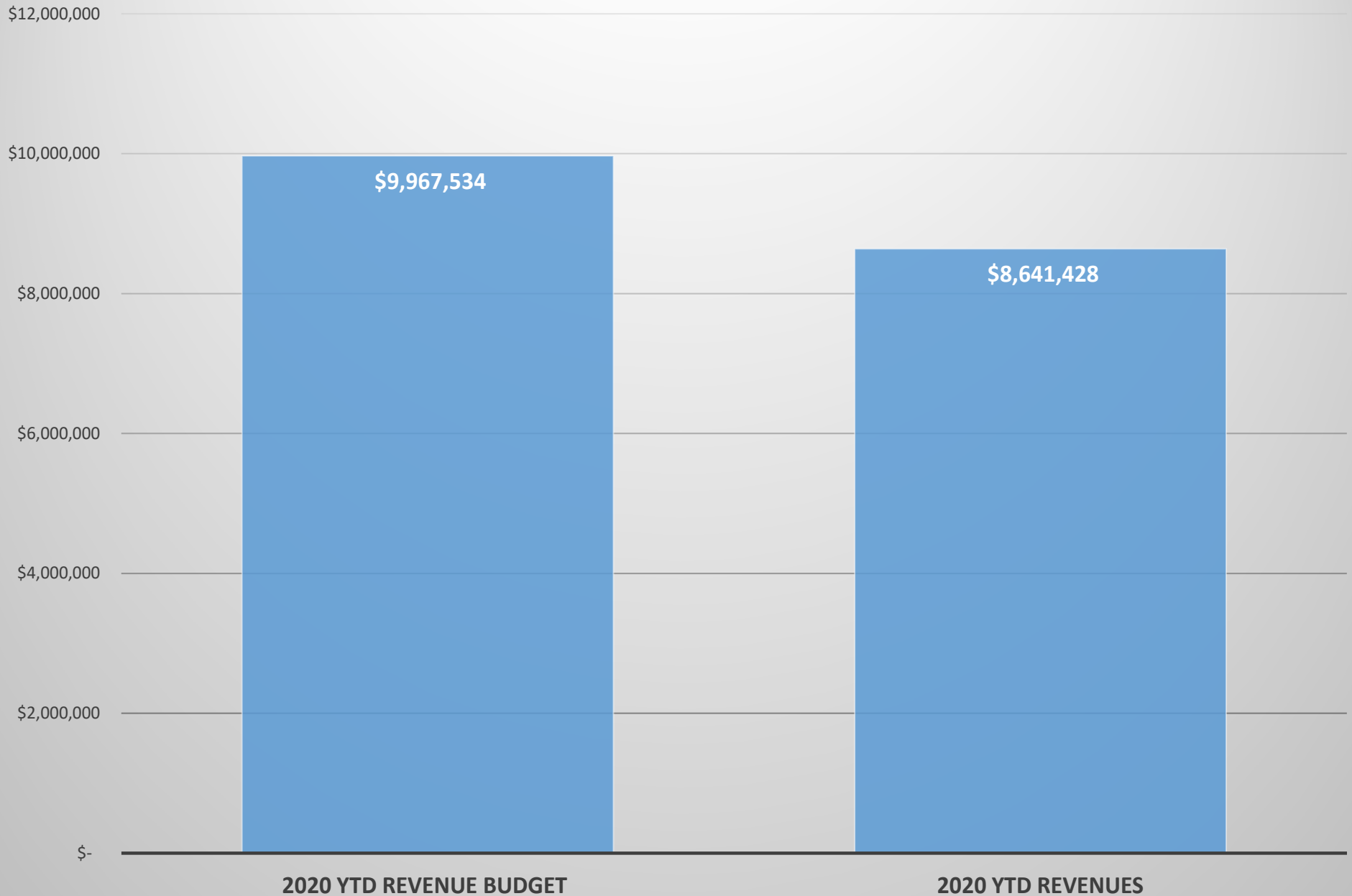

June 2020 Expenditures vs. Historical Budget Average



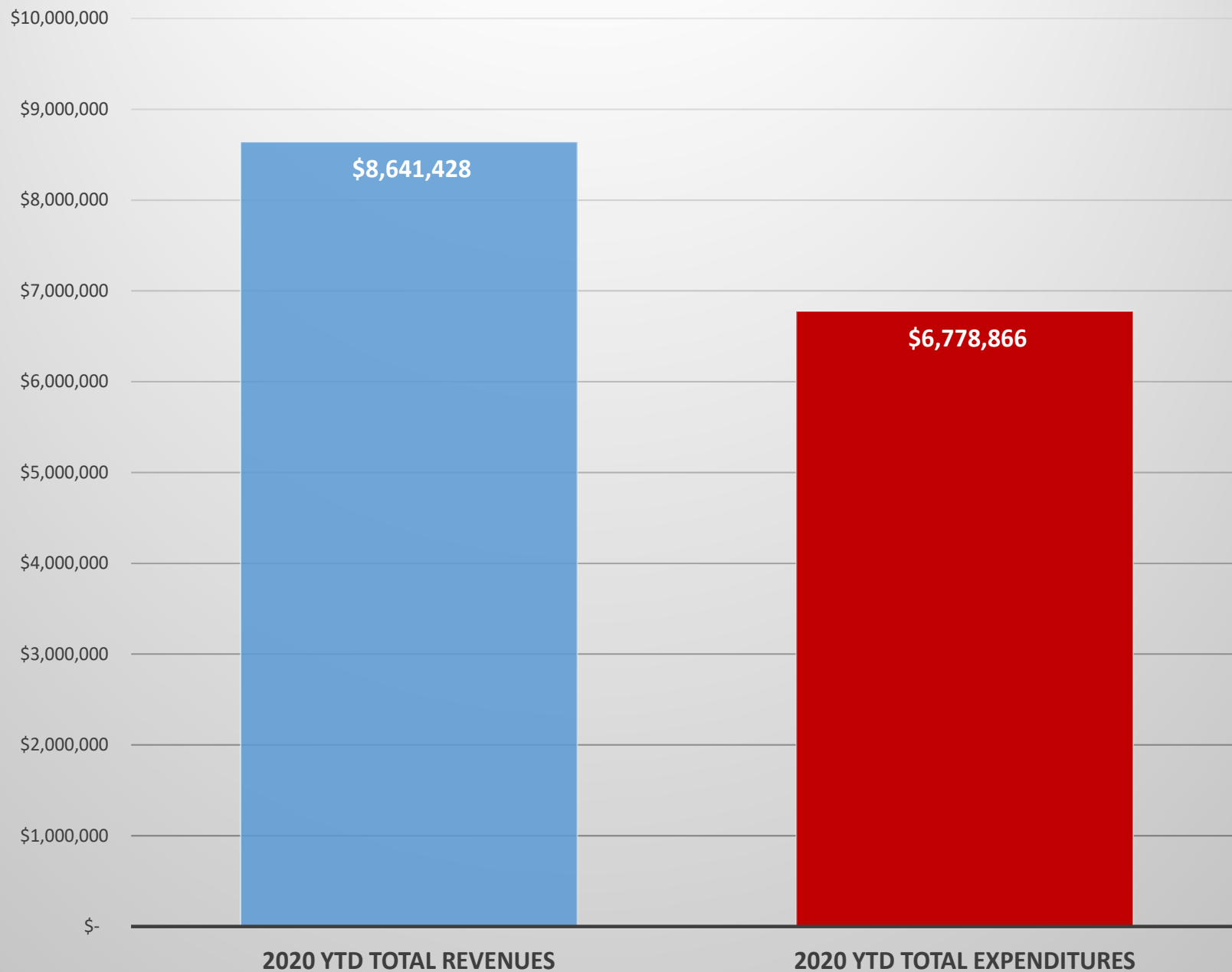

June 2020 Total Revenues vs. Historical Budget Average

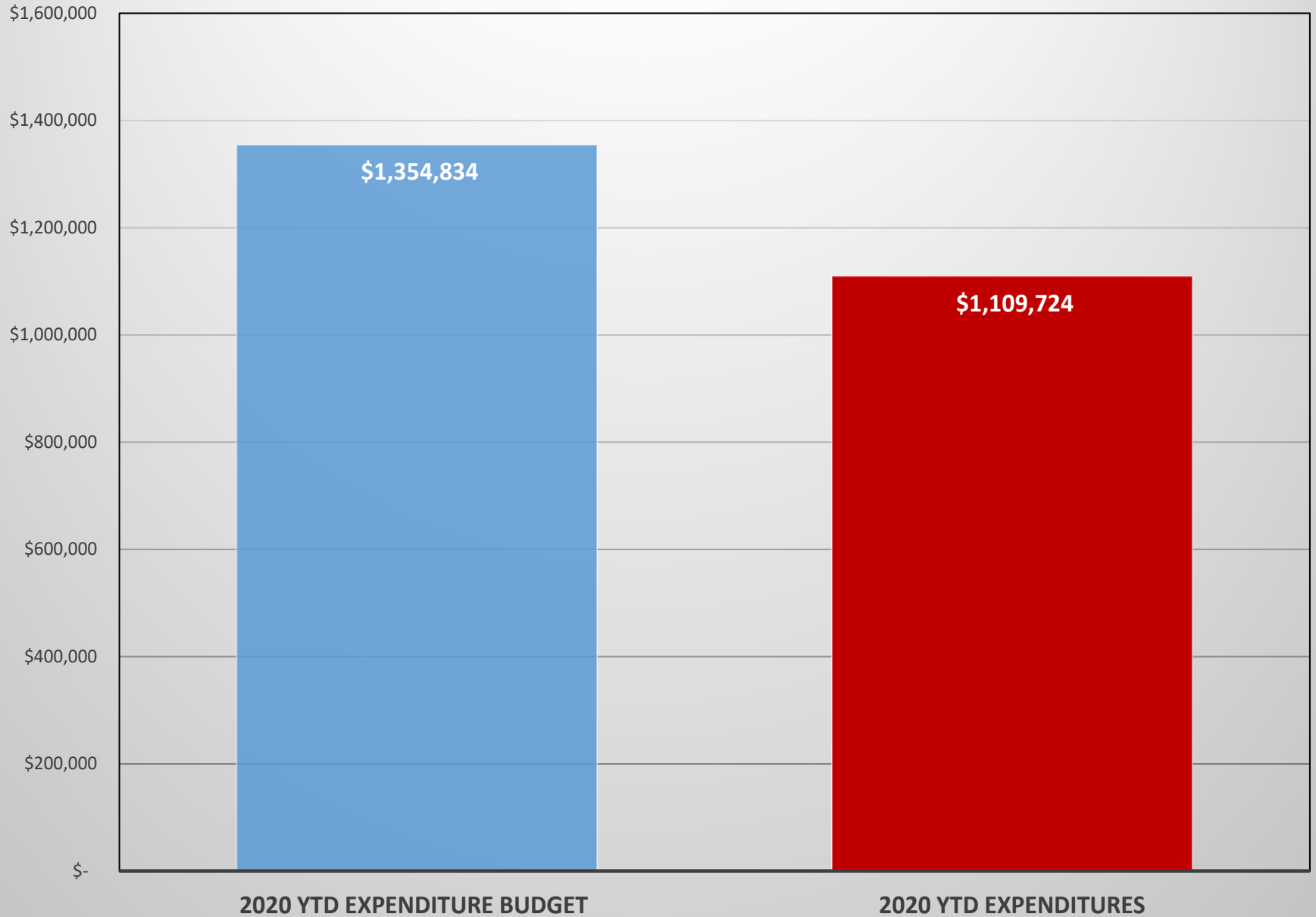

Total June 2020 YTD Expenditures vs. Total YTD Revenues

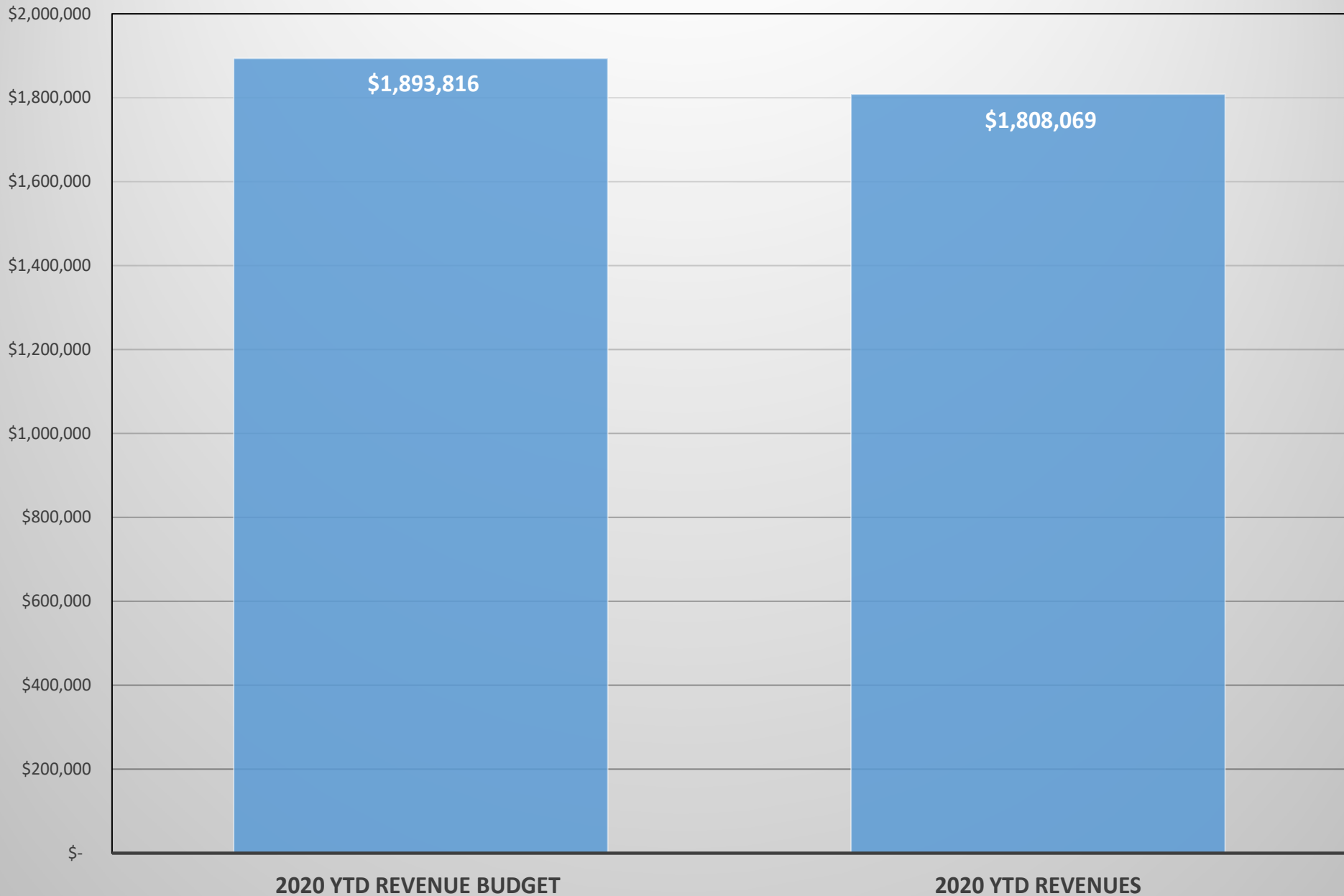

June 2020 Expenditures vs. Historical Budget Average



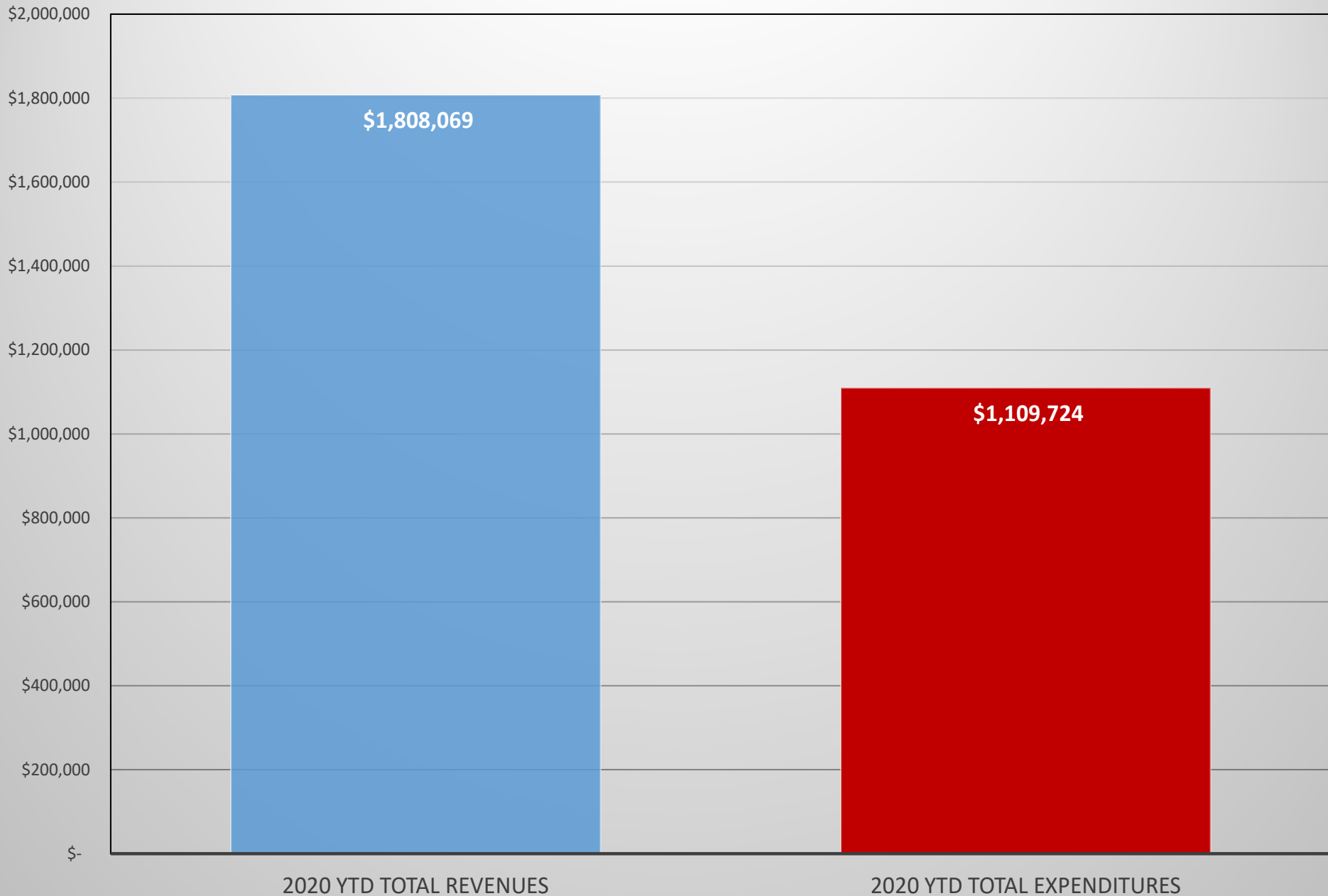

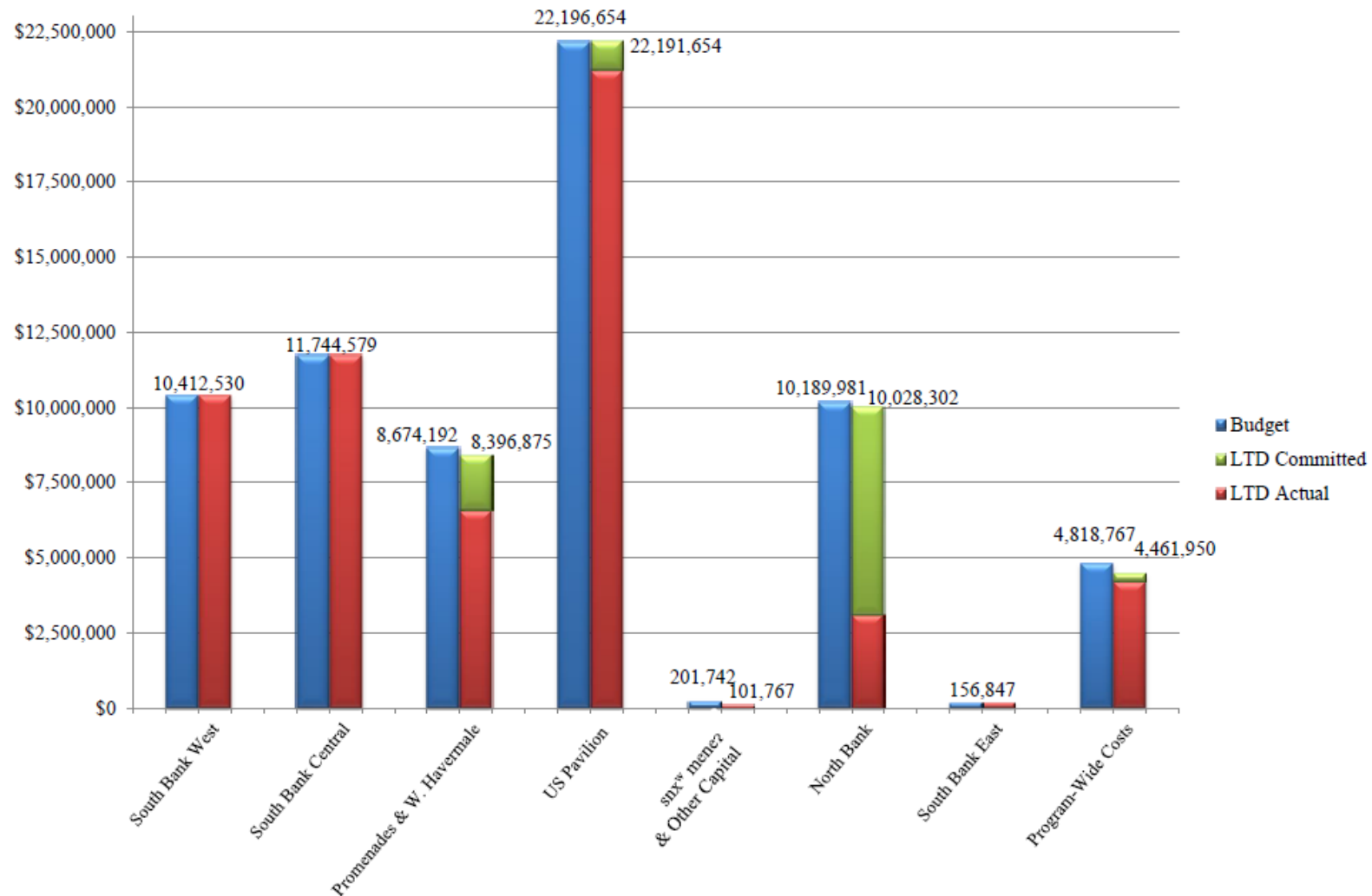


Lou Barbieri Bridge – New Deck

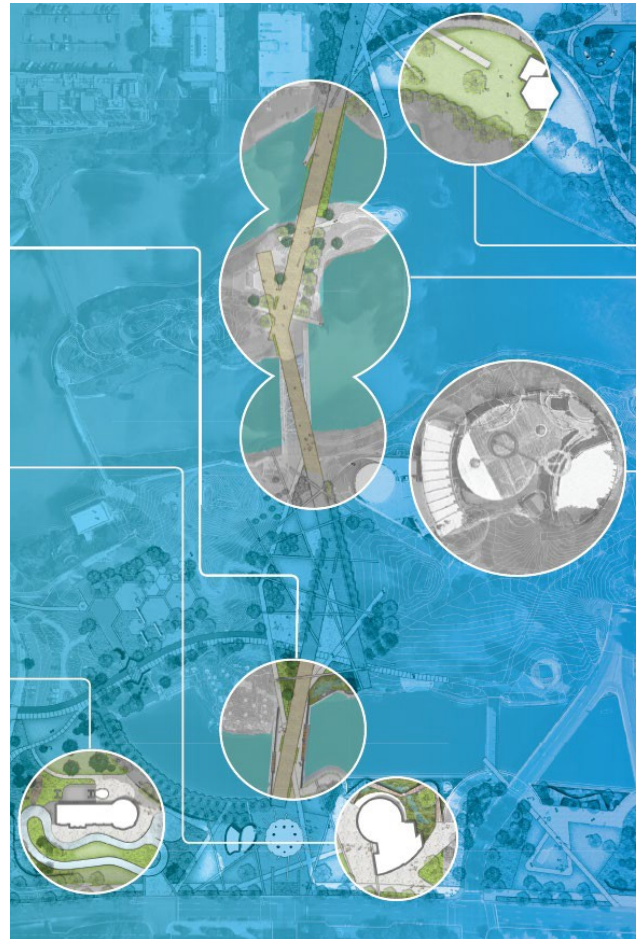

First off, I am highly disappointed that you are backtracking like this when you were already so far along and had already talked with the artist with her proposed work and just when things started to happen, the moment someone bad mouths art, you tuck your tails in. Please be professional with artists. Otherwise, Spokane may become a town of no-art, which isn't healthy. A thriving city has art, public art, and the city must be professional in their dealings.

If you are still reading this, here is a breakdown of my own opinions. Some of which are professional as an artist and curator.

Whispering Disc

I actually liked the interactive component of this piece. Visually it is almost brutalist in aesthetics, which won't appeal to children. It certainly appeals to adults. The only drawback I see is the potential for unwanted vocals occurring. Say an individual decided to say inappropriate things in a park where there are children present. But that is an individual problem, not an art problem.

The Seeking Place

I love the call back to a lot of our natural features but the interactive portion is lackluster. It is a very pretty light-up show. So it seems to be more activated at night. Perhaps with sunlight, it is just as visually interesting but again the interactive component is not really there other than people looking at it and the seating feels like an afterthought. Again, another piece that would appeal to adults. I don't see children being that interested in it.

Beaver

I personally don't like the aesthetics. But it is very whimsical and I think children would love it. With the swivel seating, it brings me memories of the berry-go-round. I think the only other critic I have is that it is limiting. As one focal point, only a handful of people can interact with it at a time. Although I suppose the garbage eating goat is the same thing. I suppose you need to ask yourselves, is the park for adults, or for children. And if the answer is both, then the art should reflect as such.

Redband Trout

I don't see the interactive component at all. At least Seeking place offered a path to walk through. This is just an oversized fish sculpture that will be begging folks to climb. It certainly

is colorful which will appeal to children. I am personally sick of fish art. So tired of seeing it literally everywhere (I get it, it is a safe choice but a lazy choice). We have more to offer than fish. In fact, we barely offer fish as a city (when was the last time you ate fish?). And yet it is the easiest go-to representation. Can we **not** have more fish art, please? We have so much to offer!
