## MINUTES

The meeting was called to order at 2:15 p.m. by committee chair Sally Lodato.

### **Discussion Items:**

1. Dwight Merkel Softball Concessions RFP – Carissa Ware

A request for proposal went out in January for sole concessionaire for Dwight Merkel Sports Complex (DMSC) with two respondents. The winning bid was awarded to All Star Concessions. They are a sports family and are familiar with the amount of activity at DMSC. They also won a bid for Riverfront Park's Skate Ribbon. This will be a good arrangement so that policies and procedures can be similar across Parks. Included in the DMSC contract is a clause stating that during busier events, DMSC will be allowed to bring in extra food trucks to alleviate the burden on just one vendor. They will be open for adult softball leagues for the first time in about 3 years. Jennifer pointed out that having a regular vendor in the complex will provide valuable insight into customer feedback based on their observations and interactions. Additionally, their consistent presence will help oversee the space and enhance overall awareness.

2. Community Center Contract & Funding Process Review – Jennifer Papich

Spokane Parks and Recreation partners currently with nine nonprofit Youth and Senior Centers through the Spokane Youth and Senior Center Association, each addressing unique community needs. A review of the funding model, last updated in 2013, is necessary for transparent and fair resource allocation. A working group comprised of City Staff, Park Board members, and other individuals will develop the Center Recreation Services Program Funding Application to gather comparable data on programs, community impact, and budget needs. The goals of this review are to enhance transparency, link funding to programming, and allow centers to adapt services. This structured approach will help ensure that we are making data-driven, equitable funding decisions while continuing to support the incredible work these centers do for Spokane residents. The Small group hopes to meet within the next month and hopes to have a first draft of an application to bring back to the Recreation Committee to review by no later than August 2025. If there are any funding modifications that are made after the review, these changes would not go into effect until the 2027 SYSCA Community Center Contract Cycle.

- 1. Recreation Quarter 1 Report Jennifer Papich & Fianna Dickson
  - a. Spokane Parks and Recreation supervisors are diligently working to adjust programming offerings to best suit the needs of the public. It's exciting to see the number of participants and teams continue to grow. (Please see the specific breakdown by program). Field allocations had a significant drop due to a combination of a milder winter season, opening of other synthetic turf fields in the area and some sporting programs starting than in 2024.
  - b. Marketing Josh and Adriano Eva also with camp staffers provided some great interviews on KXLY this week for Aquatics and the Dwight Merkel summer camp. They are already planning post summer promotions to get that into people's minds early. There will be an AED event at Dwight Merkel on April 19<sup>th</sup>.
  - c. Recreation is looking forward to exciting summer events staring soon!


Corbin experienced a 17% increase in revenue in Q1 of 2025 by adjusting programming according to demand and implementing minimal price increases.
