#### 2. **Presentation:**

A. Guy Gifford, Northeast Region Forester, Washington State Department of Natural Resources gave an overview of DNR programs and State grant opportunities. The Landowner Assistance Section's purpose is to assist forest landowners meet their goals and objectives for their land. They offer technical assistance, grants and the Firewise Communities program. Two of the main species of trees found in our local area are Ponderosa Pine, also known as the bull pine or yellow pine, and the Douglas Fir, also known as the Red Fir. Mr. Gifford explained how bark beetles can damage and kill trees and that trees use pitch as their natural defense to these beetles. Healthy trees with plenty of water sunlight and food can better ward off the insects. Mr. Gifford advised that Mistletoe, not the kind that you get at Christmas, is a disease that afflicts our forests. It is not considered a tree killer and is native to the area. Mistletoe spreads very slowly. He spoke about the natural process in the Ponderosa pine forests

### 2. **Presentation:**

Healthy trees with plenty of water sunlight and food can better ward off the insects. Mr. Gifford advised that Mistletoe, not the kind that you get at Christmas, is a disease that afflicts our forests. This disease is not considered a tree killer, is native to the area and spreads very slowly. He also spoke about the natural process in the Ponderosa pine forests. Historically naturally occurring low burning fire has been an integral part of keeping our forests healthy. Current fire protection laws prevent this natural process from happening and negatively affected the health of our forests. The lack of slow burning low natural fires creates more fuels and an increased risk of larger fires. DNR offers matching funds grants to thin and prune trees and clean up the slash created from the operation. With these grants the landowner is responsible for 50% of the cost. There is a maximum that the DNR will pay per acre. The landowner's matching portion can be in the form of money or in kind labor. Recently the DNR made these monies available to City and County properties which historically had not been an option. Our Urban Forestry Department has been awarded \$10,000 this year for work in Palisades. The DNR offers Firewise Communities program that is modeled after the Tree City USA program. The Palisades Neighborhood is becoming a Firewise Community and this will include Palisades Park. Firewise Communities can potentially qualify for more grants.
