ARPA Grantmaking (Shelly Wynecoop)

- Spokane Arts grantmaking \$2.3 million rewarded to artists since 2017.
- ARPA Spokane Arts will distribute \$1 million to artists/organizations/creative businesses who experienced unreimbursed negative economic impacts from pandemic.
- Working with a lot of minority communities, making sure materials are accessible.
- Awards to individuals and households, business, and organizations.
 Individual/ household Applications opened on 5/1 and closed on 6/15. Applicants will be notified on 7/15
- Empire Health Foundation bought in 3 national consultants to help navigate the process.
- Juan Mas was bought on board to help facilitate this process. He has been out in the community as a community navigator.
- \$200,000 to disperse to individuals; 68 eligible applicants.
- Non-Profits and Business portal opened June 1st and closes on July 15th Applicants will be notified 8/1.
 \$600,000 to disperse, 59 eligible applicants. Up to 10k/25k per applicant.
- Emma suggests that we capture the story of the ARPA process and how it is impacting artists and our creative community. Audrey suggests identifying 1-2 people of what this means to them, press release, quotes. Audrey will draft the press release.
- Shelly will share slides with commission, also available to answer any more questions or walking through the process.
