ALEXANDER J. SHOGAN, JR., Complainant in This Matter, In Reply to Respondent's Motion To Dismiss His Amended Complaint states as follows:

A. That Complainant had Conducted an Appropriate Good Faith Inquiry and Investigation before making the Allegations contained in Paragraph D of his Amended Sworn Complaint regarding Carly Cortwright and her Complaint of a Hostile Work Environment created by former SPD Chief Frank Straub. Complainant's Appropriate Good Faith Inquiry and Investigation led to an Article entitled "Cop Culture" on Page 20 in the December 20, 2015 Issue of the INLANDER (see Attached Copy of Page 20 of said Article). In that Article Carly Cortwright and Capt. Brad Arleth said that in executive staff meetings Straub would reference penis-measuring contests when challenged. Furthermore, Cortwright and Arleth said that in August 2013 Straub threatened to demote them after they exchanged a knowing glance and raised eyebrows during another executive meeting.

B. The **INLANDER** Article goes on to state as follows:

"Cortwright, who had worked fo the police department for more that a decade before she moved to a new job in City Hall two years ago, constantly ly butted heads with Straub over budgetary issues. For her, the culture created under his leadership punished honesty. 'The sexually charged language and behavior created another layer of disrespect' she says. "But the meat of the matter was, 'You know not to say anything or your turn to be degraded was next'"

C. It defies logic and reality to believe that Respondent did not know of Cortwright's Complaints against Straub in August, 2013 which led to her transfer to a "new job"in City Hall in 2013, since Respondent would have had to **personally** Approve the Transfer of such a high-level person as herself (SPD Executive) to the "new job". If Respondent had No knowledge of the reasons for Cortwright's Transfer to a Unique Position for her in City Hall and had No Participation in her Transfer, then he can merely Rebut Complainant's Reply herein by means of a SWORN AFFIDAVIT Stating so.

Based on All of the <u>Facts</u> stated above, Respondent's Motion For Dismissal of my Amended Sworn Complaint must be **DENIED**.
