Last year I began complaining to my council member Mike Fagan about the sanctuary city ordinances which I have since found out were requested by Mayor Condon.

Mike Fagan "suggested" that I do a petition rather than a writ of mandamus. He didn't tell me that 1) he already had made plans to do a petition and 2) he was very involved in the petition world.

Mike Fagan pretended that this was all my idea when the truth of the matter is that I was chosen by Mike Fagan, Tim Benn and others to be the "face" of their petition since none of them wanted to do something so dangerous. The petition was already set up and the players involved were just waiting for somebody with "working class" status and of the proper "ethnic background" to use. I find this unethical. I was tricked into doing a petition, which I was loath to do by subterfuge and deceit.

I have sent copies of the emails I have received from Mike Fagan, who also admonished me NOT to use the city email account, so that he could avoid detection in this enterprise.

In the email dated 11/10/2014 please note that Mike Fagan suggests that FAIR is "interested in finding someone in Spokane..." This is not true as I had already tried to contact FAIR. At no time was any correspondance to back up this allegation presented to me. This was a ruse, in my opinion, to insert Craig Keller and respectwashington, which Craig Keller is the sole proprietor of.

In the email dated 11/12/14 You can see how Craig Keller and respectwashington were inserted into the conversation. Now we have FAIR and respectwashington willing to "assist" me in this endeavor. That is NOT what is true. As you can see, Mike Fagan and Craig Keller were already in collusion about this matter. FAIR was never a part of this.

In the email dated 11/21/2014 you will see the proof of my allegation that Mike and Craig conspired to bring me in on THEIR petition. Mike has already lined up Mr Keller "a couple of weeks back, and Mike Fagan had sent my emails to himself to Craig Keller. Seems like a vetting process. At no time was I apprised of this "vetting" process. Craig Keller pretended to have this "idea' that I should be on the board of respectwashington. I did not like the idea but was persuaded by Mike Fagan and Craig Keller to do so. Of course all the expense of phones and PO boxes were borne by me. As I found out later, Mike used his insider information to circumvent the ordinance #C35167 barring outside influence in local politics. I find it unethical to use my name so that Craig Keller and respectwashington could get his foot in the door. I have been unable to get Craig Keller and respectwashington to remove my name from his organization.

I have included an email from Craig Keller showing how many times he tried to get me to send emails, purporting to be from me to Mr. Piccolo. I sent emails entirely from Craig Keller, he would not allow me to change a single word of his missives. Craig Keller feels that \*I\* was simply his "name" to use to get around the Ord. C35167.

I was informed on Dec. 2 2015 by Mike Fagan in front of witnesses that he had lied to me. Mike stated that I was merely Craig Keller's "local contact" and Craig's "coordinator". I NEVER signed on for that. Craig Keller was explained to me as my "assistant" not my boss. This was unethical in my opinion.

The whole petition was started and implemented through fraud and deception. I am angry that my city councilman Mike Fagan subjected me to all the hatred and vitriol, the expense and time I put into this endeavor under false pretences. I feel used an abused and Mike Fagan deliberately tricked me into this situation. He should be punished.

Thank you for your December 8 communication:

I appreciate your addressing of my concerns with that very early ballot title draft.

I also thank you for efficiently reformatting the ordinance and technically adding the "Effective Date" and Charter Section 82 sections.

Thank you for seeking clarification about the name of the committee which I - the sole petition sponsor- am partnering with to offer this petition to the public. Yes, please utilize "Respect Washington" as the registered entity.

Despite those several improvement I have three small, detail questions.

Recommended in the signature block is a column entitled "CHECK IF REGISTERED ADDRESS IS DIFFERENT." This data does not seem to be "mandatory" under SMC 2.02.060. I do appreciate how this data can be helpful to the Auditor come her attempted validation of signatures which did not record an address of domicile. Yet I speculate that the County Auditor should have no problem validating such enteries as modern day voter registration databases link mailing address and physical-voter-registration address. I hope this column can be avoided to make room for other desired information and toward promoting improved legibility of the signer's input on this relatively small sheet of paper. I thank you for your review.

2. I notice now how the prayer of the ballot title has added "special" [election]. While the option of sending the question to a special \_or\_ general election appears to be the Council's, upon submission of a "Fifteen Per Centum Petition," it would also appear from Charter Section 82 that a "Less than Fifteen Per Centum Petition", can be referred only to a general election ballot. I duly note that "special or general" precludes neither! So perhaps I waste words here. Yet I just have a

## **ORDINANCE NO. C - 2015-1**

AN ORDINANCE RELATING TO IMMIGRATION STATUS INFORMATION, AMENDING SMC SECTION 3.10.050 AND ADOPTING A NEW SECTION 3.10.060 TO CHAPTER 3.10 OF THE SPOKANE MUNICIPAL CODE

## The City of Spokane does ordain:

**Section 1.** That SMC 3.10.040 (Ord. No. C35164 relating to bias-free policing), is amended to read as follows:

## 3.10.040 Biased-Free Policing

A. The City of Spokane is committed to providing services and enforcing laws in a professional, nondiscriminatory, fair and equitable manner.

B. Spokane Police Department Officers and all officers commissioned under the Spokane Police Department shall be prohibited from engaging in bias-based profiling.

C. Bias-based profiling is defined as an "act of a member of the Spokane Police Department or a law enforcement officer commissioned by the Spokane Police Department that relies on actual or perceived race, national origin, color, creed, age,((-citizenship status;)) gender, sexual orientation, gender identity, disability, socio-economic status, or housing status or any characteristic of protected classes under federal, state or local laws as the determinative factor initiating law enforcement action against an individual, rather than an individual's behavior or other information or circumstances that links a person or persons to suspected unlawful activity."

D. The Spokane Police Department shall maintain policies consistent with this section.

Section 2. That SMC 3.10.050 SMC (Ord. No. C35167 relating to immigration status information), is repealed

# (( 3.10.050 Immigrant Status Information

A. Unless required by law or count order, no Spokane City officer or employee shall inquire into the immigration status of any person, or engage in activities designed to ascertain the immigration status of any person.

B. Spokane Police Department officers shall have reasonable suspicion to believe a person has been previously deported from the United States, is again present in the

United States, and is committed or has committed a felony criminal-law violation before inquiring into the immigration status of an individual.

C. The Spokane Police Department shall not investigate, arrest, or detain an individual based solely on immigration status.

D. The Spokane Police Department shall maintain policies consistent with this section: ))

**Section 3.** That there is adopted a new section 3.10.060 to chapter 3.10 of the Spokane Municipal Code to read as follows:

3.10.060 Respect for Law: The City of Spokane shall not limit the ability of any city employee from collecting immigration status information, communicating immigration status information and cooperating with federal law enforcement authorities unless such regulation is approved by a majority of the city council and a majority vote of the people at the next general election.

**Section 4.** Construction: The provisions of this measure are to be liberally construed to effectuate the intent, policies, and purposes of this measure.

Section 5. Severability: Should any provision of this ordinance or its application to any person or circumstances be held invalid, the remainder of the ordinance or the application of the provision to other persons or circumstances is not affected.

Section 6. Effective Date. This ordinance, if approved by the voters, shall take effect and be in full force upon the issuance of the certificate of election by the Spokane Auditor's Office.

Section 7. That this ordinance be submitted to the voters of the City of Spokane for their approval or rejection at the next applicable election under Section 82 of the Spokane City Charter.
