Since when do Monique Cotton and her Attorney dictate the protocol policy laws of Spokane or suggest they be ignored? EVERY THING WAS DONE ACCORDING TO THEIR OWN ACCOUNT TO CIRCUMVENT CITY RULE/POLICY/PROCEDURE/LAW!

DEFINITION OF COLLUSION:

An agreement between two or more people to defraud a person of his or her rights or to obtain something

A secret arrangement wherein two or more people whose legal interests seemingly conflict conspire to commit Fraud upon another person; a pact between two people or more to deceive a court with the purpose of obtaining something that they would not be able to get through legitimate judicial channels.
