On January 6th 2014 at 12:40 PM City Employee <u>Lisa Jones</u> and several others employees including Dean Giles City Of Spokane Planning and Development was notified by the SRHD that Spokane Daiquiri Factory was Approved to Open.

## (Email Exhibit #1 Attached).

Spokane Downtown Daiquiri Factory opened for business on January 30th 2014.

The same day local "activist" Scott Kusel launched a media smear campaign on the drink names of the venues menu.

On Friday February 7th at 1:52 PM Lisa Jones inquired with other City of Spokane Employees on the Mac Occ Load. A load that Spokane Fire is required to issue via the Assembly License applied for and approved by Spokane Fire.

Friday February 7<sup>th</sup> at 2:16 PM Scott Kusel sends a follow up email to Lisa Jones stating:

"Thank you for taking so much time to speak with me on the phone today. **The information you provided was amazing and will benefit me well beyond my situation.** (which at the time was targeting a minority owned business that just opened in downtown Spokane). In the email he attached images and stated: I will keep an eye on this and will careful if it comes time to report an over capacity situation.

Friday February 7<sup>th</sup> at 3:33 PM Lisa Jones responds to Scott Kusel via email: Thanks Scott for your "inquiry"

# (Email Exhibit #3 Attached).

This is a clear violation of PRA. Lisa Jones has disclosed specific business occupancy load information to the public without receiving a filed Public records request in effort to conspire with boycotters to target the business for future "capacity situations". Situations, that Lisa in her capacity as the Fire Marshall clearly discussed with Scott Kusel during their "phone conversation/Inquiry"

This is also a violation of the Spokane Ethics Code

#### I. Disclosure of Confidential Information

1. Disclosure of Confidential Information No City officer or employee shall, except as required or reasonably believed to be required for the performance of his/her duties, disclose confidential information gained by reason of his/her official position or use such information for his/her own personal interest. "Confidential information" is all information, whether transmitted orally or in writing, that the employee has been informed, is aware, or has reason to believe is intended to be used only for city purposes, is not intended for public disclosure, or is otherwise of such a nature that it is not, at the time, a matter of public record or public knowledge. 2. Confidential information includes, but is not limited to, personal information regarding City officials and employees; private financial and other personal information provided by city taxpayers, license holders, contractors, and customers; intelligence and investigative information, including the identity of persons filing complaints; formulas, designs, drawings, and research data obtained or produced by the city and preliminary, non-final assessments, opinions, and recommendations concerning city policies and actions. Any public official who is uncertain as to whether certain information is confidential should consult the City Attorney. An employee who is uncertain as to whether certain information is confidential should consult their immediate supervisor or department head.

We know this because 2 minutes after receiving the Occupancy load information for Spokane Downtown Daiquiri Factory by email from co-worker Laura Thurston at **2:03 PM**. Lisa Jones promptly turned the "phone conversation/Inquiry" into a Complaint. At 2:05 PM Lisa Jones claims she had "received a complaint" in an email sent to Michal Miller Assistant Spokane Fire Marshall.

## (Email Exhibit #4 Attached).

Somehow in 60 seconds a complaint (that is nowhere in the public records) came in and was taken by Lisa Jones that there were over 600 people in the business on opening night.

After disclosing confidential compliance information with Scott Kusel via phone and inquiring with City of Spokane Staff, this "information about keeping Spokane Safe" somehow turned into an official complaint. A Complaint manufactured by Lisa Jones and then forwarded to co-worker Michael Miller which was used to later by The Spokane Fire Department to target the Downtown business for compliance issues in an official capacity, when no "Official Complaint" was even made but only manufactured by Lisa Jones.

Lisa then uses her own manufactured complaint to schedule a visit to check! On the same day Scott Kusel had a protest scheduled at the location. This is clearly no coincidence. This was later followed by even more fabricated actions by Lisa Jones that we will reveal at a future Ethics Commission hearing scheduled on this matter.

These actions are also violations of the Spokane Ethics Code:

# K. Fair and Equitable Treatment.

- No City officer or employee shall knowingly use his or her office or position to secure personal benefit, gain or profit, or use position to secure special privileges or exceptions for himself/herself or for the benefit, gain or profits of any other persons.
- 2. No City officer or employee shall employ or use the employment of any person under the City officer's or employee's official control or direction for the personal benefit, gain or profit of the City officer or employee or another beyond that which is available to every other person.
- 3. No City officer or employee shall use City-owned vehicles, equipment, materials, money or property for personal or private convenience or profit. Use is restricted to such services as are available to the public generally, for the authorized conduct of official business (not personal use),

- and for such purposes and under such conditions as can be reasonably expected to be approved by City policies.
- 4. Except as authorized by law and in the course of his or her official duties, no City officer or employee shall use the power or authority of his or her office or position with the City in a manner intended to induce or coerce any other person to provide such City employee or any other person with any compensation, gift, or other thing of value directly or indirectly.
- 5. City Officers and employees are encouraged to participate in the political process on their own time and outside of the workplace by working on campaigns for the election of any person to any office or for the promotion of or opposition to any ballot proposition, but shall not use or authorize the use of City facilities of resources for such purposes except as authorized by the provisions of RCW 42.17.13.

## N. Commission of Acts of Moral Turpitude or Dishonesty Prohibited

No City officer or employee shall commit any act of moral turpitude or dishonesty relating to his or her duties or position as a City officer or employee or arising from business with the City. Conviction of a felony or a misdemeanor involving moral turpitude or dishonesty, the nature of which demonstrates lack of fitness for the position held, shall be considered conclusive evidence of a violation of this Code of Ethics. Demonstrated acts of moral turpitude or dishonesty are not limited to felony or misdemeanor criminal conviction
