



As a member of our Spokane community I felt compelled to contact you regarding a medical marijuana dispensary in Spokane. I believe there is a legitimate want and need for medical cannabis which is why the City of Spokane took the time, effort and care in drafting ordinance C-35037. Unfortunately it appears that some local entrepreneurs are "thumbing their nose" at the City of Spokane. One that particularly stands out is WA 420 Medical Facility 423 W. 1st Ave. Spokane. I realize there are not enough hours in the day or available manpower to monitor every business in Spokane all the time ...but this is a blatant disregard for the laws enacted by the City of Spokane. There are many legitimate dispensaries in Spokane operating well within the law. The 420 Medical Facility has chosen its own illegal path. According to the ordinance there are a few issues that came to my immediate attention. C-35037 - 10.49.040A - License Required - I am wondering if they are actually licensed. C-35037 - 10.49.060C - (#10) consumption of cannabis on the premises - it seems as though they have a dab/smoking bar available for use within the location. C-35037 - 10.49.060C - (#11) the premises shall be closed to distribution of marijuana between the hours of ten p.m. to seven a.m.. They advertise that they operate 24/7. Also I believe in the State of WA you must be a resident with a WA Medical Cannabis Authorization Card to obtain medical cannabis - CA cards do not cross over to a WA authorization. I have attached a page from weedmaps.com that mentions/documents all of the above concerns. Fell free to go to the website and confirm the information. I think Small Business Saturday should be represented in a positive way in the City of Spokane. I appreciate your time and efforts in keeping the City of Spokane operating safely for all.

Dear Teresa,

Thanks for contacting me about the application of Lucky Leaf LLC to relocate its retail business to West First Avenue. I have heard from dozens of community members who are concerned about the retail sale of cannabis products and especially shops located near a church. I have contacted the Washington State Liquor Control Board enforcement division for Spokane, the Spokane Police Department and other city staff. The Mayor's office speaks for the City in opposing specific locations for cannabis store and did not object to Lucky Leaf's request. One reason is that Washington State voters approved the sale of retail cannabis products in Washington with some limitations on location, which did not include proximity to a church. See RCW 69.50.331:

(8) The state liquor control board shall not issue a license for any premises within one thousand feet of the perimeter of the grounds of any elementary or secondary school, playground, recreation center or facility, child care center, public park, public transit center, or library, or any game arcade admission to which is not restricted to persons aged twenty-one years or older.

The Spokane zoning code does further limit the establishment of retail cannabis shops in residential neighborhoods, but the Lucky Leaf LLC is within the downtown core and thus is a permitted use. Ultimately, the WSLCB s ll has the power to grant or deny a permit to Lucky Leaf and you may want to direct your concerns to them at:

I've a ached more information from my colleagues in Neighborhood Services giving a little more detail, as well as CC'ed my Skyler and Julie Happy who is referenced as a contact in the a ached materials. My suggestion in expressing your concerns is to focus on the statutory reasons for denying a permit, such as Lucky Leaf's past record of compliance with the law and whether you believe any of the protected facilities listed in paragraph 8 above exist within 1,000 of the proposed location.


Dear Karen Stratton:

I wish to express my objection against the proposal for licensing of the Lucky Leaf, LLC marijuana business to be located in downtown Spokane. I am a member of the Spokane Cathedral Parish there and when I go in to make sandwiches early in the mornings for the homeless in our area, I have been approached before by individuals and felt very uncomfortable. We make sandwiches that we hand out to parents with small children who have nothing else to eat and who must walk to and from this area to get nourishment. The other women volunteering are mostly senior citizens who live alone and donate time and effort to help the poor. This feels very much like an increase in their vulnerability.

We also hold family gatherings at the church areas that are bordering this proposed establishment. Children are present here on a daily basis. Parking is at a premium and this will only increase the rise in those walking about and on the bus transit system.

This type of business needs to be located in a more appropriate area of the city that is not family oriented and tourist centered. This is just as important as a daycare center or school and functions very much in the same way. It is a neighborhood and needs to remain just that vs a retail drug area which will degrade the safety of the vulnerable elderly, children, and families who live here. Please do not consider this license as for the good of the people here. It is for a few individuals who have means of traveling to another more appropriate area to engage in their selected activities. Thank you. Sincerely,

Skyler and Brian,

I understand Karen's desire to be cautious and think she would be justified in abstaining for voting on this issue even though there is a good argument that there is no conflict since she is engaging in a legislative function that affects all businesses equally.

I do have some concerns with the suggested changes.

The Council needs to be aware that the recreational license is a state-issued regulatory license like a liquor license for a bar. The Liquor and Cannabis Board is responsible to comply with their own notice requirements. The City can certainly take the extra step of

forwarding the notice as part of a neighborhood notification process, which can be done administratively. However, I do not think the City can impose additional regulatory requirements for a state-issued license.

As for adding AIA and churches to the list of protected entities with the 1,000 foot restricted areas, I do not believe the City can expand this list, which is created by state law. *RCW* 69.50.331 (8) (a) and WAC 314-55-050(10) provide that the LCB shall not issue a license for any premises within 1,000 feet of the perimeter of the grounds of any:

- (a) Elementary or secondary school;
- (b) Playground;
- (c) Recreation center or facility;
- (d) Child care center;
- (e) Public park;
- (f) Public transit center;
- (g) Library; or
- (h) Any game arcade (where admission is not restricted to persons age twenty-one or older).

The Council could not take action that would expand this list of protected entities. The LCB certainly would not be obligated to recognize any council action that amended this list.

The City Council can regulate the location of marijuana producers, processors and retailers through zoning, which the City has by prohibiting any of these facilities in residential, CC1 and neighborhood retail zones. I have attached a link to the MRSC website that provides more discussion regarding land use and zoning issues relating to marijuana.

Tyler Whitney in the Mayor's Office had been very involved with this particular location and may have more information.

Please let me know if you would like to discuss this issue further.

Several weeks ago, there was a little public blow up regarding a new retail Marijuana shop opening up on 1st Ave. downtown.

The public outcry came from the Lady of our Lords Catholic church, the Russian Orthodox church, the Denny Murphy clinic, and other businesses due to the specific lack of public notice that a license was pending. Current law provides for 20 days notice extended to the city by the LMCB, and the city does not issue any public notice except to require the licensee to post a notice on the businesses front door.

I am writing to you today to see if you could find yourselves supporting a change in the ordinance which would;

- 1. Require a "neighborhood notification" type of public notice upon receipt of a license pending.
- 2. Add AIA (Alcohol impact areas) and Churches to the restricted list.

I understand that by adding to the list of restricted areas, there will be a

few who are grand fathered in. As long as those licensee's do not violate the law or their business license requirements they would be allowed to remain.

I have spoken with the council president who advises that if there is enough interest by council he would be supportive of allowing this issue to move forward.

Please let me know your initial thoughts.



Dear City Council President Stuckart and Council members:

Attached are photos I took on Wednesday May 18, 2016 in front of Lucky Leaf Co. at 1111 W. 1st Avenue. The signboard, which I had seen on other days in front of the shop, advertised marijuana products and was therefore in violation of WAC 314-55-155, so I reported it to the LCB. Later that afternoon, a man appeared and took photos of both sides of the sign and then went into Lucky Leaf. Within a minute or so, the sign was pulled into the shop, so I assume the gentleman was from the LCB.


In the people photos, the man in black (not Johnny Cash!) had been in Lucky Leaf and came back out, where he shared something with the other pictured man. The two men then smoked something in small pipes. The man in black invited me to "come on over and join the party". When I declined and pulled out my phone, he asked me to take photos of the group and said I could post them on Facebook. I have not posted them anywhere, but I am sharing them with you and Mayor Condon (if I've done everything correctly).

I also told Mayor Condon about my experience at Lucky Leaf on Bloomsday. Two young men (one told me he was 18; the other looked not much if any older) spread out a large blanket bearing a marijuana leaf design on the sidewalk just east of Lucky Leaf's front door and sat on it off and on for a long time. A passing pedestrian gentleman took some photos of them, then came over to me, shook my hand, and thanked me for being there with my sign. He introduced himself as a downtown business owner and told me that he and some other business owners he knows are not happy about marijuana retailers moving into downtown Spokane.

I spoke (very poorly, in my opinion) at the May 16th City Council meeting before the above-mentioned incidents happened. I do not consider myself to be a very good spokesman for Spokane's youth, poor and/or other vulnerable downtown people, but I will do what I can as long as God continues to enable me to do so.


Hi Karen,

I send you this letter as a fellow elected official in Spokane. Like you, I am deeply concerned about economic development in my community and, in particular, the orderly and safe growth of the cannabis industry. My experience with these businesses is personal in that we own a producer farm in Cheney, Washington. That said, on a political level I am also keenly aware of the positive impacts cannabis businesses can have in a community.

I am also personally acquainted with many cannabis business owners in Spokane, including David and Shilo Morgan, who own Lucky Leaf in downtown Spokane. The area of downtown where they are located struggled with crime, homelessness, and derelict buildings. The area has seen a resurgence of investment in recent years, and Lucky Leaf has been an important part of that resurgence. Since 2016, when Lucky Leaf opened, new businesses have opened nearby and the area that area of downtown continues to flourish and is experiencing less crime. 

Lori Kinnear deposes, declares and states:

- 1. I am over the age of eighteen and competent to testify in the above matter, and I make the following statements based on personal knowledge.
- 2. I am a member of the Spokane City Council. I have been an elected member of the Council since 2016. Prior to my election to the Council I served as a legislative aide to Council Member Amber Waldref. As a legislative aid, and later as a member of the Spokane City Council, I have had many discussions with Council Member Karen Stratton ("CM Stratton") on a variety of city issues and matters.
- 3. I first became aware of the licensed cannabis retailer "Lucky Leaf" in 2016. At that time Council Member Beggs ("CM Beggs") and I were approached by Father Connell, who resides at Our Lady of Lourdes cathedral downtown within several blocks of Lucky Leaf. He was very upset about Lucky Leaf locating so close to the Cathedral and related to us the increase in needles and cannabis paraphernalia in and around the grounds of the Cathedral. He also related that his living quarters were broken into and items were taken. He blamed this criminal activity and littering on the customers who frequented Lucky Leaf.
- 4. Later that year CM Beggs and I were asked to be part of a panel to discuss how to prevent cannabis retailers from locating near churches. The panel also included a

Washington State legislator. We were questioned by church participants and Father Connell about what the City could do to mitigate the perceived negative impacts of retail cannabis shops. The attendees were angry and demanded that the City "do something" to remove Lucky Leaf, citing all the negative behavior they were seeing around that part of downtown. The state legislator also put the onus on the City of Spokane, specifically the City Council, to take action regarding the siting of retail stores. CM Beggs and I pushed back on this request, reiterating that the licensing requirements for cannabis retailers is something the State of Washington should be regulating, not the City of Spokane. The panel discussion ended without resolution.

- 5. Several weeks after the panel discussion I visited Lucky Leaf with SPD Officer Ottmar. We spoke to the manager and mentioned the negative behavior in and around the area, asking him if he could better manage those customers in and around the store. The manager agreed to make an effort to resolve the behavior of his customers. I am advised that after our visit and subsequent visits by Officer Ottmar or other SPD officers, the issues around Lucky Leaf quieted down.
- 6. Despite the decreased negative behavior around the store, a protest by a former state legislator was started and petitions were circulated to change zoning laws and other regulations to remove Lucky Leaf (after the fact) and prevent further cannabis retailers from locating in and around churches. The petition was not successful.
- 7. The issues around Lucky Leaf became less of a problem as time passed. I have not heard from Father Connell or anyone at the Cathedral since, and to my knowledge other council members likewise have not received complaints about Lucky Leaf.
- 8. My interaction with Lucky Leaf in 2016 was part of a broader effort by members of the City Council at that time to engage citizens regarding issues associated with licensed cannabis businesses. My recollection is that before and after our panel discussion in 2016, CM Stratton had been communicating with concerned citizens and the operators of Lucky Leaf regarding perceived criminal activity near the store, and that she had been to the Lucky Leaf store to address those concerns.
  - 9. During my time on the City Council, CM Stratton has been careful to recuse

herself from legislative votes that she believed might appear to benefit her or her farm directly or indirectly. For this reason, I believe that if CM Stratton or her farm had a business relationship with Lucky Leaf, she would have advised me of the fact, and I would recall it. I do not remember CM Stratton ever indicating her farm had done business with Lucky Leaf.

10. I am aware of the June 20, 2018 letter written by CM Stratton to the City of Pasco. It is not my place to express an opinion as to whether the letter constitutes a violation of the Spokane Code of Ethics, but I can say the fact of the letter and the tone therein is entirely consistent with CM Stratton's approach to her position on the council. CM Stratton is well-known on the council (and in Spokane in general) for her hands-on and energetic efforts on behalf of constituents and Spokane citizens. The letter is also consistent with her stated support of the cannabis industry in Washington.



I send you this letter as a fellow elected official in Spokane. 



Mr. Steel,

On Monday, August 19, 2019, I received an invitation from the Executive Board of the Spokane County Republicans to participate in candidate interviews on Tuesday, September 3, 2019.

Initially I was very happy to receive this invitation. As you know, elections for Mayor and City Council members in the City of Spokane are non-partisan positions. I truly believe keeping the positions non-partisan ensures that we work together on many local issues.

Approximately one week after accepting the invitation, I was directed to the Facebook page of the Spokane County Republican Party. There I found a very negative and disparaging post about me and a letter I had written more than a year ago, as a public official, to City Council members in Pasco, Washington.

The comments regarding my letter took me by surprise. First, no attempt was made by the Spokane County Republican party to ask me why I had written the letter. It suggested to me your group was not interested in the whole story but rather only the narrative that fit its particular view about the current City Council.

Had you first contacted me about the letter, you would have learned a local cannabis retailer asked me to write the letter in an effort to educate the council members in Pasco on my experience in the industry and my thoughts on its impact on our community. Given my personal knowledge of the industry, I was happy to do it, as I know many communities have been hesitant to allow and welcome these businesses. I stand by what I wrote in that letter and would do it again if the opportunity arose. While I avoid votes on our local council if there is even an appearance of a personal benefit to our farm, I will always stand up for the industry and advocate for it when the opportunity presents itself.

Second, had you asked me about the letter before posting your comments, you would have learned there is no financial connection between the particular

retailer who asked for the letter and our family farm. Our farm is a licensed producer, not a processor, and thus is prohibited from selling directly to any retailer. Our product is sold wholesale to processors, and from there we have no control over its eventual destination. To my knowledge our product actually has never been sold by this particular retailer. In fact, our farm has never benefited financially by any retailer – our sales depend entirely on our relationships with processors.

Naturally, as a licensed producer I have become acquainted with many other marijuana licensees (including retailers). I have grown to appreciate their hard work and their commitment to responsible growth of the industry, to their workers, to compliance with state regulations and to the community. The fact that I supported the efforts of this particular retailer in its efforts to get a fair review in Pasco is entirely consistent with my support of the industry in general.

Coming from a political family, I was always taught to listen to both sides of an issue. I believe that it is important to listen to people of all political beliefs. Democrats, Republicans, Independents --- we all have a stake in the issues that affect our community. Regrettably, I do not see that spirit reciprocated by your party.

As a result of this turn of events, I have chosen not to participate in your interviews this campaign season. Not only do I feel it would be unproductive, but the posts on the Facebook pages convinced me that your invitation to participate is not in good faith.














#### Legislative Committee
