City of Spokane Ethics Commission,

Complaint regarding; City Council president Breean Beggs (may also go by Breen), and council members Betsy Wilkerson ("true name" may be Elizabeth Lou Wilkerson), Karen Stratton, Lori Kennear and Zack Zappone ("true name" may be Zachary).

My Name is Dave M.

I have spoken many many times at City Council meetings for the past two plus years and even longer at Park board, School board and other various City public forums without a single issue over my name Dave M. I have always been respectful. Approximately one year ago the City Council decided to have a discussion at their public council meeting on wether I should be allowed to speak using my name, Dave M. It was decided that I could speak and have spoken regularly until April 2023.

At the April 24th 3:30pm City Council meeting, (link provided below) the Council again brought up the name issue regarding my "true name" Dave M (same council, same rules). This was obviously preplanned for the next time I signed up to speak as was admitted by Zack ("true name" may be Zachary) Zappone who stated it had been "discussed extensively at their retreat". The Council argued this for over 14 minutes while the public and I were put on hold. In that lengthly discussion it was said multiple times by many council members including CP Beggs that "the name they use and/or are known by in the community or in public" is and would be allowed. Dave M is my real name and that is the name everyone in the public as well as the entire City Government knows me by. At the April 24th City Council meeting I was called "Scary", "Intimidating", "Creepy" (multiple times) and accused of "Hiding in the shadows" and "not showing my face" when calling in on the phone. It's a Phone! It was said "this is a real Creep factor". I was ultimately told I was out of order and would not be allowed to speak without giving a last name or showing my face while on the phone and was hung up on. To disparage my person as "Creepy" and "Scary" because I elect not to broadcast my private information to the entire city, for personal safety or any other reason is Not "Creepy" nor "Scary"...It's just plain SMART.

At the very next City Council meeting April 1st 6:00pm (link provided below) I signed up to speak at open forum. The council spent another 10 minutes discussing my name Dave M and whether or not I should be allowed to speak. There were statements from council members that they were "fed up" and "don't feel safe" with me calling in on the phone. The Council president along with the majority again decided I would not be allowed to speak if I didn't give them a last name and/or show my face while calling in over the phone. So I offered them a last name (Magoo) it was immediately rejected and I was not allowed to speak and again was hung up on. Obviously a last name wasn't the true issue. As of this date I am not aware that the City Council has ever checked ID's or verified anyones name as being "true". Since that time I have signed up to speak at open forum each week and have not been acknowledged or allowed to speak.

I was informed by CP Beggs, (who said he would also attend), that if I met with Council members Stratton and Wilkerson for coffee and if that is the name I use in public and am known by in the community the council would allow me to speak. Well, we met May 16th. CM Stratton, Wilkerson along with their administrative assistants Carlos and Kelly (CP Beggs was a no-show). We had coffee and spoke for approximately one and one half hours. Since our coffee meeting I have still not been allowed to speak at any council meetings under my name Dave M. I kept my word...they did not.

I would ask...who else in the community has ever been harassed and scrutinized to such a degree? What other Citizen of Spokane has ever been called out in this manner or required to prove who or what they are in order to exercise their right to speak to this Council? This has been unfairly applied to me and only me. This is an attack on me and my person because the majority on the council don't like what I have to say and don't like my name, Dave M. This is nothing less than their attempt to shut me up and make me go away.

This should never be allowed to happen to anyone.

This is a direct violation of my first amendment rights, freedom of speech as well as my right to address my government as a Senior Citizen, a taxpayer and a resident of Spokane WA. This blatant act of discrimination, bullying, intimidation, defamation, harassment, character assassination and abusive treatment is a complete violation of the Constitution, the Spokane Municipal Code and the City Code of Ethics.

I have always been respectful when speaking at any City Council meeting, board meeting or any other community meeting or event. I expect to be treated with the same respect and have my rights restored.

Everyone should be allowed to speak to or question their government and their elected officials without fear of intimidation or retaliation for doing so.



What sort of name can you call yourself?

You are free to change any part of your name — you can change your first name, your middle names, and your surname. You can add or remove names, and you can change the spelling of names.

As for each name itself; in general you can choose any name you like — it is not specifically laid down in law what sort of name you can call yourself. However, in some cases a change of name will break the law in another way. For example, you cannot change your name to avoid paying a debt, or you would be committing fraud.

The conclusion from Eckler's study was that O was the most common one-letter last name in the United States.

Single Letter Last Names (Examples)

There is no law in the United States that surnames must have more than one letter.

But that doesn't mean that there are people with one-letter last names.

I've reviewed recent censuses, data from the Social Security Administration, and a research project published in 1982.

My conclusion is that at least four letters are used as last names in America. These are the four:

Using The Social Security Index

The U.S. Social Security website publishes information about popular baby names and surnames.

But I have to go back to 1974 to find anything they disclosed about one-letter surnames.

In 1974, there were 221 people with a social security number and a one-letter name. The population of the United States was nearly 214 million that year.

Social Security told us that twenty-four people had the surname A. This was the highest number across the letters.

There were three letters that had only two people with the name:

- X

Apparently, there were other letters that had a number between that high and low. And I assume that some letters had no people at all.



City Council ARTICLE CONTENTS

At the 6:00 p.m. legislative session, prior to the consideration of consent or legislative items, the Council shall hold an open forum unless a majority of Council Members vote otherwise. The open forum shall have 15 (fifteen) spaces of two minutes each available and members of the public who have not spoken during open forum during that calendar month will be prioritized for spaces ahead of those who have spoken during that calendar month (unless changes to the agenda have been made).

Members of the public can sign up for open forum in the **2 hours** preceding the legislative session, or at the conclusion of the briefing session, whichever is later, via the virtual testimony form linked in the meeting packet, or in person outside Council Chambers. Each speaker must sign themselves using their **true first and last (name)**. Members of the public who are unable to sign up during the sign-up period or who attempt to sign up late will not be added to the list of speakers. The order of the speakers will be determined at the discretion of the chair **(and each Council Member shall be provided a list of all who have signed up for testimony)**. Each speaker shall be limited to no more than two minutes unless a majority of the Council Members in attendance vote on an alternate time limit.

No action, other than a statement of Council Members' intent to address the matter in the future, points of order, or points of information will be taken by Council Members during an open forum.

The open forum is a limited public forum and all matters discussed shall relate to affairs of the City. No person may use the open forum to speak on such matters and in such a manner as to violate the laws governing the conduct of municipal affairs. No person shall be permitted to speak on matters related to the current or advance agendas, potential or pending hearing items, or initiatives or referenda in a pending election. Individuals speaking during the open forum shall address their comments to the Council President and shall not use profanity, engage in obscene speech, or make personal comment or verbal insults about any individual.

Every single one knows me as Dave M.


