I am submitting additional information to help understand the nature of the complaint and the use of both facilities and equipment of the city of Spokane Fire Department as part of Molly Marshall's campaign. Attached are Exhibits A-E as well as photos of the site to illustrate the circumstances.

Exhibit A - This is the ownership data from Spokane County's website, SCOUT that provides ownership and site configuration for all properties in the county.
