- Police Strategies have finally received the necessary information from SPD to build the dashboards.
- o It will take approximately 3-4 months to get the dashboards online.

- O Commissioner Rose is interested in having Mr. Scales come back to show the functionality of the dashboards once they are completed.

NACOLE Resources

- a) Received Complaints
 - OPO 19-01 Demeanor / False Arrest: Complainant said they were arrested for DUI, even though they weren't the one driving and explained that because of medical reasons they wouldn't be able to do a field sobriety test.
 - ii. OPO 19-15 Inadequate Response: Complainant was arrested for DUI because they were unable to pass a field sobriety test; due to medical reasons. They were transferred to the hospital for a blood test, complainant stated the results were negative, which were not included in the police report.
 - iii. **OPO 19-16 Inadequate Response**: Complainant was suffering from a mental health situation. Complainant barricaded them self in their ca and requested a counselor. Police broke her window and forcibly removed complainant to take them to the hospital against their will.
 - iv. OPO 19-17 Inadequate Response / Demeanor: Complainant requested assistance through Crime Check. Responding officer was dismissive of the concerns and told them that they could not promise they would come.
 - v. **OPO 19-18 Excessive Force / Demeanor:** Complainant stated their minor son had excessive force used on him for a crime that he didn't commit. Complainant stated that senior officer was rude.

- vi. **OPO 19-19 Excessive Force:** Complainant alleges that excessive force was used on them during their transport to jail by SCSO (see referral ER 19-16). When they arrived at the jail, complainant alleges that SPD also used excessive force.
- vii. **OPO 19-20 Demeanor / Inadequate Response:** Requested to make a report, officer allegedly told by the officer they had a record, and were not a good citizen and that was probably the reason they were experiencing these issues.
- viii. **OPO 19-21 Commendation:** Thanked officer for continuing to help their initiative.
- ix. **OPO 19-22 Harassment:** Multiple business owners allege they are being targeted by receiving continuous tickets on their businesses.
