RE: Police Guild Letter (June 2019)

First of all, this is my opinion as a commissioner for the Office of Police Ombudsman.

Please know that I was a Union President for 8 years so I know how a union works. The Spokane Police Guild (one of SPD's Unions) is certainly entitled to their own opinion as we all are. However, when it comes to matters of the Office of the Police Ombudsman they are not entitled to object or demand certain requirements.

In the City Ordinance RE: Police Oversight-- that the citizens of Spokane voted on and clearly passed, it states:

One of the many duties of the office of police ombudsman (OPO) is to:

Provide visible, professional, INDEPENDENT civilian oversight of police officers."

Another part of the ordinance states:

"The police ombudsman and any employee of the OPO must, at all times, be totally INDEPENDENT."

So, we have a theme here – INDEPENDENCE. The Office of Police Ombudsman and the Office of Police Ombudsman Commissioners are independent entities. No one can dictate to us on how to carry out our duties. The ordinance does that for us and our job is to follow this ordinance as professional and as transparent as we can.

Another part of the ordinance states:

"No person shall attempt to unduly influence or undermine the independence of the police ombudsman, or any employees of the OPO, in the performance of the duties and responsibilities.

We, OPOC, do not answer to the police guild. They can file all the grievances and potential unfair labor practices they want! But, they hold no rights over us, the commissioners, who oversee the Office of Police Ombudsman. We are independent!

This being said – I would be open and willing to discuss this issue and any other issues anytime with the police guild.

I felt it was important that I be here today to offer my perspective on the issues you are dealing with today since I brought the issue regarding the Officer Dan and Scott Lesser arrest of Lucas Ellerman to the attention of the OPO and ended up being the complainant in the current ongoing IA Investigation of the arrest.

I want to be perfectly clear that I could not have brought the information forward if it were not for some outstanding SPD Officers who are extremely concerned about the culture that exists within SPD, a culture that hasn't changed since the Otto Zehm case which was the catalyst for the OPO and the OPOC coming into existence.

I also want to be perfectly clear that at no time has OPO Logue inappropriately provided me with any information with respect to this case or any other case, to the contrary the record is clear that I in fact provided him with the information necessary to bring this and other cases forward. It appears from the letter sent by the Spokane Police Guild that once again OPO Logue is being falsely accused. Members of the OPOC and the public should be thankful that unlike his predecessor Mr. Logue is willing to not only stand up to the SPD Command Staff but also the Spokane Police Guild.

In my view although the conduct of Officers Dan and Scott Lesser has been described as horrific, terrifying, criminal, along with several other adjectives I won't list here, I feel it is really important that the fact that there was a concerted effort to cover-up the conduct by circumventing the process is equally important.

The attempt to cover this incident up began in April of 2019 when I submitted a Public Records Request for all documents relating to the removal of Officer Dan Lesser from the SPD K9 Unit, and SPD responded that Dan Lesser was not removed from the K9 Unit. Most people would haven't gone any further once they received that information, but I was well aware that the arrest of Lucas Ellerman was the cause of Officer Dan Lesser no longer being a K9 Officer, so I pursued my efforts to get to the truth and that is why we are here today. Once the entire record becomes public it will show there was a meeting which was never documented or recorded between Officer Dan Lesser and a member of SPD Command Staff during which Officer Dan Lesser supposedly voluntarily resigned form his long involvement as an SPD K9 Officer. People will be able decide for themselves if someone with his K9 history and relationship with his K9 would "voluntarily resign" that position.

Many people wonder why law enforcement officers come to me with information, the reason is quite simple if officers come forward at SPD they will be subject to some kind of retribution, which may well be present in this case as one of the two Officers who stood up against the culture and assessed the conduct of the Lessers as outside of SPD policy, Sgt. Sean Wheeler, was replaced in his K9 position and transferred back to Patrol. What is even more troubling about the transfer of Sgt. Wheeler is that according to a June 1, 2019 Spokesman Review article written by SR Reporter Kip Hill "Spokane Police Chief Craig Meidl confirmed Friday that the video of an arrest of a 29-yeard old man (Lucas Ellerman) fleeing police contained evidence of "policy violations"..." The question must be asked; Why was

Wheeler transferred and why did Wheeler direct Officer Buchmann to make a report documenting that witnesses heard Officers yelling "I'm gonna kill you".

Many of the people who provide me information, as am I, are seriously questioning the judgement of allowing Officer Dan Lesser after four previous Officer Involved Shootings, and the known conduct exhibited in the Lucas Ellerman arrest being allowed to remain in an assignment where he could likely once again become involved in a shooting incident like he was on July 6, 2019 near 6th and Maple,

It should be pretty obvious to the OPOC as well as members of the Community that every effort is being made despite the recommendations by the Use of Force Commission and the COPs/DOJ Review to circumvent by any available means SPD transparency. Those of us who studied the Otto Zehm case remember full well among other things the lie about Otto Zehm lunging at Karl Thompson the constant barrage of stonewalling the process by SPD must be stopped if the Department ever wants to gain the respect of the Community.

Although I have not viewed the video I trust my sources with respect to its horrific content and I'm sure Chief Meidl knows full well that once the video is made public most will perceive it as wrong, very wrong, and any effort to mitigate the conduct will only serve to prove the point that the culture at SPD has not changed.

Spokane city lawmakers and the police department are at an impasse over access to body camera footage of a February arrest that prompted the agency's civilian watchdog to urge a formal investigation.

The Spokane City Council declined on Thursday to sign a nondisclosure agreement that would have allowed them access to the video, multiple lawmakers said. Spokane Police Chief Craig Meidl confirmed Friday that the video of an arrest of a 29-year-old man fleeing police contained evidence of "policy violations" but denied suggestions his agency was attempting to downplay the incident.

"The mere insinuation that there's a cover-up, again, puts me in a position where I want to be able to address that, because that is inflammatory, and it does a lot of damage," said Meidl in an interview Friday. "It doesn't matter what I can say, until I can say, here's everything else."

It should also be noted that both Fry and Deone Bercier heard the pickup engine revving and saw the pickup rocking back and forth in an apparent attempt to get away.
