



OPO 25-11	A community member believes that their arrest was retaliation for a comment that the community member made while passing by the officer.
OPO 25-12	A community member alleged that SPD officers targeted them during a homeless camp sweep where they were arrested.
OPO 25-13	A community member stated that SPD officers refused to charge the family members who assaulted and stalked them.
OPO 25-14	A community member stated that an off duty SPD officer ran a red light causing them to collide. Responding SPD officers did not cite the off duty officer.


