#### Introduction

- Agenda and minutes Commissioner Jasmin motioned to approve the agenda and minutes;

  - 4 commissioners approved
- Introduction of New Deputy Ombuds Lissa Mascio
- Public Forum:
  - Jim Leighty- Speaking in favor of Ombuds Logue. Would like to recommend removing the 3-year term for the Ombuds position. This is the only position in the City that has term limits besides the mayor.
  - Debbie Novak Attorney General Office Bill, Introduced during the 2025 session. The name of the bill will be changing to Oversight for Law Enforcement and Corrections. This is meant to address systemic issues in an agency.
  - Anwar Peace Thanked Ombuds Logue for his participation in the Courageous Conversation. Discussed his upstairs neighbor, Josh who was killed and his concerns surrounding the killing of Josh by the SPD.
  - o Christian Kinney Discussed his June 11<sup>th</sup> protest experience and concerns
  - Kevin Strickland Discussed his June 11<sup>th</sup> protest experience and concerns
  - Sierra Louse Discussed her June 11<sup>th</sup> protest experience and concerns
  - Hadley Morrow Discussed her June 11<sup>th</sup> protest experience and concerns. Requests follow up on the DRT metrics
  - o Lydia Sitherelli Discussed her June 11<sup>th</sup> and protest experience and concerns
  - Commissioner Jasmin has concerns about the SPD response to the Washington Working Act and the violation of this law.






