accusations of under 21 year olds drinking parties related to police department employees going
back to 2008. His former colleague worked for the City of Spokane and was made aware of
allegations of rape. These Spokane Police Department individuals referenced as having sexual
assault claims against them still work for the police department. He stated that there is
definitely a problem at the state level with arbitrators and the guild and not being able to get rid
of bad officers.
