 - Use of Force Policy collaboration

 - Focus will be on the tactics of the officers prior to and leading up to the Use of Force incident
 - However the last thing the Chief wants is to have officers second guessing themselves
 - o The policy is currently with the Executive Team & Police Guild
 - Goal is to roll it out during the Fall in-service

 - We will need to discuss the Vice Chair option during the August meeting

 - o The police guild sent a letter to the City Council that this would need to be negotiated.
