Items Session

- Public Forum:
 - o Anwar Peace -
 - Would like to support the reappointment of the Police Ombudsman, Bart Logue.
 - During his tenure he has shown his ability to be evenhanded in dealing with the complainants and officers.
 - Mr. Peace has witnessed this firsthand through filing of complaints that led to 2 different mediations with officers.
 - o Robert Esseltine -
 - I researched the past 3 years and could not find any instance where Bart was not doing his job.
 - Bart does his job of being transparent and assisting the public.
 - Everyone has bad days and we deal with them accordingly. When a police
 officer has a bad day sometimes people get hurt. Bart is here to act as that
 go between to get people on the same page.

 - The Council President is proposing an ordinance (C36259) Letter E
 - Public Hearing on Police Contracts The City Council and the Office

 testimony on the effectiveness of Police Accountability system and
 will be held no less than 30 days prior to contract negotiations with
 the Police Guild
