- **Public Forum:**
 - Anwar Peace
 - Spoke on the rash of police shootings (3 in two weeks)
 - Asked the City to bring the Department of justice to conduct a patterns and practices investigation of SPD
 - Debbie Novak
 - HB 1579 – Independent prosecuting attorney legislation
 - Passed Law and Justice Committee
 - Office of Independent Investigation and Independent Prosecuting Attorney would be separate but together out of the AG's office
- **Guest Speaker: Betsy Wilkerson – City Council President**
 - As a community we have lost the sense of urgency around police accountability
 - Legislative Committee – if the Commission or community has issues, they should bring them to Council so that they can be addressed on a State legislative level
 - Community Policing – What is this and what does it look like
 - DT Precinct – Would like to see this be more inviting to the public
 - Building a level of trust between Public Safety and the Community
- **Ombudsman January Monthly Report:**
 - 173 contacts, 10 OPO interviews, 1 Commendation, 5 complaints, 4 referrals, 5 cases certified, 158 special cases reviewed, 7 IA interviews attended
 - Focus for January has been meeting with City Council Members
 - Council Member Dillon mentioned that he would like to see us have a more active role in the PSCHC meetings
 - Staggering of OPOC commissioner appointment terms

Commission Business

- **Critical Incidents** – 17 officers out on administrative leave for approximately 2 weeks
 - 1/31/24 – 9 officers involved
 - 2/12/24 – 3 officers involved

- 2/12/24 - 2 officers involved
- What is SPD doing right now to help? Checking in with officers' morale in the department. Reinforcing the importance of giving their best to upcoming calls on the next shift
- What can we do?
- What are other Boards and Commissions doing?
 - Human Rights Commission would like to collaborate with the OPOC
- **Budget Letter**
 - Sent to the Mayor and to the City Council
- **OPOC Plan for 2024**
 - Social Media presence – Different groups, Carl Maxey Center

Complaints and Referrals




Highlights:

In February, the Office of the Police Ombudsman (OPO) submitted 1 complaint, 4 referrals to the Spokane Police Department (SPD) Internal Affairs, and 1 referral to Code Enforcement.

Highlights include:

- OPO 24-07: A community member alleged that an officer cut them off by going into their lane without using a signal.
- IR 24-05: A community member was frustrated that they were denied buying a gun due to an alleged error in their background check.
- IR 24-06: A community member was concerned about how officers handled a DV situation while serving a warrant.
- IR 24-07: A community member wanted to press charges on a person who assaulted them.
- ER 24-08: A community member wanted to report an RV parked illegally behind their home; Code Enforcement
- IR 24-09: A community member wanted to make sure that SPD has the correct building information for an apartment complex, due to SPD coming to their apartment instead of the correct building.


Complaints 2023 vs. 2024









Reporting Period: March 1-31, 2024


Complaints and Referrals



In March, the Office of the Police Ombudsman (OPO) submitted 6 complaints and 5 referrals to the Spokane Police Department (SPD) Internal Affairs. The OPO also submitted 2 referrals to the Spokane County Sheriff Office(SCSO) and 1 referral to Code Enforcement.

- OPO 24-08: A community member was frustrated with SPD’s response when they called for assistance in removing a person who passed out in their business parking lot.
- OPO 24-09: A community member was concerned with how officers entered a medical facility to arrest a patient.
- OPO 24-10: A community member stated that they were almost hit by an SPD vehicle while they were getting ready to cross the street downtown.
- OPO 24-11: A community member believes that they only received a traffic ticket as retaliation for giving a disapproving look to the officer.
- OPO 24-12: A community member witnessed officers allegedly using excessive force on people after a vehicle accident. The same person was then pushed by officers while on the scene for recording them.
- OPO 24-13: A community member is concerned that a detective is disseminating information unethically.

- IR 24-10: A community member wanted to follow up on a hit and run to see if a person was caught and held responsible; SPD / IA.
- IR 24-11: A community member is frustrated with the lack of response regarding a suspected drug house they live next to; SPD / IA.
- IR 24-12: A community member is frustrated with responding officers taking the word of other people instead of them; SPD / IA.
- ER 24-13: A community member believes that the person who assaulted them should have been arrested; SCSO.
- ER 24-14: A community member is frustrated that a person who drums in the park is not being held accountable to the noise ordinance; Code Enforcement.
- IR 24-15: A community member has been trying to get an update on a case for 4 weeks; SPD / IA.
- IR 24-16: A community member is concerned that a detective is disseminating information unethically; SPD / IA. Upon review, this was submitted at OPO complaint OPO 24-13
- ER 24-17: A community member is frustrated with how they are being treated like the criminal in a no contact order; SCSO.
- IR 24-18: A community member is frustrated that SPD stated their parents' vehicle being stolen is a civil matter and will not enter the vehicle as stolen; SPD /IA.






