Briefing Session:

- 1. City Council Liaison Report -Zack Zappone
 - Council Member Zappone attended the Association of Washington Cities (AWC) conference. He commented that the AWC is not supportive of housing bill 1110 and will propose amendments to it.
 - CM Zappone also reported that City Council is continuing to discuss the redevelopment of surface parking lots in Spokane, and they are considering which percentage of affordable units would be required for residential development in those locations.
- 2. Community Assembly Liaison Report Mary Winkes
 - Mary Winkes reported that moving forward, she will be able to directly email Community Assembly members to be able to better communicate in a timely manner. Ms. Winkes also commented that 4 o'clock is a difficult and inconvenient time for citizens to join a hearing and suggested exploring other times.
- 3. Commission President Report Greg Francis
 - Greg Francis stated that he attended a Bicycle Committee meeting last week.

- 5. Secretary Report Spencer Gardner

 - Public Comment:
 - Scott Krajack, Ryan Built Homes, spoke in favor of Option 4 as it has the lowest impact fee and recommended removing some of the additional fees.
 - Jim Frank, Greenstone, spoke in favor of the boundary in Option 4.
 - Elizabeth Tellessen, Winston and Cashatt, spoke in favor of letting the moratorium expire continuing to work through the impact fee discussion. Spoke in favor of Option 4.
 - Andrew Rowles, Downtown Spokane Partnership, opposes increase in cost in the downtown area, spoke in favor of option 2.
 - Darin Watkins, Spokane Realtors Association, spoke about fairness and the fear that if fees are too high development will stop in Spokane.

1. Ryan Patterson made a motion to adopt changes to SMC17D.075.040 Section 1 and 17D.075.070 Section 2, with the addition of SMC 17D.075.190 Appendix B and adopt the language changes as recommended. Seconded by Clifford Winger

Ryan Patterson made a friendly amendment to the motion to exclude SMC17D.075.180 impact fee schedule and SMC17D.075.070 Fee Reductions and Credits and SMC17D.075.190 Service Area Map. Seconded by Clifford Winger.

Motion Carries (9,0)

2. Ryan Patterson made a motion to recommend Service Area Map Option 6. Seconded by Clifford Winger.

Ryan Patterson amended the motion to consider sections 3 and 4 to include 075-180 Impact Fee Schedule and SMC17D.075-190 Service Area Map Option 6 and adding Appendix B Service Area Map. Clifford Winger seconded.

Motion failed to carry (1, 7, 1)

3. Todd Beyreuther made a motion to remand back to city staff to look at a city wide option. Seconded by Jesse Bank.

Todd Beyreuther amended the motion to recommend to not adopt the proposed service area maps and recommend in the findings that alternative service area boundaries and resulting fees should be considered prior to updating the City's transportation impact fees based on discussion. Seconded by Jesse Bank

4. Ryan Patterson motioned to adopt changes SMC17D.075-210 Impact Fee Project List as mentioned in Section 5 of the proposed ordinance. Seconded by Jesse Bank

Todd Beyreuther made a friendly amendment to the motion to change the Thorpe Tunnels engineering cost to include full construction cost to the Impact Fee Project List. Seconded by Jesse Bank
