Briefing Session:

Community Assembly Liaison Report - Mary Winkes

 Mary mentioned that Community Assembly did not meet in August. When they meet in September, they will be discussing their proposed changes to the neighborhood chapter of the Comprehensive Plan.

• Transportation Commission Liaison Report - Ryan Patterson

• There was no Transportation Commission meeting in July, the August meeting is coming up next week. She did participate in the Spokane Bike Party bike ride last week as well as other members of the Transportation Commission, City Council and the Mayor.

• President Report - Jesse Bank

• President Bank only wanted to mention that he will be recusing himself from the fourth item on the today's agenda (Hillyard Subarea Plan) as he is also a member of the project.

• Secretary Report - Spencer Gardner

- Spencer stated that they have completed interviews for new applicants for the empty Plan Commission seat. They have passed that information onto the Mayor's office.
- They have put out an RFP (Request for Proposal) to do a full code audit and rewrite. This is work that is happening alongside the Comprehensive Plan update. We have a lot of code changes that are going to be required but they also want to take the opportunity recognizing that there are about twenty years' worth of code amendments that have accumulated. There will be a process to select a consultant to help us with that. The RFP's are open for another week or two at which point they will select a consultant and get started. This is work that the Plan Commission will be participating in over the next year or so.
- Spencer stated that it is good practice to occasionally revisit the Plan Commission rules so that everyone is aware of the duties of the Plan Commission. Today he went over how to handle sharing your views in public as a member of the Plan Commission. Especially

pertaining to how to handle a situation where you disagree with a decision made by the Plan Commission. He read the following rules:

- 10.3.3: Commission members may speak as an individual member reflect and inform about Commission positions and activities and on their own position as long as it is clear whether such position is or is not a Commission position and clearly specifying they are speaking as an individual, or as an individual Plan Commissioner articulating their own views and concerns.
- o 10.3.4: When expressing personal views, Commission members do not include a reference to their Commission membership on letterhead, in a signature line, or in another way that could be construed as representing the Commission as a whole.

The takeaway is that if you are speaking about anything related to the work Plan Commission does and especially if you are known to be a Plan Commission member, just make sure that you are being really careful about characterizing your position as your own views and not the views of the Plan Commission as a whole.

10.13: Except for submitting a written dissenting opinion as provided under these rules
of procedure, no Commission member shall work for the frustration, or the overturn of
any decision made by a majority of the Commission outside the framework of the
Commission.

If there is something that the Commission does that you disapprove of or disagree with, the proper way to handle that is through your participation in the Commission (ie. sharing and voting at hearings). However, after a vote/decision has been made and especially as it works its way through the subsequent parts of the adoption process, be very careful as to not be seen as trying to frustrate or overturn a decision that has been made by the Plan Commission by advocating against it. If you have questions about how to address these kinds of situations, he is happy to be a resource as well as our city legal team.
