2. Chair Report- John Dietzman

3. Secretary Report - Louis Meuler

Next Monday, October 15, there will be a public meeting at the Northeast Community Center regarding the North South Corridor (NSC) project.

4. Council Liaison Report - Lori Kinnear

At the City Council meeting on October 8 there was a forum on mental health awareness. A Property Crimes Initiative task force is being assembled to provide awareness and education to the community to help citizens avoid becoming a victim of property crimes. Lori will be the recipient of the Spokane Preservation Advocates Advocacy Award for her work with Historic Preservation. The Pedestrian, Traffic & Transportation (PeTT) committee is looking at ways to slow traffic around parks for safety. The Lime Bike pilot program has been popular, however, issues have been identified and need addressed.

5. Stakeholder Reports

- The Bicycle Advisory Board is renewing the City's Bicycle Community application.
- o Oddly shaped curb cuts and roundabouts cause challenges for those with vision loss to cross the street because of the lack of parallel traffic.
- Spokane County recently had a meeting of the Plan Commission and they are looking at changes to the County Connectivity Ordinance.
- WSDOT wants to put the sidewalk on Wellesley on the north side instead of the south side as originally planned this can potentially cause safety issues for pedestrians.
- o STA is working on the 2019 service change which is focused on the south hill.
