<u>Subject</u>

2019 Schedule for stakeholder and public input for updating the Street Design Standards.

Background

The Design Standards Update has been a work in progress for the past few years. A new draft is in the works to be shared with internal departments as well as stakeholders, the development community, and the public. The Street Design Standards are used during engineering of streets, sidewalks, pathways and stormwater facilities within the public right of way. These are used by City Staff as well as the Development Community.

Best practices for management of space, right-sizing traffic facilities, and long-term maintenance budgeting have motivated adjusting the standards to accommodate efficient street management into the future.

The Draft Design Standards are nearly ready to share, and the public outreach schedule will be shared with the Plan Commission Transportation Subcommittee (PCTS) for discussion and input.

<u>Impact</u>

The PCTS represents several Committees and Boards that make up Spokane's stage for public input. The Design Standards are generally very technical, but the impacts of changes to the standards can be discussed in layman's terms. Public feedback will serve to reinforce or revise the direction this update to the Design Standards is heading.

<u>Action</u>

Review the schedule for completing the Design Standards update and provide feedback to City Staff.

<u>Subject</u>

2020 - 2025 Six-year Comprehensive Street Program - Proposed Programming

Background

The Six-Year Comprehensive Street Program lists projects scheduled for design and construction, and which have received dedicated funding. The Transportation Subcommittee has worked closely with City staff to bring together a prioritization matrix for arterial streets. This scoring matrix has been applied to all arterial streets that have not recently been reconstructed through the bond or other grant programs and have met pavement reconstruction criteria.

Generally, the next step is to reference the prioritized list of projects and select projects to fill the "out years" of the program (2024-2025). Another aspect of programming projects is to assure financial constraint and a schedule facilitating constructability. Over the past three years, costs for labor and materials have increased, so projects within the program are expected to cost more than originally anticipated. Grant funding availability impacts the ability to deliver projects. The City is also coordinating schedules with STA where projects overlap with the Central City Line.

The selection of new projects will depend upon the program budget. For 2019, this means reviewing potential grant opportunities aligned with the current budget forecasts related to the projects already programmed. Adding new projects may require delaying projects currently in the program.

<u>Impact</u>

Programming of projects prioritizes efforts to seek State and Federal grants to supplement arterial street funds. Balancing the program for budget adjustments is another important step in this process.

<u>Action</u>

Review project prioritization within the program as budgeted for the annual update to the 6-Year Program.
