Briefing Session:

Minutes from the February 1, 2022 meeting approved unanimously.

- 1. Chair Report Clifford Winger
 - Mr. Winger said that he is glad to be back after taking break for the last two months.
- 2. Secretary Report Colin Quinn-Hurst
 - Mr. Quinn-Hurst reported that wheelshare, Lime Scooters, and electric bikes will relaunch in larger numbers in March.
 - He also reported that the Transit Oriented framework study is wrapping up in March as well.
 - DivisionConnects project is identifying active transportation projects that will go with the BRT improvements.
 - The new Planning Director, Spencer Gardner introduced himself to the PCTS.
- 3. Council Liaison Report Jonathan Bingle
 - Council Member Bingle reported that City Council has been going through 6 year plans and that ARPA funding has been approved.
 - Neighborhood councils would like more communication from PCTS related to what they are doing. Mary Winkes responded that she delivers a report to Community Assembly about the PCTS and the PC.

Stakeholders Report -

- Michelle Pappas, Futurewise none
- Paul Kropp, Neighborhood Alliance reported that he is interested in equity and roadways of significance. He is looking forward to learning more about SRTC's equity framework project.

- Rachel Callary, Lilac Services for the Blind commented that the additional labeling on Lime Scooters are an improvement and hopes that they will help to alleviate improper parking. The labels, which are also in braille, include a phone number that can be called to report improper parking.
- Cindy Green, Spokane Regional Health District (SRHD)- none
- Charlene Kay, Washington State Department of Transportation (WSDOT) reported that WSDOT and the City of Spokane are collaborating for a grant for a land bridge across I-90. The grant application will also include and active transportation component.
- Rhonda Young, Bicycle Advisory Board (BAB) Reported that BAB is looking at the construction detour for the Don Kardong bridge and is hoping to get protected bike lanes installed along Spokane Falls Blvd. during construction. The BAB is also interviewing new applicants for the Bicycle Advisory Board.
- Charles Hansen, Whitman Neighborhood Council, PeTT Committee reported that Traffic Calming projects he has worked on have been added to 6-year program. Nothing to report from PeTT.
- Eve McMenamy, Spokane Regional Transportation Council (SRTC)- reported that an equity planning framework project is underway, it will continue until December. The goal is to improve equity planning and to learn from stakeholders what their equity needs are. SRTC hopes to identify policies that are missing at regional level and criteria that would make them more competitive. The SRTC Household Travel survey is underway. It is a randomized study that informs planning tools, so decision makers know how households travel. The DivisionConnects study will wrap up early summer. Finally, critical urban freight projects, including one along Wellesley Ave. will soon be considered by the SRCT board.

Subject

2023 - 2028 Six-year Comprehensive Street Program Proposed Additions

Background

In support of the State Growth Management Act and the City of Spokane's Comprehensive Plan, the City must maintain 6-year capital financing plans for certain providers of public facilities and services. Accordingly, the City must maintain a 6-year capital financing plan for its capital street program. Pursuant to RCW 35.77.010 the capital street program must be adopted before July 1 of each year, and filed with the Secretary of Transportation not later than 30 days after adoption. To determine the plan's consistency with the Comprehensive Plan, it is scrutinized by the City Plan Commission. The Plan Commission then makes a recommendation to the City Council as to the program's consistency with the Comprehensive Plan. The City Council then accepts or modifies the plan accordingly.

Each new project to the 6-Year Program is assessed for compliance with the Comprehensive Plan by verifying fulfillment of the Transportation goals and policies (TR's). Staff have prepared an assessment, and seek a PCTS recommendation to Plan Commission regarding program compliance.

<u>Impact</u>

Staff will present a draft assessment of new projects being brought into the 2023 – 2028 6-Year Comprehensive Street Program. The assessment includes a review of each project for consistency with the transportation chapter goals and policies of the comprehensive plan.

Action

Seeking recommendation to the Plan Commission:

New projects coming into the 6-Year Comprehensive Street Program are consistent with the comprehensive plan.
