Briefing Session:

Minutes from the December 6, 2022 meeting approved unanimously with edits.

1. Chair Report - Clifford Winger

 Clifford Winger reported that Plan Commission will have workshops about Transportation Impact Fees, the Six Year Street program which is presented by Integrated Capital management. Plan Commission will be held at 2 pm on Wednesday.

2. Secretary Report - Colin Quinn-Hurst

- Colin Quinn-Hurst reported that Ryan Shea will be taking over as Secretary for the Bicycle Advisory Board.
- A Center and Corridor Study Review contract will be going before Council for briefing.
- Finally, there is a greenway alignment study in the area east of Sherman and along Riverside into downtown which will connect with Sprague.

Council Liaison Report - Johnathan Bingle

• Council Member Bingle reported that he is on the Traffic Impact Committee and a draft for new Impact Fees is being formed. Additionally, the Landlord-Tenant Ordinance is still being considered by Council but should move forward soon.

3. Stakeholders Report -

- Rachel Callary, Citizen-at-Large, is working to identify more policies that support additional accessibility for removing snow for pedestrians and bicyclists.
- Mike Tresidder, Spokane Transit Authority (STA), stated that a virtual open house regarding today at STA. Additionally, Cityline buses drivers are in training, and they are running full schedules. The official launch will be in July.
- Rhonda Young, Bicycle Advisory Board (BAB), reported that the Bike Parking draft was
 presented at the last meeting, and BAB gave feedback to city staff about their experiences
 with winter maintenance and snow blocking sidewalks and bike lanes.
- Charles Hansen, Whitman Neighborhood Council, PeTT Committee, discussed the Strongtowns article: https://www.strongtowns.org/journal/2023/1/3/dont-add-trains-sidewalks-and-bike-lanes-to-your-city.

- Samantha Hennessy, Spokane Regional Health District, is the new Spokane Regional Health District liaison to PCTS.
- Eve McMenamy, Spokane Regional Transportation Council, reported that SRT, received a\$400,000 grant for the Streets for All Program. SRTC will be funding an action plan with this money and will be analyzing needs throughout the City of Spokane and other cities around Spokane County.
- Paul Kropp, Neighborhood Alliance, reported that Kevin Picanco recently presented about the Six-Year Streets Program plan.

Subject

2024 - 2029 Six-year Comprehensive Street Program – Program Update Kick-off and Programming Consistency

Background

In support of the State Growth Management Act and the City of Spokane's Comprehensive Plan, the City must maintain 6-year capital financing plans for certain providers of public facilities and services. Accordingly, the City must maintain a 6-year capital financing plan for its capital street program. Pursuant to RCW 35.77.010 the capital street program must be adopted before July 1 of each year, and filed with the Secretary of Transportation not later than 30 days after adoption. To determine the plan's consistency with the Comprehensive Plan, it is reviewed by the City Plan Commission and Plan Commission Transportation Subcommittee (PCTS). The Plan Commission then makes a recommendation to the City Council as to the program's consistency with the Comprehensive Plan. The City Council then accepts or modifies the plan accordingly.

Each new project to the 6-Year Street Program is assessed for compliance with the Comprehensive Plan by verifying fulfillment of the Transportation goals and policies (TR's). Staff will present a draft at the PCTS meeting for information and discussion. Staff will later seek PCTS recommendation to Plan Commission regarding compliance of the new projects being added to the program.

Impact

Staff will present a draft assessment of new projects being brought into the 2024 – 2029 6-Year Comprehensive Street Program. The assessment includes a review of each project for consistency with the comprehensive plan, particularly the transportation chapter.

Action

This item will be informational for discussion purposes during the meeting. An action will be requested at the April PCTS meeting for a recommendation to the Plan Commission.
